WHEREAS, The members of the House of Representatives of the 135th General Assembly of Ohio were deeply saddened to learn of the death of Ronald Mottl, Sr., and extend our heartfelt condolences to his family and friends; and

WHEREAS, Ron Mottl left an indelible impression on the lives he touched, and he will be remembered as a spirited individual who contributed immeasurably to the world around him. After graduating with a law degree from the University of Notre Dame, where he captained the 1955 baseball team, he served in the U.S. Army. As an elected official, he held positions as president of Parma City Council and a member of the Parma City Schools Board of Education, the Ohio Senate and House of Representatives, and the United States Congress. While in the state legislature, he was instrumental in the establishment of the Ohio Lottery, and he was also a member of the Greater Cleveland Sports Hall of Fame and its board of directors; and

WHEREAS, Ron Mottl's regard for improving the quality of life in our society was clearly evident in his personal sacrifices of time and effort to his family, friends, and community. Giving generously of his energy and abilities in all of his endeavors, he displayed exceptional concern and insight, and his absence will be keenly felt; and

WHEREAS, A loving husband to his wife, Debbie, a devoted father to his children, Ron, Ron Mickey, Ronda, and Amanda, and a doting grandfather to his grandchildren, Alexis, Samantha, Mickey, and Mickayla, Ron Mottl always used his talents to the benefit of others, and the laurels of his life stand as a tribute not only to him but also to those he left behind. Although the void his death has created can never be filled, the legacy of care and commitment he established will surely live on. The world is a richer place for his having been in it, and he will be sorely missed; therefore be it
