Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Dobos was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

### INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 652** - Representative Swearingen.

To enact section 5534.482 of the Revised Code to designate a portion of State Route 2 in Ottawa County as the "Cpl. Robert Dockstader Memorial Highway."

**H. B. No. 653** - Representative Lorenz.

To amend sections 2903.06 and 2903.08 of the Revised Code to alter the law governing vehicular manslaughter and vehicular assault.

**H. B. No. 654** - Representative Click.

Cosponsors: Representatives Dean, Gross, King, Klopfenstein, Lear, Wiggam, Williams.

To amend sections 5747.01 and 5747.025 of the Revised Code to authorize a personal income tax exemption and credit for conceived children and to name this act the Strategic Tax Opportunities for Raising Kids (STORK) Act.

**H. B. No. 655** - Representative Patton.

To amend sections 323.152, 323.153, 323.156, 323.158, 4503.06, 4503.066, 4503.067, 4503.069, and 4503.0610 and to enact section 4503.0612 of the Revised Code to authorize a property tax freeze for certain owner-occupied homes.

Said bills were considered the first time.
