### INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 640** - Representatives Demetriou, Roemer.

To amend sections 107.42, 3704.14, 4503.10, 4503.102, and 4503.103 and to repeal section 3704.032 of the Revised Code to create an alternative method to certify compliance with the E-Check program, to eliminate the authority to declare an air pollution emergency, and to name this act the E-Check Ease Act.

**H. B. No. 641** - Representatives Williams, Rogers.

To enact section 5534.617 of the Revised Code to designate a portion of I-280 in Lucas County as the "SSG Jack W. Coy Memorial Highway."

Said bills were considered the first time.
