The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

The journal of the previous legislative day was read and approved.

#### **INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 489 -** Representatives Dell'Aquila, Rogers. Cosponsors: Representatives Russo, Brennan, McNally, Isaacsohn, Lorenz.

To enact section 4521.11 of the Revised Code to prohibit parking fee collection services from selling personal data relating to transactions for payment of parking fees.

**H. B. No. 490 -** Representatives Skindell, Piccolantonio. Cosponsors: Representatives Brent, Brennan, Russo, Troy, Rogers.

To enact section 5.56 of the Revised Code to designate the third Sunday in November as "Road Traffic Victims Day of Remembrance."

**H. B. No. 491 -** Representatives Young, T., Peterson. Cosponsors: Representatives Dean, Dell'Aquila, Johnson, King.

To amend sections 113.70, 113.71, 113.72, 113.73, 113.75, 113.76, and 5501.521; to enact new section 113.77; and to repeal section 113.77 of the Revised Code to require a political subdivision or state retirement system to provide information on expenditures to the Treasurer of State for inclusion in the Ohio State and Local Government Expenditure Database.

H. B. No. 492 - Representative Miller, K.

Cosponsors: Representatives Abrams, Creech, Ghanbari, Hall, Johnson, Williams.

To amend sections 145.22, 145.23, 145.35, 145.46, 145.561, and 742.63 and to enact sections 145.71, 145.72, 145.721, 145.722, 145.73, 145.74, 145.75, 145.751, 145.76, and 145.77 of the Revised Code to establish a deferred retirement option plan for law enforcement officers in the Public Employees Retirement System.

H. B. No. 493 - Representative King.

To enact section 5534.813 of the Revised Code to designate a portion of

State Route 185 in Darke County the "Lance Corporal Gerald Subler Memorial Highway."

H. B. No. 494 - Representative King.

To enact section 5534.616 of the Revised Code to designate a bridge spanning Indian Creek in Darke County as the "SSgt Gene F. Morrison Memorial Bridge."

**H. B. No. 495 -** Representatives Carruthers, Sweeney. Cosponsors: Representatives Grim, Brennan, Brent, Robb Blasdel, Russo, Dell'Aquila.

To amend sections 3715.01, 3715.025, 3715.99, and 3717.01 and to enact section 3715.522 of the Revised Code to prohibit the sale of cosmetics tested on animals except under certain specified circumstances.
