The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 450 - Representatives Lampton, Young, T.

To amend sections 2907.08, 2911.21, 2911.211, and 2911.23 of the Revised Code to prohibit voyeurism, criminal trespass, and aggravated criminal trespass through the use of an unmanned aerial vehicle system.

H. B. No. 451 - Representatives Wiggam, King.

Cosponsors: Representatives Barhorst, Click, Creech, Dean, Gross, Hall, Holmes, Hoops, John, Johnson, Kick, Klopfenstein, Lear, Lorenz, Miller, K., Miller, M., Seitz, Williams, Willis.

To amend section 5747.98 and to enact sections 1315.131, 5502.80, and 5747.87 of the Revised Code to levy a remittance transfer fee on money transmissions to a person outside of the United States, to authorize an income tax credit based on the amount of remittance transfer fees paid, and to name this act Ohio's Withholding Illegal Revenue Entering Drug Markets (WIRED) Act.

H. B. No. 452 - Representatives White, Baker.

To amend section 3727.18; to amend, for the purpose of adopting a new section number as indicated in parentheses, section 3727.18 (3727.182); and to enact new section 3727.18 and sections 109.7411, 3333.96, and 3727.181 of the Revised Code regarding hospital violence prevention and related training, security plans, and incident reporting.

H. B. No. 453 - Representative Jones.

To enact section 5534.615 of the Revised Code to designate a portion of I-77 in Noble County as the "Staff Sergeant George P. Mizik (USMC) Memorial Highway."

Said bills were considered the first time.
