The House met pursuant to adjournment.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 602 - Representatives Fowler Arthur, McClain.

Cosponsors: Representatives Barhorst, Claggett, Click, Dean, Ferguson, Gross, Holmes, John, Johnson, Kick, King, Klopfenstein, Lear, Stein, Stoltzfus, Swearingen, Wiggam, Williams, Willis.

To amend sections 5104.01, 5104.02, and 5104.38 and to enact sections 303.215 and 519.215 of the Revised Code to exempt home education groups from child care regulations, county and township zoning regulations, and to amend the versions of sections 5104.01, 5104.02, and 5104.38 of the Revised Code that are scheduled to take effect on January 1, 2025, to continue the change on and after that date.

H. B. No. 603 - Representative Pavliga.

To amend sections 2929.15 and 2929.25 of the Revised Code to allow a sheriff or deputy sheriff to report violations of community control.

H. B. No. 604 - Representatives Upchurch, Abdullahi.

Cosponsors: Representatives Brennan, Piccolantonio, Dell'Aquila, Forhan, Grim.

To enact section 101.18 of the Revised Code to allow a General Assembly member to determine the member's legislative aide's work-from-home hours.

H. B. No. 605 - Representatives Upchurch, Creech.

To enact section 3775.17 of the Revised Code to require that the playing surface of a professional sporting stadium be comprised of not less than 90% natural grass.

H. B. No. 606 - Representatives Pizzulli, Jarrells.

To enact sections 3320.05, 3320.06, 3320.07, 3333.80, 3333.801, and 4112.20 of the Revised Code to enact the Campus Accountability and Modernization to Protect University Students "CAMPUS" Act regarding the prevention of racial, religious, and ethnic bias, harassment, and intimidation at institutions of higher education, regarding antisemitism prevention policies at state agencies, to establish different campus safety and community programs, and to make appropriations.

H. B. No. 607 - Representatives McClain, Willis.

To enact sections 3523.13, 3523.14, 3523.15, 3523.16, 3523.17, 3523.18, and 3523.99 of the Revised Code to establish procedures for appointing delegates to a convention of the states under Article V of the United States Constitution.

H. B. No. 608 - Representative Williams.

To amend sections 2953.33, 2953.34, and 2953.61 and to enact section 2953.331 of the Revised Code to reduce the requirements for sealing or expungement of records in a case where the defendant was acquitted or found not guilty.

H. B. No. 609 - Representatives Hillyer, Holmes.

To amend section 3517.13 of the Revised Code to modify the Campaign Finance Law regarding foreign nationals and statewide initiatives and referenda and to declare an emergency.
