The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Dobos was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 496 - Representative Hoops.

To amend sections 133.18, 306.32, 306.322, 319.05, 319.54, 321.24, 321.26, 323.156, 505.37, 505.48, 505.481, 511.28, 513.18, 755.181, 1545.21, 3311.50, 3318.01, 3318.061, 3318.45, 3381.03, 4503.06, 4503.066, 4503.068, 4503.0611, 4582.024, 4582.26, 5705.01, 5705.03, 5705.195, 5705.21, 5705.212, 5705.213, 5705.215, 5705.25, 5705.251, 5705.261, 5713.083, 5715.19, 5715.22, 5723.05, 5723.06, 5723.10, 5748.01, 5748.02, 5748.03, and 5748.04 of the Revised Code to revise the law governing property taxes and county auditors.

H. B. No. 497 - Representatives Stewart, Klopfenstein.

Cosponsors: Representatives Creech, Peterson, Seitz, Dean, Lorenz, Johnson, Hoops, Claggett, Barhorst, Wiggam.

To amend sections 135.33, 153.31, 153.35, 153.36, 153.37, 153.38, 153.39, 153.44, 307.12, 309.09, 325.15, 2335.061, and 5540.03 of the Revised Code to make various changes regarding county law and to amend the version of section 153.39 of the Revised Code that is scheduled to take effect January 1, 2025, to continue the change on and after that date.

H. B. No. 498 - Representative Carruthers.

To repeal section 2927.13 of the Revised Code to remove the criminal offense related to donating blood when the donor is a carrier of the virus that causes AIDS.

H. B. No. 499 - Representatives Isaacsohn, Mathews.

To amend sections 319.302 and 3735.67 and to enact sections 175.41, 175.42, and 175.43 of the Revised Code to create grant programs for housing developments near megaprojects and for townships and municipalities that adopt pro-housing policies, to modify the community reinvestment area law relating to residential property, and to limit the 10% nonbusiness property tax

credit.

H. B. No. 500 - Representatives Carruthers, Upchurch.

To amend sections 2911.211, 2917.12, 2923.04, 2927.12, 4511.16, 4511.17, and 5589.99 and to enact sections 2911.212 and 5589.34 of the Revised Code to prohibit unauthorized displays of symbols on bridges or highways and unauthorized projections of images onto buildings and to expand the offenses of aggravated trespass and ethnic intimidation.

H. B. No. 501 - Representative Carruthers.

Cosponsors: Representatives Lipps, Piccolantonio, Williams, Brennan.

To create the Joint Legislative Study Committee on Small Business Retirement Options to study and report on private sector retirement plans and state-facilitated retirement savings options to improve access to retirement programs.

H. B. No. 502 - Representatives Somani, Piccolantonio.

Cosponsors: Representatives Grim, McNally, Miller, A., Denson, Russo, Brent, Weinstein.

To enact sections 2305.2312, 3732.01, 3732.02, 3732.03, 3732.04, 3732.05, 3732.06, 3732.08, 3732.09, 3732.11, 3732.13, and 3732.14 of the Revised Code to protect assisted reproduction care.

H. B. No. 503 - Representatives Peterson, Jones.

To amend sections 901.43, 942.01, 942.02, 943.23, 943.26, 1531.01, 1533.01, 1533.731, 1533.99, and 4745.01; to amend, for the purpose of adopting a new section number as indicated in parentheses, section 942.13 (942.05); to enact new sections 942.03 and 942.04 and sections 1533.75 and 1533.751; and to repeal sections 942.03, 942.04, 942.05, 942.06, 942.07, 942.10, 942.11, 942.12, and 942.99 of the Revised Code to prohibit certain activities regarding garbage-fed swine, feral swine, and wild boar.

Said bills were considered the first time.
