**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 383** - Representative Fowler Arthur.

To enact section 5534.499 of the Revised Code to designate a portion of U.S. Route 20 in Ashtabula County as the "Corporal John E. Ruch Memorial Highway."

**H. B. No. 384** - Representatives Abdullahi, Hall.

To enact section 3902.63 of the Revised Code to cap cost sharing for prescription insulin drugs and diabetes devices.

To amend section 2953.36 of the Revised Code to allow a victim of human trafficking to expunge certain criminal records.

**H. B. No. 386** - Representatives Mathews, Lampton.

To amend sections 122.17, 122.66, 323.151, 3317.021, 3318.011, 5747.02, 5747.10, 5748.01, and 5751.02 of the Revised Code to phase-out the state income tax on nonbusiness income over six years and to repeal the commercial activity tax after 2029.

Said bills were considered the first time.
