INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 631 - Representative Cross.

To enact section 5534.665 of the Revised Code to designate a portion of State Route 273 in Hardin County as the "Major David McGue Memorial Highway."

H. B. No. 632 - Representative Daniels.

Cosponsors: Representatives Hillyer, Lorenz.

To amend sections 2329.01, 2329.151, 2329.152, 2329.153, 2329.17, 2329.18, 2329.19, 2329.20, 2329.211, 2329.26, 2329.27, 2329.312, 2329.51, and 2329.52 of the Revised Code relating to real property foreclosures.

H. B. No. 633 - Representatives Miller, J., Hall.

Cosponsors: Representatives Russo, Brown, Click, Denson, Piccolantonio, McNally, Brennan, Abdullahi.

To amend sections 3314.03 and 3326.11 and to enact sections 3313.7118 and 3707.61 of the Revised Code to require the Department of Health to develop type 1 diabetes informational materials for parents and guardians of elementary school students and to amend the version of section 3314.03 of the Revised Code that is scheduled to take effect January 1, 2025, to continue the changes on and after that date.

H. B. No. 634 - Representative Barhorst.

To amend section 113.53 of the Revised Code to generally exempt funds in an Ohio ABLE account from collection under the Medicaid Estate Recovery Program.

H. B. No. 635 - Representative Swearingen.

To amend sections 929.03, 6103.052, and 6117.062 and to enact sections 6121.30, 6121.31, 6121.32, and 6121.33 of the Revised Code to re-establish the Water and Sewer Commission and the Water and Sewer Fund.

Said bills were considered the first time.
