INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 643 - Representative Edwards.

To express the General Assembly's intent to exempt tips and gratuities from income tax.

H. B. No. 644 - Representatives Thomas, C., Grim.

Cosponsors: Representatives Liston, McNally, Sims, Troy, Denson, Brown, Brennan, Baker, Robinson.

To amend sections 2923.13 and 2923.14 and to enact section 2923.133 of the Revised Code to prohibit certain conduct regarding trigger cranks, bump-fire devices, and other items that accelerate a semi-automatic firearm's rate of fire but do not convert it into an automatic firearm.

H. B. No. 645 - Representatives Isaacsohn, Hall.

To amend sections 5747.08 and 5747.98 and to enact section 5747.86 of the Revised Code to authorize a refundable income tax credit or rebate for homeowners and renters whose property taxes or a portion of their rent exceed five per cent of their income.

H. B. No. 646 - Representative Miller, J.

To amend section 3501.01 and to enact sections 4507.60, 4507.61, and 4507.62 of the Revised Code to authorize the use of a digital driver's license or state identification card.

H. B. No. 647 - Representative Miller, J.

To amend sections 955.20 and 955.221 of the Revised Code to require a county auditor to transfer certain funds from the county's dog and kennel fund

to municipal corporations within the county that employ dog wardens.

H. B. No. 648 - Representatives Lorenz, Lear.

To enact section 5534.927 of the Revised Code to designate a portion of State Route 203 in Delaware County as the "Ronald "Bumpy" Rhoades Memorial Highway."
