Tuesday, January 3, 2023, 1:30 p.m.

This being the day fixed by law for the meeting of the General Assembly in regular session, the Senators and Senators-elect of the One Hundred Thirty-Fifth General Assembly of the State of Ohio, met in the Senate Chamber and were called to order by Senator Matt Huffman, President of the One Hundred Thirty-Fourth General Assembly.

Prayer was offered by Rev. Dr. LaMont Monford, Sr., Philippian Baptist Church, Lima, Ohio. The colors were presented by the Ohio Air National Guard 179th Airlift Color Guard.

The children and grandchildren of the senators and senators-elect assembled in the well and led the Chamber in the Pledge of Allegiance following the presentation of the colors.

The National Anthem was performed by Lima Symphony Orchestra.
