INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bill was introduced and considered for the first time:

S. B. No. 142 - Senator Antonio.

Cosponsors: Senators Sykes, Smith, DeMora, Craig, Hicks-Hudson, Romanchuk, Dolan.

To enact section 5.266 of the Revised Code to designate April as "Arab American Heritage Month."

OFFERING OF RESOLUTIONS

Senator Johnson offered the following concurrent resolution:

To condemn the People's Republic of China for its role in the global drug trade, especially in its capacity as the largest point of origin of fentanyl smuggled to the United States.
