To amend section 4501.21 and to enact section 4503.959 of the Revised Code to create the "Dublin City Schools" license plate.

**S. B. No. 164** - Senator Craig.

Cosponsors: Senators Antonio, DeMora, Sykes.

To amend sections 149.43, 2923.11, 2923.125, 2923.128, and 2923.20 and to enact sections 2923.133, 2923.22, 2923.221, and 4731.058 of the Revised

Code to enact the Suicide Self-Defense Act, relative to the creation of a do not possess firearms registry.

**S. B. No. 165** - Senator Johnson.

Cosponsors: Senators Antani, O'Brien.

To amend sections 2913.02, 2913.51, 4737.012, 4737.04, 4737.041, 4737.045, 4737.99, 4738.03, 4738.07, 4738.12, 4745.01, and 4775.09 and to enact sections 4737.046, 4737.20, 4737.21, 4737.22, 4737.23, 4737.24, 4737.25, and 4737.98 of the Revised Code regarding the sale of used catalytic converters, and to make an appropriation.

**S. B. No. 166** - Senators Sykes, Reynolds.

Cosponsors: Senators Antonio, Craig, Ingram, Smith.

To amend sections 122.71 and 122.76 of the Revised Code to allow a limited amount of minority business direct loans to be used to increase working capital.

**S. B. No. 167** - Senators Gavarone, Manning.

To enact section 5534.654 of the Revised Code to designate a portion of State Route 60 in Erie County as the "Marine Corporal Tim W. Russell Highway."

**S. B. No. 168** - Senator Reynolds.

Cosponsor: Senator Brenner.

To amend sections 3301.0714, 3302.03, 3302.151, 3311.80, 3312.02, 3313.413, 3313.48, 3313.92, 3314.012, 3314.016, 3314.017, 3314.0211, 3314.03, 3314.29, 3314.35, 3319.077, 3319.0811, 3319.111, 3319.112, 3319.172, 3319.22, 3319.27, 3319.291, 3323.251, 3326.11, and 5502.70; to enact sections 3319.225 and 3319.273; and to repeal sections 3301.0717, 3301.131, 3301.134, 3301.14, 3301.30, 3302.22, 3313.6015, 3317.50, 3317.51, 3319.234, 3319.55, 3319.56, and 3319.57 of the Revised Code with regard to education regulation reform and to amend the versions of sections 3301.0714 and 3314.03 of the Revised Code that are scheduled to take effect January 1, 2025, to continue the changes on and after that effective date.
