INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered for the first time:

S. B. No. 184 - Senator Antani.

To amend section 3509.05 of the Revised Code to prohibit boards of elections from receiving absent voters ballots in outdoor receptacles.

S. B. No. 185 - Senator Landis.

Cosponsor: Senator Cirino.

To amend sections 149.43, 149.45, and 319.28 of the Revised Code to exempt redaction request forms, affidavits, and the records of the work schedules of designated public service workers from disclosure under public records law.

OFFERING OF RESOLUTIONS

Senator Schaffer offered the following concurrent resolution:

S. C. R. No. 8-Senator Schaffer.

Cosponsors: Senators Hoagland, Wilkin, Romanchuk.

To urge the President of the United States, the United States Secretary of Veterans Affairs, and the United States Congress to take prompt action to reduce the processing time for veterans' disability benefit claims.

The question being, "Shall the concurrent resolution, **S. C. R. No. 8**, be adopted?"

On the motion of Senator Schaffer, **S. C. R. No. 8**, was referred to the Committee on Rules and Reference.

Senator Schaffer offered the following concurrent resolution:

S. C. R. No. 9-Senator Schaffer.

Cosponsors: Senators Hoagland, Wilkin, Romanchuk, Cirino, Ingram.

To urge the U.S. Congress to support the provision of prompt and comprehensive mental health treatment to military personnel and veterans who are suffering from post-traumatic stress disorder and other service-related stress disorders.

The question being, "Shall the concurrent resolution, **S. C. R. No. 9**, be

adopted?

On the motion of Senator Schaffer, **S. C. R. No. 9**, was referred to the Committee on Rules and Reference.

Pursuant to Senate Rule No. 55, the following resolution was offered:

S. R. No. 230 - Senators Dolan, Craig.

Honoring Caryl Philips for outstanding service to the State of Ohio.

The question being, "Shall the resolution listed under the President's prerogative be adopted?"
