FORTY-SECOND DAY Senate Chamber, Columbus, Ohio Wednesday, May 10, 2023, 1:30 p.m.

The Senate met pursuant to adjournment.

Prayer was offered by Pastor Brian Hanson, Capitol Ministries in Columbus, Ohio, followed by the Pledge of Allegiance to the Flag.

The journal of the last legislative day was read and approved.

To amend sections 145.11, 742.11, 3307.15, 3309.15, 3345.16, 4123.44, 4123.442, and 5505.06 and to enact section 3345.161 of the Revised Code regarding environmental, social, and corporate governance policies with respect to the state retirement systems, Bureau of Workers' Compensation, and state institutions of higher education, was considered the third time.

Proposing to amend Sections 1b, 1e, and 1g of Article II and Sections 1 and 3 of Article XVI of the Constitution of the State of Ohio to require a vote of at least 60% of the electors to approve any constitutional amendment and to modify the procedures for an initiative petition proposing a constitutional amendment.

In line 11, delete "a" and insert "the next general or"

In line 12, delete "to be held on August 8, 2023" and insert "scheduled to occur not earlier than ninety days after this resolution is submitted to the Secretary of State"

In line 10, delete "there shall be submitted" and insert "a special election is hereby called to be held on August 8, 2023, such election being prescribed pursuant to the authority provided by Section 1 of Article XVI of the Constitution of the State of Ohio, and which election shall be conducted pursuant to all applicable laws, for the purpose of submitting"

In line 11, delete ", in the manner prescribed by law at the next"

In line 14, delete "of State,"
