The Senate met pursuant to adjournment.

**OFFERING OF RESOLUTIONS**

Senator Antonio offered the following resolution:

**S. R. No. 257-Senator Antonio.**

To honor the Bulgarian-American heritage in the State of Ohio.

WHEREAS, Bulgaria and the United States are strategic partners and allies, sharing ties of culture, tradition, and common interest; and

WHEREAS, The State of Ohio is proud to be called home by a large number of Bulgarian-Americans and their descendants who have contributed significantly to the economic development, multicultural diversity, and enrichment of all aspects of life in the State of Ohio; and

WHEREAS, 2023 marks the 20th anniversary of the United States Senate's ratification of the Protocol for Accession of Bulgaria into the North Atlantic Treaty Organization (NATO); the 80th anniversary of the rescue of the Bulgarian Jews by the Bulgarian people; and the 120th anniversary of the establishment of diplomatic relations between the United States and Bulgaria; and

WHEREAS, March 3, 2023, marks the 145th anniversary of the reestablishment of a free Bulgaria; and

WHEREAS, The saving of Bulgarian Jews during World War II is a valuable lesson about the essential role of civic mobilization in support of freedom, democracy, the rule of law, and human rights. It is a powerful, positive example that inspires today's efforts of the civilized world to fight the modern manifestations of antisemitism; and

WHEREAS, Bulgaria, as a member of NATO and an integral part of the European Union, is a strategic partner to the United States and a key ally in Eastern Europe, contributing to the stability of the Balkan Peninsula and Black Sea Region; and

WHEREAS, Bulgaria and the United States entered into the U.S.-Bulgarian Defense Cooperation Agreement in 2006, providing the U.S. military access to specified Bulgarian military facilities; and

WHEREAS, In 2020, the United States and Bulgaria signed a 10-year Roadmap for Defense Cooperation to foster increased military cooperation and preparation; now therefore be it

RESOLVED, That we, the members of the Senate of the 135th General Assembly of Ohio, in adopting this Resolution, honor the Bulgarian-American heritage in the state of Ohio and recognize and applaud the historic significance of the 145th anniversary of the re-establishment of the sovereign and independent Republic of Bulgaria; and be it further

RESOLVED, That we reaffirm the bonds of friendship and cooperation that have existed between the United States, the State of Ohio, and the Republic of Bulgaria for the past 120 years and commit to strengthening these bonds; and be it further

RESOLVED, That the Clerk of the Senate transmit duly authenticated copies of this resolution to the Consul General of the Republic of Bulgaria in Chicago.

**RESOLUTIONS REPORTED BY COMMITTEE**

**S. R. No. 240**-Senator Johnson.

Cosponsors: Senators Brenner, Cirino, Dolan, Hackett, Hoagland, Kunze, Lang, McColley, O'Brien, Reineke, Romanchuk, Rulli, Schaffer, Schuring, Wilkin, Wilson.

To condemn the People's Republic of China for its role in the global drug trade, especially in its capacity as the largest point of origin of fentanyl smuggled to the United States.

WHEREAS, The People's Republic of China (PRC) has adopted a permissive and indifferent attitude toward rampant money laundering and drug trafficking taking place within its borders; and

WHEREAS, According to the U.S.-China Economic and Security Review Commission, "the DEA [Drug Enforcement Administration] reported [in 2020 that] it informally asked its Chinese counterparts for assistance with the [Xianbing] Gan investigation but did not receive Chinese support despite multiple requests"; and

WHEREAS, The Los Zheng cartel continues to operate in the PRC and Mexico and, according to intelligence professionals, maintains "the largest presence in Mexico for trafficking fentanyl and methamphetamines," but its leaders based in Shanghai have not been apprehended by PRC officials; and

WHEREAS, Admiral Craig Faller has testified to the U.S. Congress that the PRC is "at least tacitly supporting" money laundering activity associated with the global drug trade; and

WHEREAS, John Tobon, the Chief of the Homeland Security Investigations office in Honolulu, claimed, "The amount of money coming out of China via the underground banking system is so significant that it would be virtually impossible for a government that has as much control of their people as the government of China to not be aware of how it's happening"; and

WHEREAS, The PRC has been slow to respond to U.S. requests for access to investigate potential sites of illegal chemical production, often allowing operations to escape detection; and

WHEREAS, According to the Congressional Research Service, "On August 5, 2022, in response to House Speaker Nancy Pelosi's visit to Taiwan, the PRC's Ministry of Foreign Affairs announced the PRC's formal suspension of U.S.-China cooperation in five areas, including counternarcotics"; and

WHEREAS, The PRC has implemented economic incentives that encourage the production and distribution of fentanyl, along with its analogues and precursors; and

WHEREAS, The "New and High Technology Enterprise" designation

by the PRC has allowed companies like Yuancheng and 5A Pharmatech Co., which distribute fentanyl, to enjoy financial incentives and preferential tax policies; and

WHEREAS, Yuancheng also has been a beneficiary of economic programs and initiatives sponsored by the PRC's Ministry of Science and Technology, including the Torch Program, the Spark Program, and the Innovation Fund; and

WHEREAS, In the PRC, fentanyl receives a 10% value-added tax rebate, and several fentanyl analogues and precursors receive 13% rebates. Higher rebate rates increase the incentive to export that product; and

WHEREAS, To the extent that the PRC is involved directly in enabling the global drug trade, the PRC does so as a means of facilitating destabilization and division in the United States and across the region more broadly; now therefore be it

RESOLVED, That we, the members of the Senate of the 135th General Assembly of the State of Ohio, condemn the PRC's campaign of attempting to destabilize and divide the United States and the broader region through its tolerance and facilitation of the global drug trade; and be it further

RESOLVED, That the Clerk of the Senate transmit duly authenticated copies of this resolution to the members of Ohio's Congressional delegation, Secretary of State Antony Blinken, and the news media of Ohio.

- (4) A parent of a transgender child appointed by Trans Allies of Ohio.
- (B) The Commission, by a majority vote of a quorum of its members, shall select an individual to serve as its chairperson.
- (C) The Commission shall meet quarterly in calendar year 2024 at the call of the chairperson.
- (D) The purpose of the Commission is to:
- (1) Study the current state of economic opportunity for transgender people in Ohio;
  - (2) Study the current state of health care for transgender people in Ohio, including access and quality;
  - (3) Ascertain best practices within Ohio with respect to health care for transgender people;
  - (4) Reconcile conflicting data and develop a common baseline of data regarding transgender people in Ohio;
  - (5) Ascertain the type and number of supportive human resources policies by Ohio businesses;

Steurer, Democrat, from Lewis Center, Delaware County, Ohio, as a Member of the Ohio Commission on Service and Volunteerism for a new term beginning May 5, 2023 and ending at the close of business April 21, 2026, replacing Pamela S. Steurer, whose term expired.
