INTRODUCTION AND FIRST CONSIDERATION OF BILLS

To amend sections 505.82, 1514.10, 1517.01, 1517.02, 1517.021, 1517.11, 1531.04, 1546.01, 1546.02, 1546.04, 1547.73, 1547.75, 1547.81, 1547.82, 1547.83, 1547.84, 1547.85, 1547.86, 3714.03, and 4501.24 and to amend, for the purpose of adopting new section numbers as indicated in parentheses, sections 1547.81 (1517.14), 1547.82 (1517.15), 1547.83 (1517.16), 1547.84 (1517.17), 1547.85 (1517.18), and 1547.86 (1517.19) of the Revised Code to revise the law governing the designation of wild, scenic, and recreational rivers.

S. B. No. 157 - Senator Lang.

To amend sections 1317.05 and 3905.426 and to enact section 1310.251 of the Revised Code to modify the law governing debt suspension products, extended wear and use waivers, motor vehicle ancillary product protection contracts, and vehicle protection agreements.

S. B. No. 158 - Senator Cirino.

To amend section 705.19 of the Revised Code regarding the disbursement of municipal funds by residents and to declare an emergency.

S. B. No. 159 - Senator O'Brien.

Cosponsors: Senators Johnson, Schaffer, Antani.

To amend sections 5747.98 and 5751.98 and to enact sections 5747.74 and 5751.55 of the Revised Code to authorize a nonrefundable tax credit for donations to certain pregnancy resource centers.
