To amend sections 122.925, 124.23, 145.30, 742.52, 742.521, 2151.4210, 3307.75, 3309.02, 3313.471, 3319.085, 3511.01, 4731.36, 4743.041, 5747.01, 5903.01, 5903.02, 5907.01, 5907.04, and 5910.01 of the Revised Code to include Space Force in the definition of the armed forces, armed services, and uniformed services of the United States, and to amend the version of section 4743.041 of the Revised Code that is scheduled to take effect December 29, 2023, to continue the change on and after that date.
