### **INTRODUCTION AND FIRST CONSIDERATION OF BILLS**

The following bills were introduced and considered for the first time:

**S. B. No. 89** - Senator Roegner.

To amend section 4713.37 and to enact sections 4713.33 and 4713.331 of the Revised Code to enter into the Cosmetology Licensure Compact and to amend the version of section 4713.37 of the Revised Code that is scheduled to take effect on December 29, 2023, to continue the changes on and after that date.

**S. B. No. 90** - Senator Roegner.

To enact sections 4757.52 and 4757.521 of the Revised Code to enter into the Social Work Licensure Compact.

**S. B. No. 91** - Senator Schaffer.

Cosponsors: Senators Cirino, Romanchuk.

To amend sections 117.103, 124.341, 126.47, 1347.15, and 4113.52 of the Revised Code regarding fraud, waste, and abuse of public funds.

**S. B. No. 92** - Senators McColley, Gavarone.

To amend section 3501.022 of the Revised Code to allow a special election to be held in August for certain purposes and to make an appropriation.

### **OFFERING OF RESOLUTIONS**
