**INTRODUCTION AND FIRST CONSIDERATION OF BILLS**

The following bills were introduced and considered for the first time:

**S. B. No. 214** - Senator Kunze.

Cosponsors: Senators Antonio, DeMora, Manning, Smith, Sykes.

To amend section 2953.36 of the Revised Code to allow a victim of human trafficking to expunge certain criminal records.

**S. B. No. 215** - Senators Gavarone, McColley.

To amend sections 3517.01, 3517.10, 3517.12, 3517.13, and 3517.992 of the Revised Code to prohibit foreign nationals from making contributions or expenditures regarding ballot issue campaigns.

**S. B. No. 216** - Senators Lang, Huffman, S.

To amend sections 122.17, 122.66, 323.151, 3317.021, 3318.011, 5747.02, 5747.10, 5748.01, and 5751.02 of the Revised Code to phase-out the state income tax on nonbusiness income over six years and to repeal the commercial activity tax after 2029.
