RESOLUTIONS REPORTED BY COMMITTEE

Am. S. R. No. 121-Senator Rulli.

Cosponsors: Senators Landis, Romanchuk, Brenner.

To recognize that natural gas and its production industry are vital to Ohio's economic future and to urge continued investment in natural gas infrastructure to make affordable energy available to every Ohioan.

WHEREAS, Natural gas is a leading contributor to clean, affordable,

and reliable energy security, and it is vital for Ohio families and businesses in maintaining lower energy bills and for Ohio to become the low-cost energy capital of the United States; and

WHEREAS, Ohio's natural gas industry has transformed from a low production industry to one of the top seven in terms of production when compared to other states; and

WHEREAS, Ohio is a leader in clean energy technology, and the natural gas industry leads Ohio in clean electricity production when compared to other energy sources such as nuclear, wind, and solar. In addition, in 2019, natural gas generated more of Ohio's in-state electricity than coal for the first time in history; and

WHEREAS, Natural gas saves the average Ohio family \$2,500 annually in total energy costs, including over \$1,000 for home heating and appliances. The 36% of Ohioans utilizing other energy sources do not realize these savings; and

WHEREAS, The natural gas industry supports 375,000 jobs, which constitutes 5.3% of Ohio's total employment. In addition, the natural gas industry contributed \$58.8 billion to Ohio's gross domestic product in 2019; now therefore be it

RESOLVED, That we, the members of the Senate of the 135th General Assembly of Ohio, in adopting this resolution, recognize that natural gas and the natural gas industry are vital components of the state's economic future and urge continued investment in natural gas infrastructure to make affordable energy available to every Ohioan; and be it further

RESOLVED, That the clerk of the Senate send duly authenticated copies of this resolution to the President of the United States, the President Pro Tempore and Clerk of the United States Senate, the Speaker and Clerk of the United States House of Representatives, each member of the Ohio congressional delegation, Governor Mike DeWine, and the news media of Ohio.

S. R. No. 241-Senator Johnson.

Cosponsors: Senators Brenner, Cirino, Dolan, Lang, Reynolds, Romanchuk, Schaffer, Schuring.

To condemn the People's Republic of China and the Chinese Communist Party for conducting unrestricted warfare against the world, and especially against the United States, and for the systematic, brutal oppression of its own people.

WHEREAS, There have been over 200 reported instances of Chinese espionage directed at the United States since 2000, many cases involving attempts to smuggle controlled items from the United States to China, usually munitions or controlled technologies, and more than 1,200 cases of intellectual property theft lawsuits brought by United States companies against Chinese entities; and

WHEREAS, In the years immediately before 2019, China was the primary source of United States-bound illicit fentanyl, fentanyl-related substances, and production equipment. The People's Republic of China's (PRC) traffickers supplied fentanyl and fentanyl-related substances directly to the United States via international mail and express consignment operations; and

WHEREAS, To the extent that the PRC is involved directly in enabling the global drug trade, the PRC does so as a means of facilitating destabilization and division in the United States and across the region more broadly; and

WHEREAS, The PRC failed to keep the COVID-19 virus from spreading, and was less than forthcoming with respect to information about the virus; and

WHEREAS, The United States Department of Energy has assessed that the COVID-19 pandemic most likely came from a laboratory leak in Wuhan, China; and

WHEREAS, The PRC's strict COVID-19 policy resulted in unpredictable lockdowns, idle ports, and congested infrastructure, contributing greatly to the global supply chain crisis; and

WHEREAS, Despite claims of international environmental leadership, the PRC's energy-related carbon dioxide emissions are rising. It has been the world's largest annual greenhouse gas emitter since 2006, with total energy-related emissions twice that of the United States and nearly one-third of all emissions globally; and

WHEREAS, The PRC has arbitrarily detained more than one million Uyghurs and other mostly Muslim minorities in China's far western Xinjiang Uyghur Autonomous Region; and

WHEREAS, It is estimated that 100,000 Uyghurs and other ethnic minority ex-detainees in China may be working in conditions of forced labor following detention in reeducation camps, and many more rural poor workers also experience coercion without detention; and

WHEREAS, The PRC has been included on the List of Goods Produced by Child Labor or Forced Labor since 2009; and

WHEREAS, The final judgment of the Independent Tribunal into Forced Organ Harvesting from Prisoners of Conscience in China Tribunal, published in March 2020, concluded that forced organ harvesting from prisoners of conscience has been practiced for a substantial period of time involving a very substantial number of victims; and

WHEREAS, Chinese espionage is undertaken in pursuit of China's strategic objectives; and

WHEREAS, The PRC has imposed a sweeping national security law on Hong Kong, limiting freedoms of the press and speech, and arresting pro-democracy activists, lawmakers, and journalists, raising questions about Hong Kong's status as a global financial hub; and

WHEREAS, The PRC has employed a variety of coercive tactics to intimidate Taiwan; and

WHEREAS, The PRC has increased the frequency and scale of patrols of PLA bombers, fighter jets, and surveillance aircraft over and around Taiwan, and also has increasingly sailed its warships and aircraft carriers through the Taiwan Strait in shows of force; and

WHEREAS, Taiwan has reported that thousands of cyber attacks from the PRC target its government agencies every day; and

WHEREAS, The PRC regularly is accused of state-organized economic espionage and theft of intellectual property; and

WHEREAS, The PRC is upgrading its offensive nuclear ballistics, airborne, subsurface, and intercontinental ballistic missiles (ICBM). It is reported that the PRC is constructing as many as 200 ICBM sites in West China; and

WHEREAS, Across much of the Indo-Pacific region, the Chinese Communist Party (CCP) is using military and economic coercion to bully its neighbors, advance unlawful maritime claims, and threaten maritime shipping lanes; and

WHEREAS, The PRC, in direct contravention of international law, and ignoring a recent decision of the Permanent Court of Arbitration in the Hague, has fabricated phony islands in the South China Sea and elsewhere, and has militarized them, thus making false claims to vast ocean territories clearly not their own; and

WHEREAS, Support from the PRC is critical to Russia's ability to continue waging its war against Ukraine. A report from the Office of the Director of National Intelligence has outlined how a range of actors, including the Chinese government, the CCP, state-owned Chinese companies, and other Chinese entities, are supporting Russia's economy and its military; and

WHEREAS, The PRC incorporates a network of monitoring systems to monitor Chinese citizens, including internet surveillance, camera surveillance, and other digital technologies; and

WHEREAS, Under a 2016 cybersecurity law, the PRC, with the help of corporations, has significantly increased mass surveillance. It is estimated that 200 million monitoring cameras have been put to use in mainland China; and

WHEREAS, The CCP continues to violate the right to freedom of religion, persecuting Christians, demolishing churches, and arresting leaders. Tibetan Buddhists are targeted through strict state surveillance, destruction of religious sites, and mass eviction of clergy. More than 500 Tibetans currently are held as political prisoners, including the Panchen Lama, the Dalai Lama's intended successor. These concerns are heightened by the CCP's new forced labor transfer policy. Uyghur Muslims are subject to some of the worst abuses. Between 1.8 million and 3 million Uyghurs have been interned in hundreds of political reeducation camps in Xinjiang Province since 2018, where they face brutalities including forced labor, torture, sexual abuse, and forced abortion and sterilization. Hui Muslims also have witnessed tightening restrictions, including forced mosque closures and imprisonment of religious leaders. The Falun Gong members reportedly are subject to forced organ harvesting and extrajudicial imprisonment; now therefore be it

RESOLVED, That we, the members of the Senate of the 135th General Assembly of the State of Ohio, in adopting this resolution, condemn the People's Republic of China and the Chinese Communist Party for these actions, which constitute unrestricted warfare against the world, and especially against the United States, as described in the 1999 book on military strategy, entitled "Unrestricted Warfare: Two Air Force Senior Colonels on Scenarios for War and the Operational Art in an Era of Globalization," by two colonels in the People's Liberation Army, Qiao Liang and Wang Xiangsui, and for the systematic, brutal oppression of its own people; and be it further

RESOLVED, That the Clerk of the Senate transmit a duly authenticated copy of this resolution to the news media of Ohio.
