# INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered for the first time:

S. B. No. 309 - Senator Wilson.

Cosponsor: Senator Cirino.

To amend sections 1715.51, 3315.10, and 3315.41 and to enact sections 3314.55, 3315.43, 3326.53, and 3328.53 of the Revised Code to permit community foundations to be trustees of endowments and other charitable funds received by public schools and to classify some funds held by community foundation trustees as institutional funds.

S. B. No. 310 - Senator Chavez.

To enact section 5534.672 of the Revised Code to designate a portion of I-77 in Noble County as the "U.S.S. Shenandoah Memorial Highway."

S. B. No. 311 - Senator O'Brien.

To amend sections 3310.034 and 3310.51 of the Revised Code to permit students to concurrently receive an Educational Choice scholarship or Pilot Project scholarship and either an Autism or Jon Peterson Special Needs scholarship.
