A BILL

То	amend section 5902.02 and to enact sections	1
	5902.09 and 5919.21 of the Revised Code to	2
	create the Ohio Cold War Victory Medal.	3

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 5902.02 be amended and sections	4
5902.09 and 5919.21 of the Revised Code be enacted to read as	5
follows:	6
Sec. 5902.02. The duties of the director of veterans	7
services shall include the following:	8
(A) Furnishing the veterans service commissions of all	9
counties of the state copies of the state laws, rules, and	10
legislation relating to the operation of the commissions and	11
their offices;	12
(B) Upon application, assisting the general public in	13
obtaining records of vital statistics pertaining to veterans or	14
their dependents;	15
(C) Adopting rules pursuant to Chapter 119. of the Revised	16

Code pertaining to minimum qualifications for hiring,	17
certifying, and accrediting county veterans service officers,	18
pertaining to their required duties, and pertaining to	19
revocation of the certification of county veterans service	20
officers;	21
(D) Adopting rules pursuant to Chapter 119. of the Revised	22
Code for the education, training, certification, and duties of	23
veterans service commissioners and for the revocation of the	24
certification of a veterans service commissioner;	25
(E) Developing and monitoring programs and agreements	26
enhancing employment and training for veterans in single or	27
multiple county areas;	28
(F) Developing and monitoring programs and agreements to	29
enable county veterans service commissions to address	30
homelessness, indigency, and other veteran-related issues	31
individually or jointly;	32
(G) Developing and monitoring programs and agreements to	33
enable state agencies, individually or jointly, that provide	34
services to veterans, including the veterans' homes operated	35
under Chapter 5907. of the Revised Code and the director of job	36
and family services, to address homelessness, indigency,	37
employment, and other veteran-related issues;	38
(H) Establishing and providing statistical reporting	39
formats and procedures for county veterans service commissions;	40
(I) Publishing electronically a listing of county veterans	41
service offices and county veterans service commissioners. The	42
listing shall include the expiration dates of commission	43
members' terms of office and the organizations they represent;	44
the names, addresses, and telephone numbers of county veterans	45

service offices; and the addresses and telephone numbers of the

Ohio offices and headquarters of state and national veterans

service organizations.

- (J) Establishing a veterans advisory committee to advise 49 and assist the department of veterans services in its duties. 50 Members shall include a member of the national guard association 51 of the United States who is a resident of this state, a member 52 of the paralyzed veterans of America who is a resident of this 53 state, a member of the military officers association of America 54 who is a resident of this state, a state representative of 55 56 congressionally chartered veterans organizations referred to in section 5901.02 of the Revised Code, a representative of any 57 other congressionally chartered state veterans organization that 58 has at least one veterans service commissioner in the state, 59 three representatives of the Ohio state association of county 60 veterans service commissioners, who shall have a combined vote 61 of one, three representatives of the state association of county 62 veterans service officers, who shall have a combined vote of 63 one, one representative of the county commissioners association 64 of Ohio, who shall be a county commissioner not from the same 65 county as any of the other county representatives, a 66 representative of the advisory committee on women veterans, a 67 representative of a labor organization, and a representative of 68 the office of the attorney general. The department of veterans 69 services shall submit to the advisory committee proposed rules 70 for the committee's operation. The committee may review and 71 revise these proposed rules prior to submitting them to the 72 joint committee on agency rule review. 73
- (K) Adopting, with the advice and assistance of the 74 veterans advisory committee, policy and procedural guidelines 75 that the veterans service commissions shall adhere to in the 76

development and implementation of rules, policies, procedures,	77
and guidelines for the administration of Chapter 5901. of the	78
Revised Code. The department of veterans services shall adopt no	79
guidelines or rules regulating the purposes, scope, duration, or	80
amounts of financial assistance provided to applicants pursuant	81
to sections 5901.01 to 5901.15 of the Revised Code. The director	82
of veterans services may obtain opinions from the office of the	83
attorney general regarding rules, policies, procedures, and	84
guidelines of the veterans service commissions and may enforce	85
compliance with Chapter 5901. of the Revised Code.	86
(L) Receiving copies of form DD214 filed in accordance	87
with the director's guidelines adopted under division (L) of	88
this section from members of veterans service commissions	89
appointed under section 5901.02 and from county veterans service	90
officers employed under section 5901.07 of the Revised Code;	91
(M) Developing and maintaining and improving a resource,	92
such as a telephone answering point or a web site, by means of	93
which veterans and their dependents, through a single portal,	94
can access multiple sources of information and interaction with	95
regard to the rights of, and the benefits available to, veterans	96
and their dependents. The director of veterans services may	97
enter into agreements with state and federal agencies, with	98
agencies of political subdivisions, with state and local	99
instrumentalities, and with private entities as necessary to	100
make the resource as complete as is possible.	101
(N) Planning, organizing, advertising, and conducting	102
outreach efforts, such as conferences and fairs, at which	103
veterans and their dependents may meet, learn about the	104
organization and operation of the department of veterans	105

services and of veterans service commissions, and obtain

information about the rights of, and the benefits and services	107
available to, veterans and their dependents;	108
(O) Advertising, in print, on radio and television, and	109
otherwise, the rights of, and the benefits and services	110
available to, veterans and their dependents;	111
(P) Developing and advocating improved benefits and	112
services for, and improved delivery of benefits and services to,	113
veterans and their dependents;	114
(Q) Searching for, identifying, and reviewing statutory	115
and administrative policies that relate to veterans and their	116
dependents and reporting to the general assembly statutory and	117
administrative policies that should be consolidated in whole or	118
in part within the organization of the department of veterans	119
services to unify funding, delivery, and accounting of statutory	120
and administrative policy expressions that relate particularly	121
to veterans and their dependents;	122
(R) Encouraging veterans service commissions to innovate	123
and otherwise to improve efficiency in delivering benefits and	124
services to veterans and their dependents and to report	125
successful innovations and efficiencies to the director of	126
veterans services;	127
(S) Publishing and encouraging adoption of successful	128
innovations and efficiencies veterans service commissions have	129
achieved in delivering benefits and services to veterans and	130
their dependents;	131
(T) Establishing advisory committees, in addition to the	132
veterans advisory committee established under division (J) of	133
this section, on veterans issues;	134
(II) Developing and maintaining a relationship with the	135

United States department of veterans affairs, seeking optimal	136
federal benefits and services for Ohio veterans and their	137
dependents, and encouraging veterans service commissions to	138
maximize the federal benefits and services to which veterans and	139
their dependents are entitled;	140
(V) Developing and maintaining relationships with the	141
several veterans organizations, encouraging the organizations in	142
their efforts at assisting veterans and their dependents, and	143
advocating for adequate state subsidization of the	144
organizations;	145
(W) Requiring the several veterans organizations that	146
receive funding from the state annually, not later than the	147
thirtieth day of July, to report to the director of veterans	148
services and prescribing the form and content of the report;	149
(X) Reviewing the reports submitted to the director under	150
division (W) of this section within thirty days of receipt and	151
informing the veterans organization of any deficiencies that	152
exist in the organization's report and that funding will not be	153
released until the deficiencies have been corrected and a	154
satisfactory report submitted;	155
(Y) Releasing funds and processing payments to veterans	156
organizations when a report submitted to the director under	157
division (W) of this section has been reviewed and determined to	158
be satisfactory;	159
(Z) Furnishing copies of all reports that the director of	160
veterans services has determined have been submitted	161
satisfactorily under division (W) of this section to the	162
chairperson of the finance committees of the general assembly;	163
(AA) Investigating complaints against county veterans	164

services commissioners and county veterans service officers if	165
the director reasonably believes the investigation to be	166
appropriate and necessary;	167
(BB) Developing and maintaining a web site that is	168
accessible by veterans and their dependents and provides a link	169
to the web site of each state agency that issues a license,	170
certificate, or other authorization permitting an individual to	171
engage in an occupation or occupational activity;	172
(CC) Encouraging state agencies to conduct outreach	173
efforts through which veterans and their dependents can learn	174
about available job and education benefits;	175
(DD) Informing state agencies about changes in statutes	176
and rules that affect veterans and their dependents;	177
(EE) Assisting licensing agencies in adopting rules under	178
section 5903.03 of the Revised Code;	179
(FF) Administering the provision of grants from the	180
military injury relief fund under section 5902.05 of the Revised	181
Code;	182
(GG) Issuing a county veterans service officer	183
certification or county veterans service commissioner	184
certification in accordance with Chapter 4796. of the Revised	185
Code to an applicant if the applicant holds a license or	186
certification in another state or the applicant has satisfactory	187
work experience, a government certification, or a private	188
certification as described in that chapter as a county veterans	189
service officer or county veterans service commissioner, or in a	190
position that is the equivalent to county veterans service	191
officer or county veterans service commissioner, in a state that	192
does not issue that license or certification;	193

(HH) Administering a program for the distribution of the	194
Ohio cold war victory medal created in section 5919.21 of the	195
Revised Code;	196
(II) Taking any other actions required by this chapter.	197
Sec. 5902.09. (A) An individual may apply to the director	198
of veterans services, on a form prescribed by the director, to	199
receive an Ohio cold war victory medal. The applicant shall	200
include with the application a fee in an amount to be determined	201
by the director. The director shall set the fee at an amount not	202
greater than the cost of producing the medal. The director shall	203
award the medal to each applicant who meets the criteria in	204
division (A) of section 5919.21 of the Revised Code.	205
(B) The director shall not award the Ohio cold war victory	206
medal if a federal cold war medal or an equivalent federal medal	207
is available to be awarded.	208
Sec. 5919.21. (A) The Ohio cold war victory medal is	209
created. The adjutant general shall design the medal in a manner	210
that resembles equivalent medals adopted by other states and	211
veterans' organizations. To be eligible to receive the medal, an	212
individual must be all of the following:	213
(1) A current or former member of the Ohio national quard	214
who enlisted for a term of not less than eighteen consecutive	215
months between September 2, 1945, and December 26, 1991;	216
(2) A current or former member of the Ohio national guard	217
who was a resident of this state at the time the member was	218
enlisted, as described in division (A) (1) of this section;	219
(3) In the case of a former member of the Ohio national	220
guard, an individual who was discharged or released from service	221
under conditions other than dishonorable.	222

(B) The Ohio cold war victory medal fund is created in the	223
state treasury. The fund shall consist of all fees collected	224
from applicants for medals, as well as any appropriations made	225
by the general assembly for purposes of the medal program. The	226
fund shall be used to pay for the production of medals.	227
Investment earnings of the fund shall be credited to the fund.	228
Section 2. That existing section 5902.02 of the Revised	229
Code is hereby repealed.	230
Section 3. Section 5902.02 of the Revised Code is	231
presented in this act as a composite of the section as amended	232
by both S.B. 131 and S.B. 259 of the 134th General Assembly. The	233
General Assembly, applying the principle stated in division (B)	234
of section 1.52 of the Revised Code that amendments are to be	235
harmonized if reasonably capable of simultaneous operation,	236
finds that the composite is the resulting version of the section	237
in effect prior to the effective date of the section as	238
presented in this act	230
