A BILL

To amend section 3704.99 and to enact sections	1
3704.21, 3704.22, and 3704.23 of the Revised	2
Code to prohibit a person from engaging in solar	3
radiation modification and to name the act the	4
Atmosphere Protection Act.	5

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 3704.99 be amended and sections	6
3704.21, 3704.22, and 3704.23 of the Revised Code be enacted to	7
read as follows:	8
Sec. 3704.21. As used in sections 3704.21 to 3704.23 of the Revised Code:	9 10
(A) "Pollutant" means any aerosol; biologic,	11
transbiologic, or genetically modified agent; chaff; metal;	12
radioactive material; acid; alkali; chemical; particulate;	13
contaminant; smart dust; smoke; soot; fume; vapor; air pollutant	14
regulated by this state; mechanical vibration or other physical	15
agent; waste, including materials that may be recycled,	16
reconditioned, or reclaimed; solid, liquid, gaseous, or thermal	17
irritant; or artificially produced electric field, magnetic	18

field, electromagnetic field, electromagnetic pulse, sound wave,	19
sound pollution, light pollution, microwave, or ionizing or non-	20
ionizing radiation.	21
(B) "Solar radiation modification" means an experiment in	22
the earth's climatic system involving the release of pollutants	23
that reduces the amount of sunlight reaching the earth's	24
surface.	25
Sec. 3704.22. No person shall engage in solar radiation	26
modification in this state, including through the use of an	27
aircraft, balloon, space-based platform, or interoperable	28
ground-based facility.	29
A violation of this section is a strict liability offense	30
and section 2901.20 of the Revised Code does not apply.	31
Sec. 3704.23. (A) The director of environmental protection	32
shall adopt policies that encourage the public to monitor,	33
measure, document, and report present, potential, and past	34
incidents that may constitute solar radiation modification.	35
(B) The director shall adopt policies and procedures to	36
aid the public in reporting and presenting evidence of solar	37
radiation modification or attempted solar radiation	38
modification.	39
(C) The director shall investigate any report of solar	40
radiation modification or attempted solar radiation	41
modification.	42
(D) The director shall issue a cease-and-desist order to a	43
person who the director determines is conducting or attempting	44
to conduct solar radiation modification. No person shall fail to	45
comply with a cease and desist order issued under this division.	46

A violation of this division is a strict liability offense 47 and section 2901.20 of the Revised Code does not apply. 48 Sec. 3704.99. (A) Whoever recklessly violates division 49 (A), (B), (C), (D), (E), (F), (G), or (I) of section 3704.05 or 50 division (B)(5) of section 3704.16 of the Revised Code shall be 51 fined not more than twenty-five thousand dollars or imprisoned 52 not more than one year, or both, for each violation. Each day 53 the violation continues after a conviction for a violation is a 54 separate offense. 55 (B) Whoever knowingly violates division (H), (J), or (K) 56 of section 3704.05 of the Revised Code shall be fined not more 57 than ten thousand dollars for each day of each such violation. 58 (C) Whoever violates section 3704.15 of the Revised Code 59 is guilty of a misdemeanor of the first degree. 60 (D) Whoever violates division (B)(2) or knowingly violates 61 division (C)(1) of section 3704.16 of the Revised Code is guilty 62 of a minor misdemeanor. 63 (E) Whoever violates division (B)(1) or (3) or knowingly 64 violates division (C)(2) or (3) of section 3704.16 of the 65 Revised Code shall be fined not less than five hundred nor more 66 than twenty-five hundred dollars for each day of each violation. 67 (F) Whoever recklessly violates division (B)(4) of section 68 3704.16 of the Revised Code shall be fined not more than twenty-69 five thousand dollars or imprisoned not more than one year, or 70 71 both, for each violation. Each day the violation continues after a conviction for a violation is a separate offense. 72 (G) The sentencing court, in addition to the penalty 73

(G) The sentencing court, in addition to the penalty 73 provided in divisions (D), (E), and (F) of this section, shall 74 order the offender to restore within thirty days any emission 75
