BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 3333.47 of the Revised Code be	5
enacted to read as follows:	6
Sec. 3333.47. (A) As used in this section, "qualifying	7
institution" means either of the following:	8
(1) A state institution of higher education, as defined in	9
section 3345.011 of the Revised Code;	10
(2) A private nonprofit institution of higher education	11
that holds a certificate of authorization pursuant to Chapter	12
1713. of the Revised Code.	13
(B) (1) The chancellor of higher education shall establish	14
and administer the hunger-free campus grant program and	15
designation. Under the program, the chancellor shall award	16
grants to qualifying institutions, prioritizing institutions	1.7

with higher percentages of Pell grant-eligible students	18
enrolled. Grants shall be used by institutions to support or	19
leverage existing basic needs infrastructure, maximize federal	20
programs, build strategic partnerships at the local, state, and	21
national levels to address food insecurity among students, and	22
to raise awareness on resources available to address basic food	23
needs.	24
(2) The chancellor shall develop an application process	25
for the grant program. A qualifying institution is eligible for	26
an initial hunger-free campus grant if it demonstrates a	27
commitment to basic needs infrastructure and intends to use	28
funds to pursue the hunger-free campus designation. A qualifying	29
institution with an existing hunger-free campus designation is	30
eligible to apply for additional hunger-free campus grants.	31
(3) The chancellor shall develop a method to determine the	32
amount of a grant the chancellor awards to an institution. The	33
chancellor shall develop a tiered system for awards that permits	34
institutions with existing hunger-free campus designations to	35
receive larger grants.	36
(4) Each institution that receives a grant under the	37
hunger-free campus grant program shall report to the chancellor	38
information on how the grant is used and its effects on food	39
security on the institution's campus for each academic year in	40
which the institution receives the grant. If an institution has	41
not received a hunger-free campus designation, the institution	42
shall report its progress toward qualifying for that	43
designation.	44
(C) The chancellor of higher education shall develop an	45
application process for a qualifying institution to receive a	46
hunger-free campus designation. The chancellor shall award a	47

hunger-free campus designation to each qualifying institution	48
that the chancellor determines satisfies both of the following	49
conditions:	50
(1) The institution does either of the following:	51
(a) Provides free meals to students who have demonstrated	52
food insecurity or establishes campus emergency funds for such	53
students. Institutions may establish a definition or method by	54
which to identify students who have demonstrated food insecurity	55
but shall include students who have an expected family	56
contribution of zero dollars and students who are work-study	57
eligible, as determined by the free application for federal	58
student aid. Free meals or funds may be provided through any of	59
the following methods:	60
(i) Establishing a student meal plan credit donation	61
program through which any enrolled student who has purchased a	62
meal plan may donate any meal on such plan to the program, and	63
any enrolled student who has demonstrated food insecurity may	64
apply to the program to redeem a donated meal at a meal-plan	65
eligible on-campus dining location in accordance with applicable	66
<pre>food safety regulations;</pre>	67
(ii) Designating an amount of the institution's funds for	68
free meal vouchers or gift cards for students who have	69
demonstrated food insecurity that may be used at campus stores,	70
eateries, or local establishments;	71
(iii) Establishing a campus emergency fund to support	72
students with emergency expenses, including those associated	73
with food, shelter, utilities, and childcare. An institution	74
shall limit barriers to access those funds.	75
(b) Assists students with accessing food pantries or	76

charitable food distributions by establishing an on-campus food	77
pantry or charitable distribution. All food provided from an on-	78
campus food pantry or charitable distribution shall be free to	79
all students. An institution shall not require a student to	80
demonstrate need to access the food pantry or distribution	81
service. An institution may require an individual to show a	82
valid student identification card to access food from an on-	83
campus food pantry or charitable distribution. An on-campus food	84
pantry shall include at least one staffed physical food pantry	85
on campus located in a safe and secure environment and shall	86
include measures to ensure that students may receive food	87
without facing stigma. An institution shall provide notice of	88
the food pantry or charitable distribution on the institution's	89
web site, including hours of operation and updated contact	90
information for staff members involved in operating the food	91
pantry or charitable distribution and information on other	92
efforts to address hunger at the institution.	93
(2) The institution does at least three of the following:	94
(a) Ensures that students have access to accurate and	95
current information about the supplemental nutrition assistance	96
program, other available food assistance programs, and programs	97
that support basic needs security, including information on	98
program eligibility, application processes, and how to use	99
program benefits. An institution may satisfy this condition by	100
doing any of the following:	101
(i) Including information on food assistance and basic	102
needs security programs in all financial aid information;	103
(ii) Including information on food assistance and basic	104
needs security programs in new student orientation materials;	105

(iii) Including information on food assistance and basic	106
needs security programs in each course syllabus;	107
(iv) Posting information on food assistance and basic_	108
needs security programs in all on-campus housing locations.	109
(b) Designates at least one on-campus employee who	110
students may contact for information on the supplemental	111
nutrition assistance program, other available food assistance	112
programs, and programs that support basic needs security;	113
(c) Notifies, on an individual basis, students who receive	114
need-based financial aid of their potential eligibility to	115
receive benefits under the supplemental nutrition assistance	116
program;	117
(d) Conducts an anonymous, campus-wide survey assessing	118
student food security at least once every two years;	119
(e) Sponsors at least one event per academic semester to	120
spread awareness about student hunger and provide information to	121
students about services available on campus to alleviate student	122
hunger.	123
(D) A hunger-free campus designation under this section	124
shall be for two years.	125
Section 2. (A) Not later than two years after the	126
establishment of the Hunger-Free Campus Grant Program under	127
section 3333.47 of the Revised Code, the Chancellor of Higher	128
Education shall prepare a report on the grant program that	129
includes all of the following:	130
(1) The number and amounts of grant awards under the	131
program;	132
(2) Examples of how students were supported by the program	133

and how the funding helped students continue their education;	134
(3) Examples of the impact of the grant program on	135
establishing additional hunger-free campuses at qualifying	136
institutions and reducing the number of students experiencing	137

annual appropriation for the grant program.	140
(B) The Chancellor shall submit the report to the Governor	141
and, in accordance with section 101.68 of the Revised Code, the	142
General Assembly.	143
Section 3. All items in this act are hereby appropriated	144
as designated out of any moneys in the state treasury to the	145
credit of the designated fund. For all operating appropriations	146
made in this act, those in the first column are for fiscal year	147
2024 and those in the second column are for fiscal year 2025.	148
The operating appropriations made in this act are in addition to	149
any other operating appropriations made for these fiscal years.	150
