**A BILL**

To amend sections 4501.21 and 4503.583 and to enact 1  
section 4503.896 of the Revised Code to create 2  
the "American Legion Auxiliary" license plate 3  
and to revise the requirements for the issuance 4  
of the "American Legion" license plate. 5

**BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:**

**Section 1.** That sections 4501.21 and 4503.583 be amended 6  
and section 4503.896 of the Revised Code be enacted to read as 7  
follows: 8

**Sec. 4501.21.** (A) There is hereby created in the state 9  
treasury the license plate contribution fund. The fund shall 10  
consist of all contributions for specialty license plates paid 11  
by motor vehicle registrants and collected by the registrar of 12  
motor vehicles pursuant to the Revised Code sections referenced 13  
in division (B) of this section. 14

(B) The registrar shall pay the contributions the 15  
registrar collects in the fund as follows: 16

The registrar shall pay the contributions received 17  
pursuant to section 4503.491 of the Revised Code to the breast 18  
cancer fund of Ohio, which shall use that money only to pay for 19

programs that provide assistance and education to Ohio breast 20  
cancer patients and that improve access for such patients to 21  
quality health care and clinical trials and shall not use any of 22  
the money for abortion information, counseling, services, or 23  
other abortion-related activities. 24

The registrar shall pay the contributions the registrar 25  
receives pursuant to section 4503.492 of the Revised Code to the 26  
organization cancer support community central Ohio, which shall 27  
deposit the money into the Sheryl L. Kraner Fund of that 28  
organization. Cancer support community central Ohio shall expend 29  
the money it receives pursuant to this division only in the same 30  
manner and for the same purposes as that organization expends 31  
other money in that fund. 32

The registrar shall pay the contributions received 33  
pursuant to section 4503.493 of the Revised Code to the autism 34  
society of Ohio, which shall use the contributions for programs 35  
and autism awareness efforts throughout the state. 36

The registrar shall pay the contributions the registrar 37  
receives pursuant to section 4503.494 of the Revised Code to the 38  
national multiple sclerosis society for distribution in equal 39  
amounts to the northwestern Ohio, Ohio buckeye, and Ohio valley 40  
chapters of the national multiple sclerosis society. These 41  
chapters shall use the money they receive under this section to 42  
assist in paying the expenses they incur in providing services 43  
directly to their clients. 44

The registrar shall pay the contributions the registrar 45  
receives pursuant to section 4503.495 of the Revised Code to the 46  
national pancreatic cancer foundation, which shall use the money 47  
it receives under this section to assist those who have 48  
pancreatic cancer and their families. 49

The registrar shall pay the contributions the registrar receives pursuant to section 4503.496 of the Revised Code to the Ohio sickle cell and health association, which shall use the contributions to help support educational, clinical, and social support services for adults who have sickle cell disease.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.497 of the Revised Code to the St. Baldrick's foundation, which shall use the contributions for its research and other programs.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.498 of the Revised Code to special olympics Ohio, inc., which shall use the contributions for its programs, charitable efforts, and other activities.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.499 of the Revised Code to the children's glioma cancer foundation, which shall use the contributions for its research and other programs.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.4910 of the Revised Code to the KylerStrong foundation, which shall use the contributions to raise awareness of brain cancer caused by diffuse intrinsic pontine glioma and to fund research for the cure of such cancer.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.4911 of the Revised Code to the research institution for childhood cancer at nationwide children's hospital, which shall use the contributions to fund research for the cure of childhood cancers.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.50 of the Revised Code to the

future farmers of America foundation, which shall deposit the 79  
contributions into its general account to be used for 80  
educational and scholarship purposes of the future farmers of 81  
America foundation. 82

The registrar shall pay the contributions the registrar 83  
receives pursuant to section 4503.501 of the Revised Code to the 84  
4-H youth development program of the Ohio state university 85  
extension program, which shall use those contributions to pay 86  
the expenses it incurs in conducting its educational activities. 87

The registrar shall pay the contributions received 88  
pursuant to section 4503.502 of the Revised Code to the Ohio 89  
cattlemen's foundation, which shall use those contributions for 90  
scholarships and other educational activities. 91

The registrar shall pay the contributions received 92  
pursuant to section 4503.505 of the Revised Code to the 93  
organization Ohio region phi theta kappa, which shall use those 94  
contributions for scholarships for students who are members of 95  
that organization. 96

The registrar shall pay the contributions the registrar 97  
receives pursuant to section 4503.506 of the Revised Code to 98  
Ohio demolay, which shall use the contributions for 99  
scholarships, educational programs, and any other programs or 100  
events the organization holds or sponsors in this state. 101

The registrar shall pay the contributions received 102  
pursuant to section 4503.507 of the Revised Code to the Ohio 103  
aerospace institute, which shall use those contributions to 104  
facilitate student internships in aerospace and educational 105  
programming. 106

The registrar shall pay the contributions received 107

pursuant to section 4503.508 of the Revised Code to the 108  
organization bottoms up diaper drive to provide funding for that 109  
organization for collecting and delivering diapers to parents in 110  
need. 111

The registrar shall pay the contributions the registrar 112  
receives pursuant to section 4503.509 of the Revised Code to a 113  
kid again, incorporated for distribution in equal amounts to the 114  
Ohio chapters of a kid again. 115

The registrar shall pay each contribution the registrar 116  
receives pursuant to section 4503.51 of the Revised Code to the 117  
university or college whose name or marking or design appears on 118  
collegiate license plates that are issued to a person under that 119  
section. A university or college that receives contributions 120  
from the fund shall deposit the contributions into its general 121  
scholarship fund. 122

The registrar shall pay the contributions the registrar 123  
receives pursuant to section 4503.514 of the Revised Code to the 124  
university of Notre Dame in South Bend, Indiana, for purposes of 125  
awarding grants or scholarships to residents of Ohio who attend 126  
the university. The university shall not use any of the funds it 127  
receives for purposes of administering the scholarship program. 128  
The registrar shall enter into appropriate agreements with the 129  
university of Notre Dame to effectuate the distribution of such 130  
funds as provided in this section. 131

The registrar shall pay the contributions the registrar 132  
receives pursuant to section 4503.516 of the Revised Code to 133  
Marshall university in Huntington, West Virginia, for purposes 134  
of awarding grants or scholarships to residents of Ohio who 135  
attend the university. The university shall not use any of the 136  
funds it receives for purposes of administering the scholarship 137

program. The registrar shall enter into appropriate agreements 138  
with Marshall university to effectuate the distribution of such 139  
funds as provided in this section. 140

The registrar shall pay the contributions the registrar 141  
receives pursuant to section 4503.517 of the Revised Code to the 142  
university of Alabama in Tuscaloosa, Alabama, for purposes of 143  
awarding grants or scholarships to residents of Ohio who attend 144  
the university. The university shall not use any of the funds it 145  
receives for purposes of administering the scholarship program. 146  
The registrar shall enter into appropriate agreements with the 147  
university of Alabama to effectuate the distribution of such 148  
funds as provided in this section. 149

The registrar shall pay the contributions the registrar 150  
receives pursuant to section 4503.518 of the Revised Code to the 151  
Nationwide children's hospital, which shall use the 152  
contributions for the "On Our Sleeves" campaign. 153

The registrar shall pay the contributions the registrar 154  
receives pursuant to section 4503.519 of the Revised Code 155  
equally to NAMI Ohio (national alliance on mental illness of 156  
Ohio), Ohio peer recovery organizations, and OCAAR (Ohio citizen 157  
advocates for addiction recovery). 158

The registrar shall pay the contributions the registrar 159  
receives pursuant to section 4503.521 of the Revised Code to the 160  
Ohio bicycle federation to assist that organization in paying 161  
for the educational programs it sponsors in support of Ohio 162  
cyclists of all ages. 163

The registrar shall pay the contributions the registrar 164  
receives pursuant to section 4503.522 of the Revised Code to the 165  
"friends of Perry's victory and international peace memorial, 166

incorporated," a nonprofit corporation organized under the laws 167  
of this state, to assist that organization in paying the 168  
expenses it incurs in sponsoring or holding charitable, 169  
educational, and cultural events at the monument. 170

The registrar shall pay the contributions the registrar 171  
receives pursuant to section 4503.523 of the Revised Code to the 172  
fairport lights foundation, which shall use the money to pay for 173  
the restoration, maintenance, and preservation of the 174  
lighthouses of fairport harbor. 175

The registrar shall pay the contributions the registrar 176  
receives pursuant to section 4503.524 of the Revised Code to the 177  
Massillon tiger football booster club, which shall use the 178  
contributions only to promote and support the football team of 179  
Washington high school of the Massillon city school district. 180

The registrar shall pay the contributions the registrar 181  
receives pursuant to section 4503.525 of the Revised Code to the 182  
United States power squadron district seven which shall annually 183  
distribute the contributions in equal amounts to all United 184  
States power squadrons located in the state. Each power squadron 185  
district shall use the money it receives under this section to 186  
pay for the educational boating programs each district holds or 187  
sponsors within this state. 188

The registrar shall pay the contributions the registrar 189  
receives pursuant to section 4503.526 of the Revised Code to the 190  
Ohio district Kiwanis foundation of the Ohio district of Kiwanis 191  
international, which shall use the money it receives under this 192  
section to pay the costs of its educational and humanitarian 193  
activities. 194

The registrar shall pay the contributions the registrar 195

receives pursuant to section 4503.528 of the Revised Code to the 196  
Ohio children's alliance, which shall use the money it receives 197  
under this section to pay the expenses it incurs in advancing 198  
its mission of sustainably improving the provision of services 199  
to children, young adults, and families in this state. 200

The registrar shall pay the contributions the registrar 201  
receives pursuant to section 4503.529 of the Revised Code to the 202  
Ohio nurses foundation. The foundation shall use the money it 203  
receives under this section to provide educational scholarships 204  
to assist individuals who aspire to join the nursing profession, 205  
to assist nurses in the nursing profession who seek to advance 206  
their education, and to support persons conducting nursing 207  
research concerning the evidence-based practice of nursing and 208  
the improvement of patient outcomes. 209

The registrar shall pay the contributions the registrar 210  
receives pursuant to section 4503.531 of the Revised Code to the 211  
thank you foundation, incorporated, a nonprofit corporation 212  
organized under the laws of this state, to assist that 213  
organization in paying for the charitable activities and 214  
programs it sponsors in support of United States military 215  
personnel, veterans, and their families. 216

The registrar shall pay the contributions the registrar 217  
receives pursuant to section 4503.532 of the Revised Code to the 218  
Ohio history connection, which shall use the contributions for 219  
the benefit of the Paul Laurence Dunbar house. 220

The registrar shall pay the contributions the registrar 221  
receives pursuant to section 4503.533 of the Revised Code to the 222  
nonprofit organization Ohio conference of teamsters and industry 223  
health and welfare fund, which shall use the contributions to 224  
further the nonprofit's mission. 225

The registrar shall pay the contributions the registrar receives pursuant to section 4503.534 of the Revised Code to the disabled American veterans department of Ohio, to be used for programs that serve disabled American veterans and their families.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.55 of the Revised Code to the pro football hall of fame, which shall deposit the contributions into a special bank account that it establishes and which shall be separate and distinct from any other account the pro football hall of fame maintains, to be used exclusively for the purpose of promoting the pro football hall of fame as a travel destination.

The registrar shall pay the contributions that are paid to the registrar pursuant to section 4503.545 of the Revised Code to the national rifle association foundation, which shall use the money to pay the costs of the educational activities and programs the foundation holds or sponsors in this state.

The registrar shall pay to the Ohio pet fund the contributions the registrar receives pursuant to section 4503.551 of the Revised Code and any other money from any other source, including donations, gifts, and grants, that is designated by the source to be paid to the Ohio pet fund. The Ohio pet fund shall use the moneys it receives under this section to support programs for the sterilization of dogs and cats and for educational programs concerning the proper veterinary care of those animals, and for expenses of the Ohio pet fund that are reasonably necessary for it to obtain and maintain its tax-exempt status and to perform its duties.

The registrar shall pay the contributions the registrar

receives pursuant to section 4503.552 of the Revised Code to the 256  
rock and roll hall of fame and museum, incorporated. 257

The registrar shall pay the contributions the registrar 258  
receives pursuant to section 4503.553 of the Revised Code to the 259  
Ohio coalition for animals, incorporated, a nonprofit 260  
corporation. Except as provided in division (B) of this section, 261  
the coalition shall distribute the money to its members, and the 262  
members shall use the money only to pay for educational, 263  
charitable, and other programs of each coalition member that 264  
provide care for unwanted, abused, and neglected horses. The 265  
Ohio coalition for animals may use a portion of the money to pay 266  
for reasonable marketing costs incurred in the design and 267  
promotion of the license plate and for administrative costs 268  
incurred in the disbursement and management of funds received 269  
under this section. 270

The registrar shall pay the contributions the registrar 271  
receives pursuant to section 4503.554 of the Revised Code to the 272  
Ohio state council of the knights of Columbus, which shall use 273  
the contributions to pay for its charitable activities and 274  
programs. 275

The registrar shall pay the contributions the registrar 276  
receives pursuant to section 4503.555 of the Revised Code to the 277  
western reserve historical society, which shall use the 278  
contributions to fund the Crawford auto aviation museum. 279

The registrar shall pay the contributions the registrar 280  
receives pursuant to section 4503.556 of the Revised Code to the 281  
Erica J. Holloman foundation, inc., for the awareness of triple 282  
negative breast cancer. The foundation shall use the 283  
contributions for charitable and educational purposes. 284

The registrar shall pay each contribution the registrar receives pursuant to section 4503.557 of the Revised Code to the central Ohio chapter of the Ronald McDonald house charities, which shall distribute the contribution to the chapter of the Ronald McDonald house charities in whose geographic territory the person who paid the contribution resides.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.559 of the Revised Code to playhouse square, located in Cleveland, Ohio, which shall use the contributions to further its mission of presenting and producing a wide variety of quality performing arts, advancing arts education, and creating a superior destination for entertainment, business, and residential living.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.561 of the Revised Code to the state of Ohio chapter of ducks unlimited, inc., which shall deposit the contributions into a special bank account that it establishes. The special bank account shall be separate and distinct from any other account the state of Ohio chapter of ducks unlimited, inc., maintains and shall be used exclusively for the purpose of protecting, enhancing, restoring, and managing wetlands and conserving wildlife habitat. The state of Ohio chapter of ducks unlimited, inc., annually shall notify the registrar in writing of the name, address, and account to which such payments are to be made.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.562 of the Revised Code to the Mahoning river consortium, which shall use the money to pay the expenses it incurs in restoring and maintaining the Mahoning river watershed.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.564 of the Revised Code to the Glen Helen association to pay expenses related to the Glen Helen nature preserve.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.565 of the Revised Code to the conservancy for Cuyahoga valley national park, which shall use the money in support of the park.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.566 of the Revised Code to the Ottawa national wildlife refuge, which shall use the contributions for wildlife preservation purposes.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.567 of the Revised Code to the girls on the run of Franklin county, inc., which shall use the contributions to support the activities of the organization.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.569 of the Revised Code to the Ohio bird sanctuary, located in Mansfield, Ohio, which shall use the contributions for purposes of its operations, bird care and rehabilitation, and educational programs.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.576 of the Revised Code to the Ohio state beekeepers association, which shall use those contributions to promote beekeeping, provide educational information about beekeeping, and to support other state and local beekeeping programs.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.577 of the Revised Code to the

national aviation hall of fame, which shall use the 344  
contributions to fulfill its mission of honoring aerospace 345  
legends to inspire future leaders. 346

The registrar shall pay the contributions the registrar 347  
receives pursuant to section 4503.578 of the Revised Code to 348  
keep Ohio beautiful, incorporated, which shall use the 349  
contributions towards its mission of empowering Ohio communities 350  
to take greater responsibility for improving the local 351  
environment through litter prevention, beautification, community 352  
greening, waste reduction, and recycling. 353

The registrar shall pay the contributions the registrar 354  
receives pursuant to section 4503.579 of the Revised Code to the 355  
national council of negro women, incorporated, which shall use 356  
the contributions for educational purposes. 357

The registrar shall pay the contributions the registrar 358  
receives pursuant to section 4503.581 of the Revised Code to the 359  
Ohio past detachment commander's club, inc., which shall use the 360  
contributions to support the activities of the organization. 361

The registrar shall pay the contributions the registrar 362  
receives pursuant to section 4503.582 of the Revised Code to the 363  
progressive animal welfare society adoption center, inc., which 364  
shall use the contributions to support the activities of the 365  
center. 366

The registrar shall pay the contributions the registrar 367  
receives pursuant to section 4503.583 of the Revised Code to the 368  
American legion, department of Ohio, inc., which shall use the 369  
contributions to support the activities of the organization. 370

The registrar shall pay the contributions the registrar 371  
receives pursuant to section 4503.584 of the Revised Code to the 372

Ohio natural energy institute to fund scholarships for students 373  
pursuing careers in the oil and natural gas industry. 374

The registrar shall pay to a sports commission created 375  
pursuant to section 4503.591 of the Revised Code each 376  
contribution the registrar receives under that section that an 377  
applicant pays to obtain license plates that bear the logo of a 378  
professional sports team located in the county of that sports 379  
commission and that is participating in the license plate 380  
program pursuant to division (E) of that section, irrespective 381  
of the county of residence of an applicant. 382

The registrar shall pay to a community charity each 383  
contribution the registrar receives under section 4503.591 of 384  
the Revised Code that an applicant pays to obtain license plates 385  
that bear the logo of a professional sports team that is 386  
participating in the license plate program pursuant to division 387  
(G) of that section. 388

The registrar shall pay the contributions the registrar 389  
receives pursuant to section 4503.592 of the Revised Code to 390  
pollinator partnership's monarch wings across Ohio program, 391  
which shall use the contributions for the protection and 392  
preservation of the monarch butterfly and pollinator corridor in 393  
Ohio and for educational programs. 394

The registrar shall pay the contributions the registrar 395  
receives pursuant to section 4503.594 of the Revised Code to 396  
pelotonia, which shall use the contributions for the purpose of 397  
supporting cancer research. 398

The registrar shall pay the contributions the registrar 399  
receives pursuant to section 4503.595 of the Revised Code to the 400  
Stan Hywet hall and gardens. 401

The registrar shall pay the contributions the registrar receives pursuant to section 4503.596 of the Revised Code to the Cuyahoga valley scenic railroad.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.597 of the Revised Code to the Circleville pumpkin show, incorporated, which shall use the contributions to promote good will surrounding the Circleville pumpkin show as a nonprofit annual event.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.67 of the Revised Code to the Dan Beard council of the boy scouts of America. The council shall distribute all contributions in an equitable manner throughout the state to regional councils of the boy scouts.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.68 of the Revised Code to the girl scouts of Ohio's heartland. The girl scouts of Ohio's heartland shall distribute all contributions in an equitable manner throughout the state to regional councils of the girl scouts.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.69 of the Revised Code to the Dan Beard council of the boy scouts of America. The council shall distribute all contributions in an equitable manner throughout the state to regional councils of the boy scouts.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.70 of the Revised Code to the charitable foundation of the grand lodge of Ohio, f. & a. m., which shall use the contributions for scholarship purposes.

The registrar shall pay the contributions the registrar

receives pursuant to section 4503.701 of the Revised Code to the 431  
Prince Hall grand lodge of free and accepted masons of Ohio, 432  
which shall use the contributions for scholarship purposes. 433

The registrar shall pay the contributions the registrar 434  
receives pursuant to section 4503.702 of the Revised Code to the 435  
Ohio Association of the Improved Benevolent and Protective Order 436  
of the Elks of the World, which shall use the funds for 437  
charitable purposes. 438

The registrar shall pay the contributions the registrar 439  
receives pursuant to section 4503.703 of the Revised Code to the 440  
Ohio state moose association. 441

The registrar shall pay the contributions the registrar 442  
receives pursuant to section 4503.704 of the Revised Code to the 443  
Antioch shrine foundation located in the municipal corporation 444  
of Dayton. 445

The registrar shall pay the contributions the registrar 446  
receives pursuant to section 4503.71 of the Revised Code to the 447  
fraternal order of police of Ohio, incorporated, which shall 448  
deposit the fees into its general account to be used for 449  
purposes of the fraternal order of police of Ohio, incorporated. 450

The registrar shall pay the contributions the registrar 451  
receives pursuant to section 4503.711 of the Revised Code to the 452  
fraternal order of police of Ohio, incorporated, which shall 453  
deposit the contributions into an account that it creates to be 454  
used for the purpose of advancing and protecting the law 455  
enforcement profession, promoting improved law enforcement 456  
methods, and teaching respect for law and order. 457

The registrar shall pay the contributions received 458  
pursuant to section 4503.712 of the Revised Code to Ohio 459

concerns of police survivors, which shall use those 460  
contributions to provide whatever assistance may be appropriate 461  
to the families of Ohio law enforcement officers who are killed 462  
in the line of duty. 463

The registrar shall pay the contributions received 464  
pursuant to section 4503.713 of the Revised Code to the greater 465  
Cleveland peace officers memorial society, which shall use those 466  
contributions to honor law enforcement officers who have died in 467  
the line of duty and support its charitable purposes. 468

The registrar shall pay the contributions received 469  
pursuant to section 4503.714 of the Revised Code to the Ohio 470  
association of chiefs of police. 471

The registrar shall pay the contributions the registrar 472  
receives, or has received, pursuant to section 4503.715 of the 473  
Revised Code to the community foundation of Ohio's electric 474  
cooperatives, which shall use the contributions to recognize and 475  
memorialize fallen or injured lineworkers and support their 476  
families. 477

The registrar shall pay the contributions the registrar 478  
receives pursuant to section 4503.716 of the Revised Code to the 479  
fallen timbers battlefield preservation commission, which shall 480  
use the contributions to further the mission of the commission. 481

The registrar shall pay the contributions the registrar 482  
receives pursuant to section 4503.72 of the Revised Code to the 483  
organization known on March 31, 2003, as the Ohio CASA/GAL 484  
association, a private, nonprofit corporation organized under 485  
Chapter 1702. of the Revised Code. The Ohio CASA/GAL association 486  
shall use these contributions to pay the expenses it incurs in 487  
administering a program to secure the proper representation in 488

the courts of this state of abused, neglected, and dependent 489  
children, and for the training and supervision of persons 490  
participating in that program. 491

The registrar shall pay the contributions the registrar 492  
receives pursuant to section 4503.722 of the Revised Code to the 493  
Down Syndrome Association of Central Ohio, which shall use the 494  
contributions for advocacy purposes throughout the state. 495

The registrar shall pay the contributions the registrar 496  
receives pursuant to section 4503.724 of the Revised Code to the 497  
Ohio Chapter of the American Foundation for Suicide Prevention, 498  
which shall use the contributions for programs, education, and 499  
advocacy purposes throughout the state. 500

The registrar shall pay the contributions the registrar 501  
receives, or has received, pursuant to section 4503.725 of the 502  
Revised Code to the ALS united Ohio, incorporated, which shall 503  
split the contributions between that organization and the ALS 504  
association northern Ohio chapter in accordance with any 505  
agreement between the two organizations. The contributions shall 506  
be used to discover treatments and a cure for ALS, and to serve, 507

use the money to increase consumer awareness on the importance 1022

The registrar shall pay the contributions received 1025  
pursuant to section 4503.942 of the Revised Code to zero, the 1026  
end of prostate cancer, incorporated, a nonprofit organization, 1027  
which shall use those contributions to raise awareness of 1028

prostate cancer, to support research to end prostate cancer, and 1029  
to support prostate cancer patients and their families. 1030

The registrar shall pay the contributions the registrar 1031  
receives pursuant to section 4503.944 of the Revised Code to the 1032  
eastern European congress of Ohio, which shall use the 1033  
contributions for charitable and educational purposes. 1034

The registrar shall pay the contributions the registrar 1035  
receives pursuant to section 4503.945 of the Revised Code to the 1036  
Summit metro parks foundation, which shall use the money in 1037  
support of the Summit county metro parks. 1038

The registrar shall pay the contributions the registrar 1039  
receives pursuant to section 4503.951 of the Revised Code to the 1040  
Cincinnati city school district. 1041

The registrar shall pay the contributions the registrar 1042  
receives pursuant to section 4503.952 of the Revised Code to 1043  
Hawken school located in northeast Ohio. The school shall use 1044  
fifty per cent of the contributions it receives to provide 1045  
tuition assistance to its students. The school shall use the 1046  
remaining fifty per cent to pay the expenses it incurs in 1047  
providing services to the school's students that assist in 1048  
developing or maintaining the mental and emotional well-being of 1049  
the students. The services provided may include bereavement 1050  
counseling, instruction in defensive driving techniques, 1051  
sensitivity training, and the counseling and education of 1052

developing or maintaining the mental and emotional well-being of 1118  
the students. The services provided may include bereavement 1119

The registrar shall pay the contributions the registrar 1144  
receives pursuant to section 4503.958 of the Revised Code to 1145  
Elder high school located in the municipal corporation of 1146  
Cincinnati. The school shall use fifty per cent of the 1147  
contributions it receives to provide tuition assistance to its 1148  
students, twenty-five per cent of the contributions to benefit 1149  
arts and enrichment at the school, and twenty-five per cent of 1150

the contributions to benefit athletics at the school. 1151

The registrar shall pay the contributions the registrar 1152  
receives pursuant to section 4503.961 of the Revised Code to 1153  
Fairfield senior high school located in the municipal 1154  
corporation of Fairfield. The high school shall not use the 1155  
contributions for any political purpose. 1156

The registrar shall pay the contributions the registrar 1157  
receives pursuant to section 4503.962 of the Revised Code to 1158  
Hamilton high school located in the municipal corporation of 1159  
Hamilton. The high school shall not use the contributions for 1160  
any political purpose. 1161

The registrar shall pay the contributions the registrar 1162  
receives pursuant to section 4503.963 of the Revised Code to 1163  
Ross high school located in Ross township in Butler county. The 1164  
high school shall not use the contributions for any political 1165  
purpose. 1166

The registrar shall pay the contributions the registrar 1167  
receives pursuant to section 4503.964 of the Revised Code to 1168  
Chardon hilltopper gridiron club. The club shall use 1169  
contributions to fund college and career technical training 1170  
scholarships for students. 1171

The registrar shall pay the contributions the registrar 1172  
receives pursuant to section 4503.97 of the Revised Code to the 1173  
friends of united Hatzalah of Israel, which shall use the money 1174  
to support united Hatzalah of Israel, which provides free 1175  
emergency medical first response throughout Israel. 1176

The registrar shall pay the contributions the registrar 1177  
receives pursuant to section 4503.98 of the Revised Code to the 1178  
Westerville parks foundation to support the programs and 1179

activities of the foundation and its mission of pursuing the 1180  
city of Westerville's vision of becoming "A City Within A Park." 1181

(C) All investment earnings of the license plate 1182  
contribution fund shall be credited to the fund. Not later than 1183  
the first day of May of every year, the registrar shall 1184  
distribute to each entity described in division (B) of this 1185  
section the investment income the fund earned the previous 1186  
calendar year. The amount of such a distribution paid to an 1187  
entity shall be proportionate to the amount of money the entity 1188  
received from the fund during the previous calendar year. 1189

**Sec. 4503.583.** (A) The owner or lessee of any passenger 1190  
car, noncommercial motor vehicle, recreational vehicle, or other 1191  
vehicle of a class approved by the registrar of motor vehicles 1192  
may apply to the registrar for the registration of the vehicle 1193  
and issuance of "American Legion" license plates. The 1194  
application may be combined with a request for a special 1195  
reserved license plate under section 4503.40 or 4503.42 of the 1196  
Revised Code. Upon receipt of the completed application and 1197  
compliance by the applicant with divisions (B) and (C) of this 1198  
section, the registrar shall issue to the applicant the 1199  
appropriate vehicle registration and a set of "American Legion" 1200  
license plates and a validation sticker, or a validation sticker 1201  
alone when required by section 4503.191 of the Revised Code. 1202

In addition to the letters and numbers ordinarily 1203  
inscribed on the license plates, "American Legion" license 1204  
plates shall display an appropriate logo and words that are 1205  
selected by representatives of the American legion, department 1206  
of Ohio, inc. and approved by the registrar. "American Legion" 1207  
license plates shall display county identification stickers that 1208  
identify the county of registration as required under section 1209

4503.19 of the Revised Code. 1210

(B) "American Legion" license plates and a validation 1211  
sticker, or validation sticker alone, shall be issued upon 1212  
receipt of an application for registration of a motor vehicle 1213  
under this section; payment of the regular license tax as 1214  
prescribed under section 4503.04 of the Revised Code, any 1215  
applicable motor vehicle license tax levied under Chapter 4504. 1216  
of the Revised Code, any applicable additional fee prescribed by 1217  
section 4503.40 or 4503.42 of the Revised Code, an additional 1218  
administrative fee of ten dollars, and a contribution as 1219  
provided in division (C) (1) of this section; and compliance with 1220  
all other applicable laws relating to the registration of motor 1221  
vehicles. 1222

(C) (1) For each application for registration and 1223  
registration renewal notice the registrar receives under this 1224  
section, the registrar shall collect a contribution of ten 1225  
dollars. The registrar shall deposit this contribution into the 1226  
state treasury to the credit of the license plate contribution 1227  
fund created in section 4501.21 of the Revised Code. 1228

(2) The registrar shall deposit the administrative fee of 1229  
ten dollars, the purpose of which is to compensate the bureau of 1230  
motor vehicles for additional services required in the issuing 1231  
of "American Legion" license plates, into the state treasury to 1232  
the credit of the public safety - highway purposes fund created 1233  
in section 4501.06 of the Revised Code. 1234

(D) Section 4503.78 of the Revised Code does not apply to 1235  
license plates issued under this section. 1236

Sec. 4503.896. (A) The owner or lessee of any passenger 1237  
car, noncommercial motor vehicle, recreational vehicle, or other 1238

vehicle of a class approved by the registrar of motor vehicles 1239  
may apply to the registrar for the registration of the vehicle 1240  
and issuance of "American Legion Auxiliary" license plates. The 1241  
application may be combined with a request for a special 1242  
reserved license plate under section 4503.40 or 4503.42 of the 1243  
Revised Code. Upon receipt of the completed application and 1244  
compliance by the applicant with divisions (B) and (C) of this 1245  
section, the registrar shall issue to the applicant the 1246  
appropriate vehicle registration and a set of "American Legion 1247  
Auxiliary" license plates and a validation sticker, or a 1248  
validation sticker alone when required by section 4503.191 of 1249  
the Revised Code. 1250

In addition to the letters and numbers ordinarily 1251  
inscribed on the license plates, "American Legion Auxiliary" 1252  
license plates shall display an appropriate logo and words that 1253  
are selected by representatives of the American legion auxiliary 1254  
department of Ohio and approved by the registrar. "American 1255  
Legion Auxiliary" license plates shall display county 1256  
identification stickers that identify the county of registration 1257  
as required under section 4503.19 of the Revised Code. 1258

(B) "American Legion Auxiliary" license plates and a 1259  
validation sticker, or validation sticker alone, shall be issued 1260  
upon receipt of an application for registration of a motor 1261  
vehicle under this section; payment of the regular license tax 1262  
as prescribed under section 4503.04 of the Revised Code, any 1263  
applicable motor vehicle license tax levied under Chapter 4504. 1264  
of the Revised Code, any applicable additional fee prescribed by 1265  
section 4503.40 or 4503.42 of the Revised Code, an additional 1266  
administrative fee of ten dollars, and a contribution as 1267  
provided in division (C) (1) of this section; and compliance with 1268  
all other applicable laws relating to the registration of motor 1269

vehicles. 1270

(C) (1) For each application for registration and 1271  
registration renewal notice the registrar receives under this 1272  
section, the registrar shall collect a contribution of ten 1273  
dollars. The registrar shall deposit this contribution into the 1274  
state treasury to the credit of the license plate contribution 1275  
fund created in section 4501.21 of the Revised Code. 1276

(2) The registrar shall deposit the administrative fee of 1277  
ten dollars, the purpose of which is to compensate the bureau of 1278  
motor vehicles for additional services required in the issuing 1279  
of "American Legion Auxiliary" license plates, into the state 1280  
treasury to the credit of the public safety - highway purposes 1281  
fund created in section 4501.06 of the Revised Code. 1282

(D) Section 4503.78 of the Revised Code does not apply to 1283  
license plates issued under this section. 1284
