A BILL

To amend section 4501.21 and to enact section 1
4503.588 of the Revised Code to create the "Ohio 2
State Grange" specialty license plate. 3

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 4501.21 be amended and section 4
4503.588 of the Revised Code be enacted to read as follows: 5

Sec. 4501.21. (A) There is hereby created in the state 6
treasury the license plate contribution fund. The fund shall 7
consist of all contributions for specialty license plates paid 8
by motor vehicle registrants and collected by the registrar of 9
motor vehicles pursuant to the Revised Code sections referenced 10
in division (B) of this section. 11

(B) The registrar shall pay the contributions the 12
registrar collects in the fund as follows: 13

The registrar shall pay the contributions received 14
pursuant to section 4503.491 of the Revised Code to the breast 15
cancer fund of Ohio, which shall use that money only to pay for 16
programs that provide assistance and education to Ohio breast 17
cancer patients and that improve access for such patients to 18
quality health care and clinical trials and shall not use any of 19

the money for abortion information, counseling, services, or 20
other abortion-related activities. 21

The registrar shall pay the contributions the registrar 22
receives pursuant to section 4503.492 of the Revised Code to the 23
organization cancer support community central Ohio, which shall 24
deposit the money into the Sheryl L. Kraner Fund of that 25
organization. Cancer support community central Ohio shall expend 26
the money it receives pursuant to this division only in the same 27
manner and for the same purposes as that organization expends 28
other money in that fund. 29

The registrar shall pay the contributions received 30
pursuant to section 4503.493 of the Revised Code to the autism 31
society of Ohio, which shall use the contributions for programs 32
and autism awareness efforts throughout the state. 33

The registrar shall pay the contributions the registrar 34
receives pursuant to section 4503.494 of the Revised Code to the 35
national multiple sclerosis society for distribution in equal 36
amounts to the northwestern Ohio, Ohio buckeye, and Ohio valley 37
chapters of the national multiple sclerosis society. These 38
chapters shall use the money they receive under this section to 39
assist in paying the expenses they incur in providing services 40
directly to their clients. 41

The registrar shall pay the contributions the registrar 42
receives pursuant to section 4503.495 of the Revised Code to the 43
national pancreatic cancer foundation, which shall use the money 44
it receives under this section to assist those who have 45
pancreatic cancer and their families. 46

The registrar shall pay the contributions the registrar 47
receives pursuant to section 4503.496 of the Revised Code to the 48

Ohio sickle cell and health association, which shall use the 49
contributions to help support educational, clinical, and social 50
support services for adults who have sickle cell disease. 51

The registrar shall pay the contributions the registrar 52
receives pursuant to section 4503.497 of the Revised Code to the 53
St. Baldrick's foundation, which shall use the contributions for 54
its research and other programs. 55

The registrar shall pay the contributions the registrar 56
receives pursuant to section 4503.498 of the Revised Code to 57
special olympics Ohio, inc., which shall use the contributions 58
for its programs, charitable efforts, and other activities. 59

The registrar shall pay the contributions the registrar 60
receives pursuant to section 4503.499 of the Revised Code to the 61
children's glioma cancer foundation, which shall use the 62
contributions for its research and other programs. 63

The registrar shall pay the contributions the registrar 64
receives pursuant to section 4503.4910 of the Revised Code to 65
the KylerStrong foundation, which shall use the contributions to 66
raise awareness of brain cancer caused by diffuse intrinsic 67
pontine glioma and to fund research for the cure of such cancer. 68

The registrar shall pay the contributions the registrar 69
receives pursuant to section 4503.4911 of the Revised Code to 70
the research institution for childhood cancer at nationwide 71
children's hospital, which shall use the contributions to fund 72
research for the cure of childhood cancers. 73

The registrar shall pay the contributions the registrar 74
receives pursuant to section 4503.50 of the Revised Code to the 75
future farmers of America foundation, which shall deposit the 76
contributions into its general account to be used for 77

educational and scholarship purposes of the future farmers of 78
America foundation. 79

The registrar shall pay the contributions the registrar 80
receives pursuant to section 4503.501 of the Revised Code to the 81
4-H youth development program of the Ohio state university 82
extension program, which shall use those contributions to pay 83
the expenses it incurs in conducting its educational activities. 84

The registrar shall pay the contributions received 85
pursuant to section 4503.502 of the Revised Code to the Ohio 86
cattlemen's foundation, which shall use those contributions for 87
scholarships and other educational activities. 88

The registrar shall pay the contributions received 89
pursuant to section 4503.505 of the Revised Code to the 90
organization Ohio region phi theta kappa, which shall use those 91
contributions for scholarships for students who are members of 92
that organization. 93

The registrar shall pay the contributions the registrar 94
receives pursuant to section 4503.506 of the Revised Code to 95
Ohio demolay, which shall use the contributions for 96
scholarships, educational programs, and any other programs or 97
events the organization holds or sponsors in this state. 98

The registrar shall pay the contributions received 99
pursuant to section 4503.507 of the Revised Code to the Ohio 100
aerospace institute, which shall use those contributions to 101
facilitate student internships in aerospace and educational 102
programming. 103

The registrar shall pay the contributions received 104
pursuant to section 4503.508 of the Revised Code to the 105
organization bottoms up diaper drive to provide funding for that 106

organization for collecting and delivering diapers to parents in need. 107

The registrar shall pay the contributions the registrar receives pursuant to section 4503.509 of the Revised Code to a kid again, incorporated for distribution in equal amounts to the Ohio chapters of a kid again. 109

The registrar shall pay each contribution the registrar receives pursuant to section 4503.51 of the Revised Code to the university or college whose name or marking or design appears on collegiate license plates that are issued to a person under that section. A university or college that receives contributions from the fund shall deposit the contributions into its general scholarship fund. 113

The registrar shall pay the contributions the registrar receives pursuant to section 4503.514 of the Revised Code to the university of Notre Dame in South Bend, Indiana, for purposes of awarding grants or scholarships to residents of Ohio who attend the university. The university shall not use any of the funds it receives for purposes of administering the scholarship program. The registrar shall enter into appropriate agreements with the university of Notre Dame to effectuate the distribution of such funds as provided in this section. 120

The registrar shall pay the contributions the registrar receives pursuant to section 4503.516 of the Revised Code to Marshall university in Huntington, West Virginia, for purposes of awarding grants or scholarships to residents of Ohio who attend the university. The university shall not use any of the funds it receives for purposes of administering the scholarship program. The registrar shall enter into appropriate agreements with Marshall university to effectuate the distribution of such 129

funds as provided in this section. 137

The registrar shall pay the contributions the registrar 138
receives pursuant to section 4503.517 of the Revised Code to the 139
university of Alabama in Tuscaloosa, Alabama, for purposes of 140
awarding grants or scholarships to residents of Ohio who attend 141
the university. The university shall not use any of the funds it 142
receives for purposes of administering the scholarship program. 143
The registrar shall enter into appropriate agreements with the 144
university of Alabama to effectuate the distribution of such 145
funds as provided in this section. 146

The registrar shall pay the contributions the registrar 147
receives pursuant to section 4503.518 of the Revised Code to the 148
Nationwide children's hospital, which shall use the 149
contributions for the "On Our Sleeves" campaign. 150

The registrar shall pay the contributions the registrar 151
receives pursuant to section 4503.519 of the Revised Code 152
equally to NAMI Ohio (national alliance on mental illness of 153
Ohio), Ohio peer recovery organizations, and OCAAR (Ohio citizen 154
advocates for addiction recovery). 155

The registrar shall pay the contributions the registrar 156
receives pursuant to section 4503.521 of the Revised Code to the 157
Ohio bicycle federation to assist that organization in paying 158
for the educational programs it sponsors in support of Ohio 159
cyclists of all ages. 160

The registrar shall pay the contributions the registrar 161
receives pursuant to section 4503.522 of the Revised Code to the 162
"friends of Perry's victory and international peace memorial, 163
incorporated," a nonprofit corporation organized under the laws 164
of this state, to assist that organization in paying the 165

expenses it incurs in sponsoring or holding charitable, 166
educational, and cultural events at the monument. 167

The registrar shall pay the contributions the registrar 168
receives pursuant to section 4503.523 of the Revised Code to the 169
fairport lights foundation, which shall use the money to pay for 170
the restoration, maintenance, and preservation of the 171
lighthouses of fairport harbor. 172

The registrar shall pay the contributions the registrar 173
receives pursuant to section 4503.524 of the Revised Code to the 174
Massillon tiger football booster club, which shall use the 175
contributions only to promote and support the football team of 176
Washington high school of the Massillon city school district. 177

The registrar shall pay the contributions the registrar 178
receives pursuant to section 4503.525 of the Revised Code to the 179
United States power squadron district seven which shall annually 180
distribute the contributions in equal amounts to all United 181
States power squadrons located in the state. Each power squadron 182
district shall use the money it receives under this section to 183
pay for the educational boating programs each district holds or 184
sponsors within this state. 185

The registrar shall pay the contributions the registrar 186
receives pursuant to section 4503.526 of the Revised Code to the 187
Ohio district Kiwanis foundation of the Ohio district of Kiwanis 188
international, which shall use the money it receives under this 189
section to pay the costs of its educational and humanitarian 190
activities. 191

The registrar shall pay the contributions the registrar 192
receives pursuant to section 4503.528 of the Revised Code to the 193
Ohio children's alliance, which shall use the money it receives 194

under this section to pay the expenses it incurs in advancing 195
its mission of sustainably improving the provision of services 196
to children, young adults, and families in this state. 197

The registrar shall pay the contributions the registrar 198
receives pursuant to section 4503.529 of the Revised Code to the 199
Ohio nurses foundation. The foundation shall use the money it 200
receives under this section to provide educational scholarships 201
to assist individuals who aspire to join the nursing profession, 202
to assist nurses in the nursing profession who seek to advance 203
their education, and to support persons conducting nursing 204
research concerning the evidence-based practice of nursing and 205
the improvement of patient outcomes. 206

The registrar shall pay the contributions the registrar 207
receives pursuant to section 4503.531 of the Revised Code to the 208
thank you foundation, incorporated, a nonprofit corporation 209
organized under the laws of this state, to assist that 210
organization in paying for the charitable activities and 211
programs it sponsors in support of United States military 212
personnel, veterans, and their families. 213

The registrar shall pay the contributions the registrar 214
receives pursuant to section 4503.532 of the Revised Code to the 215
Ohio history connection, which shall use the contributions for 216
the benefit of the Paul Laurence Dunbar house. 217

The registrar shall pay the contributions the registrar 218
receives pursuant to section 4503.533 of the Revised Code to the 219
nonprofit organization Ohio conference of teamsters and industry 220
health and welfare fund, which shall use the contributions to 221
further the nonprofit's mission. 222

The registrar shall pay the contributions the registrar 223

receives pursuant to section 4503.534 of the Revised Code to the 224
disabled American veterans department of Ohio, to be used for 225
programs that serve disabled American veterans and their 226
families. 227

The registrar shall pay the contributions the registrar 228
receives pursuant to section 4503.55 of the Revised Code to the 229
pro football hall of fame, which shall deposit the contributions 230
into a special bank account that it establishes and which shall 231
be separate and distinct from any other account the pro football 232
hall of fame maintains, to be used exclusively for the purpose 233
of promoting the pro football hall of fame as a travel 234
destination. 235

The registrar shall pay the contributions that are paid to 236
the registrar pursuant to section 4503.545 of the Revised Code 237
to the national rifle association foundation, which shall use 238
the money to pay the costs of the educational activities and 239
programs the foundation holds or sponsors in this state. 240

The registrar shall pay to the Ohio pet fund the 241
contributions the registrar receives pursuant to section 242
4503.551 of the Revised Code and any other money from any other 243
source, including donations, gifts, and grants, that is 244
designated by the source to be paid to the Ohio pet fund. The 245
Ohio pet fund shall use the moneys it receives under this 246
section to support programs for the sterilization of dogs and 247
cats and for educational programs concerning the proper 248
veterinary care of those animals, and for expenses of the Ohio 249
pet fund that are reasonably necessary for it to obtain and 250
maintain its tax-exempt status and to perform its duties. 251

The registrar shall pay the contributions the registrar 252
receives pursuant to section 4503.552 of the Revised Code to the 253

rock and roll hall of fame and museum, incorporated. 254

The registrar shall pay the contributions the registrar 255
receives pursuant to section 4503.553 of the Revised Code to the 256
Ohio coalition for animals, incorporated, a nonprofit 257
corporation. Except as provided in division (B) of this section, 258
the coalition shall distribute the money to its members, and the 259
members shall use the money only to pay for educational, 260
charitable, and other programs of each coalition member that 261
provide care for unwanted, abused, and neglected horses. The 262
Ohio coalition for animals may use a portion of the money to pay 263
for reasonable marketing costs incurred in the design and 264
promotion of the license plate and for administrative costs 265
incurred in the disbursement and management of funds received 266
under this section. 267

The registrar shall pay the contributions the registrar 268
receives pursuant to section 4503.554 of the Revised Code to the 269
Ohio state council of the knights of Columbus, which shall use 270
the contributions to pay for its charitable activities and 271
programs. 272

The registrar shall pay the contributions the registrar 273
receives pursuant to section 4503.555 of the Revised Code to the 274
western reserve historical society, which shall use the 275
contributions to fund the Crawford auto aviation museum. 276

The registrar shall pay the contributions the registrar 277
receives pursuant to section 4503.556 of the Revised Code to the 278
Erica J. Holloman foundation, inc., for the awareness of triple 279
negative breast cancer. The foundation shall use the 280
contributions for charitable and educational purposes. 281

The registrar shall pay each contribution the registrar 282

receives pursuant to section 4503.557 of the Revised Code to the 283
central Ohio chapter of the Ronald McDonald house charities, 284
which shall distribute the contribution to the chapter of the 285
Ronald McDonald house charities in whose geographic territory 286
the person who paid the contribution resides. 287

The registrar shall pay the contributions the registrar 288
receives pursuant to section 4503.559 of the Revised Code to 289
playhouse square, located in Cleveland, Ohio, which shall use 290
the contributions to further its mission of presenting and 291
producing a wide variety of quality performing arts, advancing 292
arts education, and creating a superior destination for 293
entertainment, business, and residential living. 294

The registrar shall pay the contributions the registrar 295
receives pursuant to section 4503.561 of the Revised Code to the 296
state of Ohio chapter of ducks unlimited, inc., which shall 297
deposit the contributions into a special bank account that it 298
establishes. The special bank account shall be separate and 299
distinct from any other account the state of Ohio chapter of 300
ducks unlimited, inc., maintains and shall be used exclusively 301
for the purpose of protecting, enhancing, restoring, and 302
managing wetlands and conserving wildlife habitat. The state of 303
Ohio chapter of ducks unlimited, inc., annually shall notify the 304
registrar in writing of the name, address, and account to which 305
such payments are to be made. 306

The registrar shall pay the contributions the registrar 307
receives pursuant to section 4503.562 of the Revised Code to the 308
Mahoning river consortium, which shall use the money to pay the 309
expenses it incurs in restoring and maintaining the Mahoning 310
river watershed. 311

The registrar shall pay the contributions the registrar 312

receives pursuant to section 4503.564 of the Revised Code to the 313
Glen Helen association to pay expenses related to the Glen Helen 314
nature preserve. 315

The registrar shall pay the contributions the registrar 316
receives pursuant to section 4503.565 of the Revised Code to the 317
conservancy for Cuyahoga valley national park, which shall use 318
the money in support of the park. 319

The registrar shall pay the contributions the registrar 320
receives pursuant to section 4503.566 of the Revised Code to the 321
Ottawa national wildlife refuge, which shall use the 322
contributions for wildlife preservation purposes. 323

The registrar shall pay the contributions the registrar 324
receives pursuant to section 4503.567 of the Revised Code to the 325
girls on the run of Franklin county, inc., which shall use the 326
contributions to support the activities of the organization. 327

The registrar shall pay the contributions the registrar 328
receives pursuant to section 4503.569 of the Revised Code to the 329
Ohio bird sanctuary, located in Mansfield, Ohio, which shall use 330
the contributions for purposes of its operations, bird care and 331
rehabilitation, and educational programs. 332

The registrar shall pay the contributions the registrar 333
receives pursuant to section 4503.576 of the Revised Code to the 334
Ohio state beekeepers association, which shall use those 335
contributions to promote beekeeping, provide educational 336
information about beekeeping, and to support other state and 337
local beekeeping programs. 338

The registrar shall pay the contributions the registrar 339
receives pursuant to section 4503.577 of the Revised Code to the 340
national aviation hall of fame, which shall use the 341

contributions to fulfill its mission of honoring aerospace 342
legends to inspire future leaders. 343

The registrar shall pay the contributions the registrar 344
receives pursuant to section 4503.578 of the Revised Code to 345
keep Ohio beautiful, incorporated, which shall use the 346
contributions towards its mission of empowering Ohio communities 347
to take greater responsibility for improving the local 348
environment through litter prevention, beautification, community 349
greening, waste reduction, and recycling. 350

The registrar shall pay the contributions the registrar 351
receives pursuant to section 4503.579 of the Revised Code to the 352
national council of negro women, incorporated, which shall use 353
the contributions for educational purposes. 354

The registrar shall pay the contributions the registrar 355
receives pursuant to section 4503.581 of the Revised Code to the 356
Ohio past detachment commander's club, inc., which shall use the 357
contributions to support the activities of the organization. 358

The registrar shall pay the contributions the registrar 359
receives pursuant to section 4503.582 of the Revised Code to the 360
progressive animal welfare society adoption center, inc., which 361
shall use the contributions to support the activities of the 362
center. 363

The registrar shall pay the contributions the registrar 364
receives pursuant to section 4503.583 of the Revised Code to the 365
American legion, department of Ohio, inc., which shall use the 366
contributions to support the activities of the organization. 367

The registrar shall pay the contributions the registrar 368
receives pursuant to section 4503.584 of the Revised Code to the 369
Ohio natural energy institute to fund scholarships for students 370

pursuing careers in the oil and natural gas industry. 371

The registrar shall pay the contributions the registrar 372
receives pursuant to section 4503.588 of the Revised Code to the 373
Ohio grange patrons of husbandry foundation, which shall use the 374
contributions to support the activities of the organization. 375

The registrar shall pay to a sports commission created 376
pursuant to section 4503.591 of the Revised Code each 377
contribution the registrar receives under that section that an 378
applicant pays to obtain license plates that bear the logo of a 379
professional sports team located in the county of that sports 380
commission and that is participating in the license plate 381
program pursuant to division (E) of that section, irrespective 382
of the county of residence of an applicant. 383

The registrar shall pay to a community charity each 384
contribution the registrar receives under section 4503.591 of 385
the Revised Code that an applicant pays to obtain license plates 386
that bear the logo of a professional sports team that is 387
participating in the license plate program pursuant to division 388
(G) of that section. 389

The registrar shall pay the contributions the registrar 390
receives pursuant to section 4503.592 of the Revised Code to 391
pollinator partnership's monarch wings across Ohio program, 392
which shall use the contributions for the protection and 393
preservation of the monarch butterfly and pollinator corridor in 394
Ohio and for educational programs. 395

The registrar shall pay the contributions the registrar 396
receives pursuant to section 4503.594 of the Revised Code to 397
pelotonia, which shall use the contributions for the purpose of 398
supporting cancer research. 399

The registrar shall pay the contributions the registrar receives pursuant to section 4503.595 of the Revised Code to the Stan Hywet hall and gardens.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.596 of the Revised Code to the Cuyahoga valley scenic railroad.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.597 of the Revised Code to the Circleville pumpkin show, incorporated, which shall use the contributions to promote good will surrounding the Circleville pumpkin show as a nonprofit annual event.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.67 of the Revised Code to the Dan Beard council of the boy scouts of America. The council shall distribute all contributions in an equitable manner throughout the state to regional councils of the boy scouts.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.68 of the Revised Code to the girl scouts of Ohio's heartland. The girl scouts of Ohio's heartland shall distribute all contributions in an equitable manner throughout the state to regional councils of the girl scouts.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.69 of the Revised Code to the Dan Beard council of the boy scouts of America. The council shall distribute all contributions in an equitable manner throughout the state to regional councils of the boy scouts.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.70 of the Revised Code to the

charitable foundation of the grand lodge of Ohio, f. & a. m., 429
which shall use the contributions for scholarship purposes. 430

The registrar shall pay the contributions the registrar 431
receives pursuant to section 4503.701 of the Revised Code to the 432
Prince Hall grand lodge of free and accepted masons of Ohio, 433
which shall use the contributions for scholarship purposes. 434

The registrar shall pay the contributions the registrar 435
receives pursuant to section 4503.702 of the Revised Code to the 436
Ohio Association of the Improved Benevolent and Protective Order 437
of the Elks of the World, which shall use the funds for 438
charitable purposes. 439

The registrar shall pay the contributions the registrar 440
receives pursuant to section 4503.703 of the Revised Code to the 441
Ohio state moose association. 442

The registrar shall pay the contributions the registrar 443
receives pursuant to section 4503.704 of the Revised Code to the 444
Antioch shrine foundation located in the municipal corporation 445
of Dayton. 446

The registrar shall pay the contributions the registrar 447
receives pursuant to section 4503.71 of the Revised Code to the 448
fraternal order of police of Ohio, incorporated, which shall 449
deposit the fees into its general account to be used for 450
purposes of the fraternal order of police of Ohio, incorporated. 451

The registrar shall pay the contributions the registrar 452
receives pursuant to section 4503.711 of the Revised Code to the 453
fraternal order of police of Ohio, incorporated, which shall 454
deposit the contributions into an account that it creates to be 455
used for the purpose of advancing and protecting the law 456
enforcement profession, promoting improved law enforcement 457

methods, and teaching respect for law and order. 458

The registrar shall pay the contributions received 459
pursuant to section 4503.712 of the Revised Code to Ohio 460
concerns of police survivors, which shall use those 461
contributions to provide whatever assistance may be appropriate 462
to the families of Ohio law enforcement officers who are killed 463
in the line of duty. 464

The registrar shall pay the contributions received 465
pursuant to section 4503.713 of the Revised Code to the greater 466
Cleveland peace officers memorial society, which shall use those 467
contributions to honor law enforcement officers who have died in 468
the line of duty and support its charitable purposes. 469

The registrar shall pay the contributions received 470
pursuant to section 4503.714 of the Revised Code to the Ohio 471
association of chiefs of police. 472

The registrar shall pay the contributions the registrar 473
receives, or has received, pursuant to section 4503.715 of the 474
Revised Code to the community foundation of Ohio's electric 475
cooperatives, which shall use the contributions to recognize and 476
memorialize fallen or injured lineworkers and support their 477
families. 478

The registrar shall pay the contributions the registrar 479
receives pursuant to section 4503.716 of the Revised Code to the 480
fallen timbers battlefield preservation commission, which shall 481
use the contributions to further the mission of the commission. 482

The registrar shall pay the contributions the registrar 483
receives pursuant to section 4503.72 of the Revised Code to the 484
organization known on March 31, 2003, as the Ohio CASA/GAL 485
association, a private, nonprofit corporation organized under 486

Chapter 1702. of the Revised Code. The Ohio CASA/GAL association 487
shall use these contributions to pay the expenses it incurs in 488
administering a program to secure the proper representation in 489
the courts of this state of abused, neglected, and dependent 490
children, and for the training and supervision of persons 491
participating in that program. 492

The registrar shall pay the contributions the registrar 493
receives pursuant to section 4503.722 of the Revised Code to the 494
Down Syndrome Association of Central Ohio, which shall use the 495
contributions for advocacy purposes throughout the state. 496

The registrar shall pay the contributions the registrar 497
receives pursuant to section 4503.724 of the Revised Code to the 498
Ohio Chapter of the American Foundation for Suicide Prevention, 499
which shall use the contributions for programs, education, and 500
advocacy purposes throughout the state. 501

The registrar shall pay the contributions the registrar 502
receives, or has received, pursuant to section 4503.725 of the 503
Revised Code to the ALS united Ohio, incorporated, which shall 504
split the contributions between that organization and the ALS 505
association in accordance with any agreement between the two 506
organizations. The contributions shall be used to discover 507

The registrar shall pay the contributions the registrar 1139
receives pursuant to section 4503.958 of the Revised Code to 1140
Elder high school located in the municipal corporation of 1141
Cincinnati. The school shall use fifty per cent of the 1142
contributions it receives to provide tuition assistance to its 1143
students, twenty-five per cent of the contributions to benefit 1144
arts and enrichment at the school, and twenty-five per cent of 1145
the contributions to benefit athletics at the school. 1146

The registrar shall pay the contributions the registrar 1147
receives pursuant to section 4503.961 of the Revised Code to 1148
Fairfield senior high school located in the municipal 1149

corporation of Fairfield. The high school shall not use the 1150
contributions for any political purpose. 1151

The registrar shall pay the contributions the registrar 1152
receives pursuant to section 4503.962 of the Revised Code to 1153
Hamilton high school located in the municipal corporation of 1154
Hamilton. The high school shall not use the contributions for 1155
any political purpose. 1156

The registrar shall pay the contributions the registrar 1157
receives pursuant to section 4503.963 of the Revised Code to 1158
Ross high school located in Ross township in Butler county. The 1159
high school shall not use the contributions for any political 1160
purpose. 1161

The registrar shall pay the contributions the registrar 1162
receives pursuant to section 4503.964 of the Revised Code to 1163
Chardon hilltopper gridiron club. The club shall use 1164
contributions to fund college and career technical training 1165
scholarships for students. 1166

The registrar shall pay the contributions the registrar 1167
receives pursuant to section 4503.97 of the Revised Code to the 1168
friends of united Hatzalah of Israel, which shall use the money 1169
to support united Hatzalah of Israel, which provides free 1170
emergency medical first response throughout Israel. 1171

The registrar shall pay the contributions the registrar 1172
receives pursuant to section 4503.98 of the Revised Code to the 1173
Westerville parks foundation to support the programs and 1174
activities of the foundation and its mission of pursuing the 1175
city of Westerville's vision of becoming "A City Within A Park." 1176

(C) All investment earnings of the license plate 1177
contribution fund shall be credited to the fund. Not later than 1178

the first day of May of every year, the registrar shall 1179
distribute to each entity described in division (B) of this 1180
section the investment income the fund earned the previous 1181
calendar year. The amount of such a distribution paid to an 1182
entity shall be proportionate to the amount of money the entity 1183
received from the fund during the previous calendar year. 1184

Sec. 4503.588. (A) The owner or lessee of any passenger 1185
car, noncommercial motor vehicle, recreational vehicle, or other 1186
vehicle of a class approved by the registrar of motor vehicles 1187
may apply to the registrar for the registration of the vehicle 1188
and issuance of "Ohio State Grange" license plates. The 1189
application may be combined with a request for a special 1190
reserved license plate under section 4503.40 or 4503.42 of the 1191
Revised Code. Upon receipt of the completed application and 1192
compliance by the applicant with divisions (B) and (C) of this 1193
section, the registrar shall issue to the applicant the 1194
appropriate vehicle registration and a set of "Ohio State 1195
Grange" license plates and a validation sticker, or a validation 1196
sticker alone when required by section 4503.191 of the Revised 1197
Code. 1198

In addition to the letters and numbers ordinarily 1199
inscribed on the license plates, "Ohio State Grange" license 1200
plates shall display an appropriate logo and words that are 1201
selected by representatives of the Ohio grange patrons of 1202
husbandry foundation and approved by the registrar. "Ohio State 1203
Grange" license plates shall display county identification 1204
stickers that identify the county of registration as required 1205
under section 4503.19 of the Revised Code. 1206

(B) "Ohio State Grange" license plates and a validation 1207
sticker, or validation sticker alone, shall be issued upon 1208

receipt of an application for registration of a motor vehicle 1209
under this section; payment of the regular license tax as 1210
prescribed under section 4503.04 of the Revised Code, any 1211
applicable motor vehicle license tax levied under Chapter 4504. 1212
of the Revised Code, any applicable additional fee prescribed by 1213
section 4503.40 or 4503.42 of the Revised Code, an additional 1214
administrative fee of ten dollars, and a contribution as 1215
provided in division (C)(1) of this section; and compliance with 1216
all other applicable laws relating to the registration of motor 1217
vehicles. 1218

(C)(1) For each application for registration and 1219
registration renewal notice the registrar receives under this 1220
section, the registrar shall collect a contribution of twenty- 1221
five dollars. The registrar shall deposit this contribution into 1222
the state treasury to the credit of the license plate 1223
contribution fund created in section 4501.21 of the Revised 1224
Code. 1225

(2) The registrar shall deposit the administrative fee of 1226
ten dollars, the purpose of which is to compensate the bureau of 1227
motor vehicles for additional services required in the issuing 1228
of "Ohio State Grange" license plates, into the state treasury 1229
to the credit of the public safety - highway purposes fund 1230
created in section 4501.06 of the Revised Code. 1231
