A BILL

To amend section 5301.072 of the Revised Code to	1
prohibit homeowners associations from	2
restricting the display of political yard signs.	3

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 5301.072 of the Revised Code be	4
amended to read as follows:	5
Sec. 5301.072. (A) No covenant, condition, or restriction	6
set forth in a deed, and no rule, regulation, bylaw, or other	7
governing document or agreement of a homeowners, neighborhood,	8
civic, or other association, shall prohibit or be construed to	9
prohibit any of the following:	10
(1) The placement on any property of a flagpole that is to	11
be used for the purpose of displaying the flag of the United	12
States, the flag of the state as defined in section 5.01 of the	13
Revised Code, or the national league of families POW/MIA flag	14
provided the flag and flag pole shall be of an appropriate size,	15
consistent with the size and character of the buildings that are	16
subject to the requirements or agreements of a homeowner,	17
neighborhood, civic, or other association;	18

(2) The display on any property of the flag of the United

States or the national league of families POW/MIA flag if the	20
flag is displayed in accordance with any of the following:	21
(a) The patriotic customs set forth in 4 U.S.C. 5-10, and	22
36 U.S.C. 902 governing the display and use of the flag;	23
(b) The consent of the property's owner or of any person	24
having lawful control of the property;	25
(c) The recommended flagpole standards set forth in "Our	26
Flag," published pursuant to S.C.R. 61 of the 105th Congress,	27
1st Session (1998);	28
(d) Any federal law, proclamation of the president of the	29
United States or the governor, section of the Revised Code, or	30
local ordinance or resolution.	31
(3) The display on any property of the state flag as	32
defined in section 5.01 of the Revised Code if the flag is	33
displayed in accordance with any of the following:	34
(a) The consent of the property's owner or of any person	35
having lawful control of the property;	36
(b) Any state law, local ordinance or resolution, or	37
proclamation by the governor of the state.	38
(4) The display of a service flag approved by the United	39
States secretary of defense for display in a window of the	40
residence of a member of the immediate family of an individual	41
serving in the armed forces of the United States. A service flag	42
includes a blue star banner, a gold star banner, and any other	43
flag the secretary of defense designates as a service flag.	44
(5) The display of political yard signs, if displayed in	45
accordance with any state law, local ordinance or resolution, or	46
a proclamation by the governor of the state.	47

(B) A covenant, condition, restriction, rule, regulation,	48
bylaw, governing document, or agreement or a construction of any	49
of these items that violates division (A) of this section is	50
against public policy and unenforceable in any court of this	51
state to the extent it violates that division.	52
(C) As used in this section, "political" means that a yard	53
(c) is used in this section, policical means that a yara_	55
<u>sign endorses a particular political candidate, party, or belief</u>	54
and does not violate section 2927.12 of the Revised Code or 18	55
<u>U.S.C. 249.</u>	56
Section 2. That existing section 5301.072 of the Revised	57
Code is hereby repealed.	58
