BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 5901.02 and 5901.03 of the	/
Revised Code be amended to read as follows:	8
Sec. 5901.02. (A) In each county there shall be a	9
commission known as "the veterans service commission." Except as	10
provided in section 5901.021 of the Revised Code, the commission	11
shall be composed of five residents of the county appointed to	12
five-year terms-by a judge of the court of common pleas. At the	13
time of appointment or reappointment to the commission, no	14
commission member appointed under this section shall be an	15
employee of the commission or hold an elective or other	16
appointive office of the county served by the commission.	17
(B) Each member of the commission appointed under this	18
section shall be an honorably discharged or honorably separated	

veteran. Within sixty days after the date of appointment, each	20
such member shall file the member's form DD214 with the	21
department of veterans services in accordance with guidelines	22
established by the director of that department. Such	23
appointments shall be made from lists of recommended persons, in	24
the manner specified in the following paragraphthis section. One	25
person shall be a representative recommended by the American	26
Legion; one person shall be a representative recommended by the	27
Veterans of Foreign Wars; one person shall be a representative	28
recommended by the Disabled American Veterans; one person shall	29
be a representative recommended by the AMVETS; and one person	30
shall be a representative recommended by the Military Order of	31
the Purple Heart of the U.S.A., the Vietnam Veterans of America,	32
or the Korean War Veterans Association. If any such organization	33
has no post or chapter located in the county, the appointment	34
shall be made from lists of recommended persons submitted by	35
posts or chapters of any other congressionally chartered	36
veterans organizations located in the county. If no such other	37
organizations have posts or chapters located in the county, the	38
judge responsible for making appointments under this section-	39
appointing authority may appoint any qualified veteran to	40
represent the veteran community.	41
(C) On or before the fifteenth day of October of each	42
year, the appointing judge authority shall notify each post or	43
chapter of each organization within the county from which the	44
member may or must be appointed that it may submit a list	45
containing three recommendations of persons who are eligible for	46
appointment. At least one of the persons recommended shall have	47
served in the military after September 11, 2001.	48
Except as provided under division (D) of this section, and	49

not later than January 15, 2024, at which time appointments

shall have been made under divisions (E)(4) and (5) of this	51
section for 2023 and 2024 respectively, a veterans service	52
commission shall consist of at least two members who served in	53
the military after September 11, 2001. The appointing authority,	54
before making an appointment, shall ascertain the current	55
composition of the commission to determine if appointment of a	56
person who served in the military after September 11, 2001, is	57
necessary to comply with this section.	58
(D) If the judge appointing authority does not receive any	59
recommendations within sixty days after providing the required	60
notification, the judge appointing authority may appoint any	61
qualified veteran to represent the veteran community. The judge	62
appointing authority shall make the appointment on or before the	63
fifteenth day of January of each year. Any vacancy in a	64
membership appointed under this section shall be filled in the	65
same manner as the original appointments.	66

common pleas of the county for terms to commence in years ending	76
in one and six.	77
$\frac{(C)}{(3)}$ Appointments for members to represent the Disabled	78
American Veterans shall be made by the judge of the court of	79

in two and seven.

(D) (4) Appointments for members to represent the AMVETS	82
shall be made by the judge of the court of common pleas of the	83
<pre>county for terms to commence in years ending in three and eight.</pre>	84
$\frac{(E)}{(5)}$ Appointments for members to represent the Military	85
Order of the Purple Heart of the U.S.A., the Vietnam Veterans of	86
America, or the Korean War Veterans Association shall be made by	87
the board of commissioners of the county. These appointments	88
shall be for terms to commence in years ending in four and nine.	89
The terms immediately preceding the initial appointments	90
made under divisions (A) to (E) of this section may be for	91
periods of less than five years.	92
(F) The appointing authority shall remove a any member who	93
was appointed by that appointing authority and who fails to	94
maintain certification or whose certification is revoked by the	95
director of veterans services. The appointing authority may	96
remove, for cause, any member of the commission appointed by	97
that appointing authority and shall fill vacancies occurring	98
among memberships for the unexpired terms in the manner provided	99
for the original appointments.	100
Sec. 5901.03. The veterans service commission shall select	101
one of its members as president, one as vice-president, and one	102
as secretary. The commission shall meet at least once each	103
month. A judge of the court of common pleas may remove, for	104
cause, any member of the commission appointed under section	105
5901.02 of the Revised Code, and shall fill vacancies occurring	106
among memberships appointed under that section for the unexpired	107
terms in the manner provided for the original appointments.	108

The commission's duties shall include but are not limited	109
to the following:	110
(A) Employing such staff as are necessary to carry out the	111
commission's duties, and fixing their compensation;	112
(B) Establishing policies and procedures for the	113
administration of the commission and the veterans service	114
office;	115
(C) Establishing policies and procedures for the	116
administration of assistance as provided under this chapter;	117
(D) Causing the budgets of the veterans service commission	118
and veterans service office to be presented to the board of	119
county commissioners for approval;	120
(E) Establishing programs of outreach and coordination	121
with other agencies to enhance available services to veterans	122
within the county;	123
(F) Promoting, monitoring, and providing funding for	124
ongoing education and training for veterans service	125
commissioners and staff;	126
(G) Making reports to the organizations represented on the	127
commission, as provided in section 5901.02 of the Revised Code,	128
and to others, upon request;	129
(H) Establishing regularly scheduled transportation for	130
veterans to and from veterans administration medical centers	131
whose districts the county is within, through contractual	132
agreements or through other arrangements determined by the	133
commission to be most cost-effective;	134
(I) Participating in appropriate memorial and	135
commemorative activities to help promote patriotism and veterans	136
