Raymond A. Pryor and extend our heartfelt condolences to his family 3

WHEREAS, Ray Pryor left an indelible impression on the people 5
whose lives he touched, and he will be remembered as a spirited 6
individual who contributed immeasurably to the world around him. Among 7
his endeavors, he was a veteran of the U.S. Navy, a veterans 8
representative retired from the Ohio Department of Job and Family 9
Services, and a member of Bethel Chapel and the Ohio House of 10
Representatives during the 128th General Assembly. He continued his 11
advocacy of serving veterans as a co-founder of South-Central Homeless 12

Veterans, Veterans in Transition, and the Ross County Veterans 13
Council, and he was active with AMVETS, the Disabled American 14
Veterans, the American Legion, the Vietnam Veterans of America, the 15
Veterans of Foreign Wars, and the 40 and 8; and 16

WHEREAS, Ray Pryor's concern for improving the quality of life in 17
our society was clearly evident in his personal sacrifices of time and 18
effort to his family, friends, and community. Giving generously of his 19
energy and abilities in all of his endeavors, he displayed exceptional 20

to his two children, Leslie and Nicholas, and a doting grandfather to 23
his six grandchildren, Gavin, Braiden, Madelyn, Clayton, Graeme, and 24

and the laurels of his life stand as a tribute not only to him but 26
also to those he left behind. Although the void his death has created 27
can never be filled, the legacy of care and commitment he established 28
