**A BILL**

To amend section 4501.21 and to enact sections 1  
4503.541, 5533.106, 5533.532, 5534.013, 2  
5534.427, 5534.429, 5534.443, 5534.482, 3  
5534.502, 5534.505, 5534.617, 5534.673, 4  
5534.705, 5534.8710, 5534.914, 5534.919, 5  
5534.921, 5534.924, 5534.926, 5534.927, 6  
5534.929, 5534.941, 5534.961, 5534.964, 7  
5534.966, and 5534.968 of the Revised Code to 8  
make multiple highway designations and to create 9  
the "Dolly Parton Imagination Library" license 10  
plate. 11

**BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:**

**Section 1.** That section 4501.21 be amended and sections 12  
4503.541, 5533.106, 5533.532, 5534.013, 5534.427, 5534.429, 13  
5534.443, 5534.482, 5534.502, 5534.505, 5534.617, 5534.673, 14

5534.705, 5534.8710, 5534.914, 5534.919, 5534.921, 5534.924, 15  
5534.926, 5534.927, 5534.929, 5534.941, 5534.961, 5534.964, 16  
5534.966, and 5534.968 of the Revised Code be enacted to read as 17  
follows: 18

**Sec. 4501.21.** (A) There is hereby created in the state 19  
treasury the license plate contribution fund. The fund shall 20  
consist of all contributions for specialty license plates paid 21  
by motor vehicle registrants and collected by the registrar of 22  
motor vehicles pursuant to the Revised Code sections referenced 23  
in division (B) of this section. 24

(B) The registrar shall pay the contributions the 25  
registrar collects in the fund as follows: 26

The registrar shall pay the contributions received 27  
pursuant to section 4503.491 of the Revised Code to the breast 28  
cancer fund of Ohio, which shall use that money only to pay for 29  
programs that provide assistance and education to Ohio breast 30  
cancer patients and that improve access for such patients to 31  
quality health care and clinical trials and shall not use any of 32  
the money for abortion information, counseling, services, or 33  
other abortion-related activities. 34

The registrar shall pay the contributions the registrar 35  
receives pursuant to section 4503.492 of the Revised Code to the 36  
organization cancer support community central Ohio, which shall 37  
deposit the money into the Sheryl L. Kraner Fund of that 38  
organization. Cancer support community central Ohio shall expend 39  
the money it receives pursuant to this division only in the same 40  
manner and for the same purposes as that organization expends 41  
other money in that fund. 42

The registrar shall pay the contributions received 43

pursuant to section 4503.493 of the Revised Code to the autism 44  
society of Ohio, which shall use the contributions for programs 45  
and autism awareness efforts throughout the state. 46

The registrar shall pay the contributions the registrar 47  
receives pursuant to section 4503.494 of the Revised Code to the 48  
national multiple sclerosis society for distribution in equal 49  
amounts to the northwestern Ohio, Ohio buckeye, and Ohio valley 50  
chapters of the national multiple sclerosis society. These 51  
chapters shall use the money they receive under this section to 52  
assist in paying the expenses they incur in providing services 53  
directly to their clients. 54

The registrar shall pay the contributions the registrar 55  
receives pursuant to section 4503.495 of the Revised Code to the 56  
national pancreatic cancer foundation, which shall use the money 57  
it receives under this section to assist those who have 58  
pancreatic cancer and their families. 59

The registrar shall pay the contributions the registrar 60  
receives pursuant to section 4503.496 of the Revised Code to the 61  
Ohio sickle cell and health association, which shall use the 62  
contributions to help support educational, clinical, and social 63  
support services for adults who have sickle cell disease. 64

The registrar shall pay the contributions the registrar 65  
receives pursuant to section 4503.497 of the Revised Code to the 66  
St. Baldrick's foundation, which shall use the contributions for 67  
its research and other programs. 68

The registrar shall pay the contributions the registrar 69  
receives pursuant to section 4503.498 of the Revised Code to 70  
special olympics Ohio, inc., which shall use the contributions 71  
for its programs, charitable efforts, and other activities. 72

The registrar shall pay the contributions the registrar receives pursuant to section 4503.499 of the Revised Code to the children's glioma cancer foundation, which shall use the contributions for its research and other programs.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.4910 of the Revised Code to the KylerStrong foundation, which shall use the contributions to raise awareness of brain cancer caused by diffuse intrinsic pontine glioma and to fund research for the cure of such cancer.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.4911 of the Revised Code to the research institution for childhood cancer at nationwide children's hospital, which shall use the contributions to fund research for the cure of childhood cancers.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.50 of the Revised Code to the future farmers of America foundation, which shall deposit the contributions into its general account to be used for educational and scholarship purposes of the future farmers of America foundation.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.501 of the Revised Code to the 4-H youth development program of the Ohio state university extension program, which shall use those contributions to pay the expenses it incurs in conducting its educational activities.

The registrar shall pay the contributions received pursuant to section 4503.502 of the Revised Code to the Ohio cattlemen's foundation, which shall use those contributions for scholarships and other educational activities.

The registrar shall pay the contributions received 102  
pursuant to section 4503.505 of the Revised Code to the 103  
organization Ohio region phi theta kappa, which shall use those 104  
contributions for scholarships for students who are members of 105  
that organization. 106

The registrar shall pay the contributions the registrar 107  
receives pursuant to section 4503.506 of the Revised Code to 108  
Ohio demolay, which shall use the contributions for 109  
scholarships, educational programs, and any other programs or 110  
events the organization holds or sponsors in this state. 111

The registrar shall pay the contributions received 112  
pursuant to section 4503.507 of the Revised Code to the Ohio 113  
aerospace institute, which shall use those contributions to 114  
facilitate student internships in aerospace and educational 115  
programming. 116

The registrar shall pay the contributions received 117  
pursuant to section 4503.508 of the Revised Code to the 118  
organization bottoms up diaper drive to provide funding for that 119  
organization for collecting and delivering diapers to parents in 120  
need. 121

The registrar shall pay the contributions the registrar 122  
receives pursuant to section 4503.509 of the Revised Code to a 123  
kid again, incorporated for distribution in equal amounts to the 124  
Ohio chapters of a kid again. 125

The registrar shall pay each contribution the registrar 126  
receives pursuant to section 4503.51 of the Revised Code to the 127  
university or college whose name or marking or design appears on 128  
collegiate license plates that are issued to a person under that 129  
section. A university or college that receives contributions 130

from the fund shall deposit the contributions into its general 131  
scholarship fund. 132

The registrar shall pay the contributions the registrar 133  
receives pursuant to section 4503.514 of the Revised Code to the 134  
university of Notre Dame in South Bend, Indiana, for purposes of 135  
awarding grants or scholarships to residents of Ohio who attend 136  
the university. The university shall not use any of the funds it 137  
receives for purposes of administering the scholarship program. 138  
The registrar shall enter into appropriate agreements with the 139  
university of Notre Dame to effectuate the distribution of such 140  
funds as provided in this section. 141

The registrar shall pay the contributions the registrar 142  
receives pursuant to section 4503.516 of the Revised Code to 143  
Marshall university in Huntington, West Virginia, for purposes 144  
of awarding grants or scholarships to residents of Ohio who 145  
attend the university. The university shall not use any of the 146  
funds it receives for purposes of administering the scholarship 147  
program. The registrar shall enter into appropriate agreements 148  
with Marshall university to effectuate the distribution of such 149  
funds as provided in this section. 150

The registrar shall pay the contributions the registrar 151  
receives pursuant to section 4503.517 of the Revised Code to the 152  
university of Alabama in Tuscaloosa, Alabama, for purposes of 153  
awarding grants or scholarships to residents of Ohio who attend 154  
the university. The university shall not use any of the funds it 155  
receives for purposes of administering the scholarship program. 156  
The registrar shall enter into appropriate agreements with the 157  
university of Alabama to effectuate the distribution of such 158  
funds as provided in this section. 159

The registrar shall pay the contributions the registrar 160

receives pursuant to section 4503.518 of the Revised Code to the 161  
Nationwide children's hospital, which shall use the 162  
contributions for the "On Our Sleeves" campaign. 163

The registrar shall pay the contributions the registrar 164  
receives pursuant to section 4503.519 of the Revised Code 165  
equally to NAMI Ohio (national alliance on mental illness of 166  
Ohio), Ohio peer recovery organizations, and OCAAR (Ohio citizen 167  
advocates for addiction recovery). 168

The registrar shall pay the contributions the registrar 169  
receives pursuant to section 4503.521 of the Revised Code to the 170  
Ohio bicycle federation to assist that organization in paying 171  
for the educational programs it sponsors in support of Ohio 172  
cyclists of all ages. 173

The registrar shall pay the contributions the registrar 174  
receives pursuant to section 4503.522 of the Revised Code to the 175  
"friends of Perry's victory and international peace memorial, 176  
incorporated," a nonprofit corporation organized under the laws 177  
of this state, to assist that organization in paying the 178  
expenses it incurs in sponsoring or holding charitable, 179  
educational, and cultural events at the monument. 180

The registrar shall pay the contributions the registrar 181  
receives pursuant to section 4503.523 of the Revised Code to the 182  
fairport lights foundation, which shall use the money to pay for 183  
the restoration, maintenance, and preservation of the 184  
lighthouses of fairport harbor. 185

The registrar shall pay the contributions the registrar 186  
receives pursuant to section 4503.524 of the Revised Code to the 187  
Massillon tiger football booster club, which shall use the 188  
contributions only to promote and support the football team of 189

Washington high school of the Massillon city school district. 190

The registrar shall pay the contributions the registrar 191  
receives pursuant to section 4503.525 of the Revised Code to the 192  
United States power squadron district seven which shall annually 193  
distribute the contributions in equal amounts to all United 194  
States power squadrons located in the state. Each power squadron 195  
district shall use the money it receives under this section to 196  
pay for the educational boating programs each district holds or 197  
sponsors within this state. 198

The registrar shall pay the contributions the registrar 199  
receives pursuant to section 4503.526 of the Revised Code to the 200  
Ohio district Kiwanis foundation of the Ohio district of Kiwanis 201  
international, which shall use the money it receives under this 202  
section to pay the costs of its educational and humanitarian 203  
activities. 204

The registrar shall pay the contributions the registrar 205  
receives pursuant to section 4503.528 of the Revised Code to the 206  
Ohio children's alliance, which shall use the money it receives 207  
under this section to pay the expenses it incurs in advancing 208  
its mission of sustainably improving the provision of services 209  
to children, young adults, and families in this state. 210

The registrar shall pay the contributions the registrar 211  
receives pursuant to section 4503.529 of the Revised Code to the 212  
Ohio nurses foundation. The foundation shall use the money it 213  
receives under this section to provide educational scholarships 214  
to assist individuals who aspire to join the nursing profession, 215  
to assist nurses in the nursing profession who seek to advance 216  
their education, and to support persons conducting nursing 217  
research concerning the evidence-based practice of nursing and 218  
the improvement of patient outcomes. 219



The registrar shall pay the contributions the registrar 220  
receives pursuant to section 4503.531 of the Revised Code to the 221  
thank you foundation, incorporated, a nonprofit corporation 222  
organized under the laws of this state, to assist that 223  
organization in paying for the charitable activities and 224  
programs it sponsors in support of United States military 225  
personnel, veterans, and their families. 226

The registrar shall pay the contributions the registrar 227  
receives pursuant to section 4503.532 of the Revised Code to the 228  
Ohio history connection, which shall use the contributions for 229  
the benefit of the Paul Laurence Dunbar house. 230

The registrar shall pay the contributions the registrar 231  
receives pursuant to section 4503.533 of the Revised Code to the 232  
nonprofit organization Ohio conference of teamsters and industry 233  
health and welfare fund, which shall use the contributions to 234  
further the nonprofit's mission. 235

The registrar shall pay the contributions the registrar 236  
receives pursuant to section 4503.534 of the Revised Code to the 237  
disabled American veterans department of Ohio, to be used for 238  
programs that serve disabled American veterans and their 239  
families. 240

The registrar shall pay the contributions the registrar 241  
receives pursuant to section 4503.541 of the Revised Code to 242  
Dolly Parton's imagination library of Ohio. The library shall 243  
use the money it receives under this section for operational 244  
costs, including the distribution of books. 245

The registrar shall pay the contributions the registrar 246  
receives pursuant to section 4503.55 of the Revised Code to the 247  
pro football hall of fame, which shall deposit the contributions 248

into a special bank account that it establishes and which shall 249  
be separate and distinct from any other account the pro football 250  
hall of fame maintains, to be used exclusively for the purpose 251  
of promoting the pro football hall of fame as a travel 252  
destination. 253

The registrar shall pay the contributions that are paid to 254  
the registrar pursuant to section 4503.545 of the Revised Code 255  
to the national rifle association foundation, which shall use 256  
the money to pay the costs of the educational activities and 257  
programs the foundation holds or sponsors in this state. 258

The registrar shall pay to the Ohio pet fund the 259  
contributions the registrar receives pursuant to section 260  
4503.551 of the Revised Code and any other money from any other 261  
source, including donations, gifts, and grants, that is 262  
designated by the source to be paid to the Ohio pet fund. The 263  
Ohio pet fund shall use the moneys it receives under this 264  
section to support programs for the sterilization of dogs and 265  
cats and for educational programs concerning the proper 266  
veterinary care of those animals, and for expenses of the Ohio 267  
pet fund that are reasonably necessary for it to obtain and 268  
maintain its tax-exempt status and to perform its duties. 269

The registrar shall pay the contributions the registrar 270  
receives pursuant to section 4503.552 of the Revised Code to the 271  
rock and roll hall of fame and museum, incorporated. 272

The registrar shall pay the contributions the registrar 273  
receives pursuant to section 4503.553 of the Revised Code to the 274  
Ohio coalition for animals, incorporated, a nonprofit 275  
corporation. Except as provided in division (B) of this section, 276  
the coalition shall distribute the money to its members, and the 277  
members shall use the money only to pay for educational, 278

charitable, and other programs of each coalition member that 279  
provide care for unwanted, abused, and neglected horses. The 280  
Ohio coalition for animals may use a portion of the money to pay 281  
for reasonable marketing costs incurred in the design and 282  
promotion of the license plate and for administrative costs 283  
incurred in the disbursement and management of funds received 284  
under this section. 285

The registrar shall pay the contributions the registrar 286  
receives pursuant to section 4503.554 of the Revised Code to the 287  
Ohio state council of the knights of Columbus, which shall use 288  
the contributions to pay for its charitable activities and 289  
programs. 290

The registrar shall pay the contributions the registrar 291  
receives pursuant to section 4503.555 of the Revised Code to the 292  
western reserve historical society, which shall use the 293  
contributions to fund the Crawford auto aviation museum. 294

The registrar shall pay the contributions the registrar 295  
receives pursuant to section 4503.556 of the Revised Code to the 296  
Erica J. Holloman foundation, inc., for the awareness of triple 297  
negative breast cancer. The foundation shall use the 298  
contributions for charitable and educational purposes. 299

The registrar shall pay each contribution the registrar 300  
receives pursuant to section 4503.557 of the Revised Code to the 301  
central Ohio chapter of the Ronald McDonald house charities, 302  
which shall distribute the contribution to the chapter of the 303  
Ronald McDonald house charities in whose geographic territory 304  
the person who paid the contribution resides. 305

The registrar shall pay the contributions the registrar 306  
receives pursuant to section 4503.559 of the Revised Code to 307

playhouse square, located in Cleveland, Ohio, which shall use 308  
the contributions to further its mission of presenting and 309  
producing a wide variety of quality performing arts, advancing 310  
arts education, and creating a superior destination for 311  
entertainment, business, and residential living. 312

The registrar shall pay the contributions the registrar 313  
receives pursuant to section 4503.561 of the Revised Code to the 314  
state of Ohio chapter of ducks unlimited, inc., which shall 315  
deposit the contributions into a special bank account that it 316  
establishes. The special bank account shall be separate and 317  
distinct from any other account the state of Ohio chapter of 318  
ducks unlimited, inc., maintains and shall be used exclusively 319  
for the purpose of protecting, enhancing, restoring, and 320  
managing wetlands and conserving wildlife habitat. The state of 321  
Ohio chapter of ducks unlimited, inc., annually shall notify the 322  
registrar in writing of the name, address, and account to which 323  
such payments are to be made. 324

The registrar shall pay the contributions the registrar 325  
receives pursuant to section 4503.562 of the Revised Code to the 326  
Mahoning river consortium, which shall use the money to pay the 327  
expenses it incurs in restoring and maintaining the Mahoning 328  
river watershed. 329

The registrar shall pay the contributions the registrar 330  
receives pursuant to section 4503.564 of the Revised Code to the 331  
Glen Helen association to pay expenses related to the Glen Helen 332  
nature preserve. 333

The registrar shall pay the contributions the registrar 334  
receives pursuant to section 4503.565 of the Revised Code to the 335  
conservancy for Cuyahoga valley national park, which shall use 336  
the money in support of the park. 337

The registrar shall pay the contributions the registrar 338  
receives pursuant to section 4503.566 of the Revised Code to the 339  
Ottawa national wildlife refuge, which shall use the 340  
contributions for wildlife preservation purposes. 341

The registrar shall pay the contributions the registrar 342  
receives pursuant to section 4503.567 of the Revised Code to the 343  
girls on the run of Franklin county, inc., which shall use the 344  
contributions to support the activities of the organization. 345

The registrar shall pay the contributions the registrar 346  
receives pursuant to section 4503.569 of the Revised Code to the 347  
Ohio bird sanctuary, located in Mansfield, Ohio, which shall use 348  
the contributions for purposes of its operations, bird care and 349  
rehabilitation, and educational programs. 350

The registrar shall pay the contributions the registrar 351  
receives pursuant to section 4503.576 of the Revised Code to the 352  
Ohio state beekeepers association, which shall use those 353  
contributions to promote beekeeping, provide educational 354  
information about beekeeping, and to support other state and 355  
local beekeeping programs. 356

The registrar shall pay the contributions the registrar 357  
receives pursuant to section 4503.577 of the Revised Code to the 358  
national aviation hall of fame, which shall use the 359  
contributions to fulfill its mission of honoring aerospace 360  
legends to inspire future leaders. 361

The registrar shall pay the contributions the registrar 362  
receives pursuant to section 4503.578 of the Revised Code to 363  
keep Ohio beautiful, incorporated, which shall use the 364  
contributions towards its mission of empowering Ohio communities 365  
to take greater responsibility for improving the local 366

environment through litter prevention, beautification, community 367  
greening, waste reduction, and recycling. 368

The registrar shall pay the contributions the registrar 369  
receives pursuant to section 4503.579 of the Revised Code to the 370  
national council of negro women, incorporated, which shall use 371  
the contributions for educational purposes. 372

The registrar shall pay the contributions the registrar 373  
receives pursuant to section 4503.581 of the Revised Code to the 374  
Ohio past detachment commander's club, inc., which shall use the 375  
contributions to support the activities of the organization. 376

The registrar shall pay the contributions the registrar 377  
receives pursuant to section 4503.582 of the Revised Code to the 378  
progressive animal welfare society adoption center, inc., which 379  
shall use the contributions to support the activities of the 380  
center. 381

The registrar shall pay the contributions the registrar 382  
receives pursuant to section 4503.583 of the Revised Code to the 383  
American legion, department of Ohio, inc., which shall use the 384  
contributions to support the activities of the organization. 385

The registrar shall pay the contributions the registrar 386  
receives pursuant to section 4503.584 of the Revised Code to the 387  
Ohio natural energy institute to fund scholarships for students 388  
pursuing careers in the oil and natural gas industry. 389

The registrar shall pay to a sports commission created 390  
pursuant to section 4503.591 of the Revised Code each 391  
contribution the registrar receives under that section that an 392  
applicant pays to obtain license plates that bear the logo of a 393  
professional sports team located in the county of that sports 394  
commission and that is participating in the license plate 395

program pursuant to division (E) of that section, irrespective 396  
of the county of residence of an applicant. 397

The registrar shall pay to a community charity each 398  
contribution the registrar receives under section 4503.591 of 399  
the Revised Code that an applicant pays to obtain license plates 400  
that bear the logo of a professional sports team that is 401  
participating in the license plate program pursuant to division 402  
(G) of that section. 403

The registrar shall pay the contributions the registrar 404  
receives pursuant to section 4503.592 of the Revised Code to 405  
pollinator partnership's monarch wings across Ohio program, 406  
which shall use the contributions for the protection and 407  
preservation of the monarch butterfly and pollinator corridor in 408  
Ohio and for educational programs. 409

The registrar shall pay the contributions the registrar 410  
receives pursuant to section 4503.594 of the Revised Code to 411  
pelotonia, which shall use the contributions for the purpose of 412  
supporting cancer research. 413

The registrar shall pay the contributions the registrar 414  
receives pursuant to section 4503.595 of the Revised Code to the 415  
Stan Hywet hall and gardens. 416

The registrar shall pay the contributions the registrar 417  
receives pursuant to section 4503.596 of the Revised Code to the 418  
Cuyahoga valley scenic railroad. 419

The registrar shall pay the contributions the registrar 420  
receives pursuant to section 4503.597 of the Revised Code to the 421  
Circleville pumpkin show, incorporated, which shall use the 422  
contributions to promote good will surrounding the Circleville 423  
pumpkin show as a nonprofit annual event. 424

The registrar shall pay the contributions the registrar 425  
receives pursuant to section 4503.67 of the Revised Code to the 426  
Dan Beard council of the boy scouts of America. The council 427  
shall distribute all contributions in an equitable manner 428  
throughout the state to regional councils of the boy scouts. 429

The registrar shall pay the contributions the registrar 430  
receives pursuant to section 4503.68 of the Revised Code to the 431  
girl scouts of Ohio's heartland. The girl scouts of Ohio's 432  
heartland shall distribute all contributions in an equitable 433  
manner throughout the state to regional councils of the girl 434  
scouts. 435

The registrar shall pay the contributions the registrar 436  
receives pursuant to section 4503.69 of the Revised Code to the 437  
Dan Beard council of the boy scouts of America. The council 438  
shall distribute all contributions in an equitable manner 439  
throughout the state to regional councils of the boy scouts. 440

The registrar shall pay the contributions the registrar 441  
receives pursuant to section 4503.70 of the Revised Code to the 442  
charitable foundation of the grand lodge of Ohio, f. & a. m., 443  
which shall use the contributions for scholarship purposes. 444

The registrar shall pay the contributions the registrar 445  
receives pursuant to section 4503.701 of the Revised Code to the 446  
Prince Hall grand lodge of free and accepted masons of Ohio, 447  
which shall use the contributions for scholarship purposes. 448

The registrar shall pay the contributions the registrar 449  
receives pursuant to section 4503.702 of the Revised Code to the 450  
Ohio Association of the Improved Benevolent and Protective Order 451  
of the Elks of the World, which shall use the funds for 452  
charitable purposes. 453



The registrar shall pay the contributions the registrar receives pursuant to section 4503.703 of the Revised Code to the Ohio state moose association.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.704 of the Revised Code to the Antioch shrine foundation located in the municipal corporation of Dayton.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.71 of the Revised Code to the fraternal order of police of Ohio, incorporated, which shall deposit the fees into its general account to be used for purposes of the fraternal order of police of Ohio, incorporated.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.711 of the Revised Code to the fraternal order of police of Ohio, incorporated, which shall deposit the contributions into an account that it creates to be used for the purpose of advancing and protecting the law enforcement profession, promoting improved law enforcement methods, and teaching respect for law and order.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.94 of the Revised Code to the Michelle's leading star foundation, which shall use the money

solely to fund the rental, lease, or purchase of the simulated 1024  
driving curriculum of the Michelle's leading star foundation by 1025  
boards of education of city, exempted village, local, and joint 1026  
vocational school districts. 1027

The registrar shall pay the contributions the registrar 1028  
receives pursuant to section 4503.941 of the Revised Code to the 1029
