Proponent Testimony on House Resolution 101 May 27, 2025

Chair Miller, Vice Chair Hiner, Ranking Member Jarrells, and members of the House Arts, Athletics, and Tourism Committee — thank you for the opportunity to submit proponent testimony on House Resolution 101, which offers support of Cleveland's bid to host the 2030 Special Olympics USA Games.

The Special Olympics are rooted in dignity, perseverance, and joy. Supporting this bid sends a clear message about Ohio's values and commitments. We believe Ohio—and Cleveland—are the right places to bring those values to life in 2030.

Cleveland already has the infrastructure and civic partnerships in place to deliver an exceptional experience. With nationally recognized venues such as Rocket Arena, and with leading partners like Destination Cleveland, the Greater Cleveland Sports Commission, and Special Olympics Ohio, this effort is both realistic and inspiring.
