That means for those of us who make \$16.00 an hour and work full time, nearly half of our annual salary would be spent on childcare for one child. Like childcare, finding health coverage is nearly impossible. Most small childcare businesses cannot afford to offer it to us. Work requirements for Medicaid will cause an additional 60,000 Ohioans like me to lose health coverage.

It is important to point out that while this budget is moving in the right direction, we need smart solutions to engage in more ways to bring about smart solutions to the problems facing childcare workers.
