I am Jeff Gaskin, the Mayor of South Point way down on Ohio's Southern Coast and my county is one of the counties with 300% of the needed treatment facilities. We have 3 resident houses and 3 day treatment facilities. We are a Village of 4,000.

Let me first say that my education and license is in drug and alcohol counseling. I say that to let you that I am not against drug treatment and rehab, I am echoing what my constituents want, that's what we are supposed to do, right?

I'm not here to complain so much about "bad actors" so much as quantity and location. I have two "good actors "in my town. Another small city in the county has 25 houses in a city of about 10,000. Most of them are not as good as my good ones. I understand well about ADA and Fair Housing. A year ago, I spent a day with OMHAS in an attempt help regulate the houses and learn more about our regulations.

I don't think many people are against drug and alcohol rehab, they just don't want to pay for it.... with our property values. I'm sure everyone here has a nice home, think of trying to sell it and you take the prospective couple out back to show them the pool. They hear a commotion next door and ask what is that? Oh, that is a drug rehab house. Would that negate your sale?

I have a friend that had a handshake deal to sell his house for \$350,000. They stepped out front talk more and asked what was across the street. It was a drug day treatment facility. They left and he finally got \$300,000 for the house.
