Chairman Click, Vice Chair Mullins, Ranking Member Brewer, and members of the House Community Revitalization Committee, thank you for allowing me the opportunity to give sponsor testimony today.

During my tenure in the state legislature, I have been confronted with an issue I never anticipated: trash.

So let's talk trash!

My constituents in Fostoria and Seneca County have struggled with out of state trash, mostly from the east coast, coming into their home for years. Most of this has happened without meaningful oversight, causing my constituents to worry about the effects on the air they breathe, the water they drink, and their overall quality of life. This struggle also affects all of us; no one wants a lack of oversight over the waste brought in our state—or even thinks about it.

This bill confronts this issue for all my constituents and for all Ohioans. After learning from the people of Fostoria and from local leaders, this bill takes steps to approaching our trash problem.

In summary, the bill:

- Creates no new fee increases and no new regulations.
- Allows for a new <u>permissive and variable</u> fee for C&DD in ORC 3714.07. These fees and their collection mirror the district disposal fees for solid waste under current law (ORC3734.57B). The money collected from the fees are passed on to the health boards that have these facilities in their territories. Boards of health can use these dollars to mitigate impacts to health, safety, and welfare.
- Allows solid waste management districts to pass funds on to cities, counties, boards of health, municipalities and townships so they can mitigate impacts to health, safety, and welfare.
- Allows a county to leave a solid waste management district via resolution by that county's board of commissioners. In the code, there is no withdrawal or "divorce" mechanism in place. Currently, Seneca County is part of a 3-county solid waste district. On your Ipads is a map showing 62 counties that are separate solid waste districts.

This bill is a direct response to my constituents and community leaders who are tired of being unheard and who have drastic concerns for their health and quality of life. For many years, local voices have been ignored in landfill decisions – local impacts make a difference. This is my constituents' home, and this will provide for some much-needed community oversight over something that is in their back yard.


The State of Ohio has been very forward in inviting new businesses to our state. I applaud all of those efforts, however, with those great innovations and technological changes coming, we also need to be on top of our trash situation. Ohio is also the destination for trash because of our reluctance to recognize exactly the need to be doing more with recycling. With local oversight, our constituents need to be assured that the air we breathe and the water we drink are clean and that the contents of trains coming through our state are adequately monitored.

This issue from my locals is complicated, but this bill is a great step for communities and trash in Ohio.
