Opponent testimony by Elliot Forhan House Bill 96, "Make state operating appropriations for FY 2026-27" Wednesday, March 12, 2025

Chair Stewart, Vice Chair Sweeney, members of the committee,

Tax the rich and stand up to bullies. That's what the government of the State of Ohio should be doing to promote the safety, health and freedom of all Ohioans. But it's not what we—what you—are doing right now. We are giving the rich a tax break and enabling bullying by the state attorney general.

Regarding taxes:

This operating budget bill continues the Great Ohio Tax Shift of the past generation:¹ it maintains loopholes for the wealthy and influential and special treatment for powerful corporations. We have lost out on decades' worth of potential in our state, sacrificing our well-being and economic security to help the rich get richer. The people with the smallest incomes pay more; the rich pay less; and we have less resources to provide the basic things that Ohioans need to live free lives as free people.

Those in the top 1% of earners, making more than \$650,000 per year, now pay on average approximately \$52,000 <u>less</u> per year in taxes than they did in 2005. Again, we are giving away more than 50 grand each year to people who already make \$650,000. Unbelievable.

These tax cuts come at a high cost: approximately \$13 billion in revenue per year. We are giving up a lot of money to make the rich richer.

We should reverse the shift and use that \$13 billion to make Ohio better for everyone. We should be funding basic services, like education, child care, health care and transportation.

Meanwhile, Ohio continues to fall behind the rest of the country in economic growth and job creation. Ohio has underperformed since 2005 in both real G.D.P. and total employment.

Once again, right now, Ohio legislators are asking the poorest Ohioans to pay more, giving handouts to the rich and draining the state of the resources that we need to guarantee our freedom. House Bill 96, this operating-budget bill, is more of the same. Ohioans have had

enough. Members of this committee, please: do your jobs. Amend this bill to (1) reverse the Great Ohio Tax Shift, (2) tax the rich and (3) ensure that we have the resources to guarantee freedom for all Ohioans.

Regarding bullying:

Ohio Attorney General Dave Yost is wasting hundreds of thousands of public dollars on a fraudulent abuse and politicization of the outside-counsel process. He is using that money to bully people who disagree with him and put money in the pocket of his rich friends—who turn around and donate to his political campaigns. It's a political money-laundering operation where the Ohio taxpayer is left holding the bag.

Yost spent approximately \$75,000.00 on a sham internal investigation of me, for which I am now suing him, together with several other folks, including former House speaker Jason Stephens and former co-House speaker Allison Russo, for defaming me.

Yost is giving even more public money to the same law firm in connection with an Ohio Civil Rights Commission matter within the Ohio House. You can see that on the attachment to my testimony. (See Exhibit A.) It's a list of engagements given by the A.G. to the Perez Morris law firm, the firm that performed the sham investigation of me. (By the way, I am also suing Perez Morris and its lawyers who performed that sham investigation.) Serving as outside counsel to the State is a lucrative business. Participating in the politicizing of workplace investigations may well be a condition of that continued work. More investigation is needed. I requested records to obtain more information about these matters. I await a response to that request.

Yost gave another \$100,000.00 to another law firm to wage a malicious prosecution against me, something clearly outside of his authority. That matter started with the filing of false police reports against me, included a person saying that she wanted an excuse to shoot me and another person committing perjury from the witness stand and ended with my total exoneration. The judge wrote, "This case has no merit. Mr. Forhan is hereby exonerated." If the attorney general had performed a minimum amount of due diligence, then he would have saved the taxpayers tens of thousands of dollars and saved my family and me from severe emotional distress—including a trip to the emergency room for one of my moms from the stress of it all.

Yost is of course also paying for lawyers to defend himself, Allison Russo and Jason Stephens in my defamation lawsuit against them. So far his lawyers are not arguing that what they did was right but rather that they are immune from liability for doing what was wrong. It's a losing argument. More Ohio taxpayer money wasted to fund the consequences of them playing their B.S. political games. They are doing it on the taxpayer dime. Shame on them.

The law already prohibits the A.G.'s outside-counsel nonsense. This committee should amend the budget bill to include more checks and oversight of the A.G.'s office in connection with this waste, fraud and abuse. Defund Yost's corruption and use the money to fund vital services for Ohioans.
