## State Representative Joshua E. Williams Ohio House of Representatives

Chairman Stewart, Vice-Chair Dovilla, Ranking Member Sweeney, and members of the House Finance Committee, thank you for the opportunity to testify in support of HB 101. I would also like to thank my joint sponsor, Representative Mohamed, for bringing this legislation forward.

As he stated, this legislation would establish a scholarship dedicated to encouraging students to pursue legal education. As a pilot program, its first iteration would choose around 10-20 Ohio students who come from groups that are underrepresented in the legal profession. In addition to receiving a scholarship of \$4,000, these students will also gain access to one-on-one mentoring, free test preparation materials, academic support, and registration for the Law School Admissions Test. In all, \$350,000 would be appropriated to the Department of Higher Education to establish this program.

Upon passage of this bill, the Ohio Bar Association must monitor the administration, outcomes, and revenues/expenses of this pilot program. By early 2028, they must then submit a report that outlines this to the Chancellor of Higher Education, the House Workforce and Higher Education Committee, and the Senate Higher Education Committee.

This legislation is essential for our state. Over the past few years, we have seen a shortage of lawyers in Ohio, especially in rural areas. According to data from the Ohio Bar Association, possible clients outnumber attorneys by more than 700 to 1 in 82 of Ohio's 88 counties<sup>1</sup>. Needless
