Chair Hall, Vice Chair Ferguson, Ranking Member Humphrey, and members of the committee:

My husband and I live in Mason, Ohio. I am a homemaker and my husband will be retiring in one month after 45 years of working for the University of Cincinnati, and the Veterans administration in IT.

Though our financial security is strong, we believe that if our country continues to add trillions to the national debt each year, our children will not be as fortunate. I do not think that two of my three daughters will ever be able to buy a home. I also do not want them to live under a tyrannical government that overregulates and controls our lives in too many areas.

We have slowly been losing our constitutional freedoms; freedom of speech, freedom of the press, freedom of religion, and the right to bear arms. The views of conservatives are blocked on social media and in the news. My comments on Facebook and on our Neighborhood app have been deleted, including a statement about what the Convention of States is about so that others could know about it. Everyone can agree that the size of government and spending are out of control. We can no longer rely on the news media to tell the truth as they are being controlled by political groups and big money. We have non-Christian values being indoctrinated against our children. Teaching preschoolers about transgenderism, and sexual identity at an age where they aren't ready to learn about sex is outrageous. Preschoolers and elementary kids do not need to be assaulted by such information. There are so many more interesting and enriching things that children can be taught! They are being taught distorted views of our country and are not being taught about the wisdom and greatness of our constitution. They don't even know the difference between Democracy and a Constitutional Republic, and therefore, the cries of the liberals that the conservatives are destroying democracy are believed by them to mean we are destroying the constitution! Even Russian is a "democracy". Fortunately, my children learned phonics at a private school, the way children used to learn to read. Now many children have very poor reading skills because of the government's control of our education, enforcing whole language learning. Everyone knows about the Catholic churches being spied on, and the cake decorator who refused to do a wedding cake for a same sex couple.
