Chair Schmidt, Vice Chair Deeter and Ranking Member Somani, and members of the House Health Committee. Thank you for the opportunity to testify on House Bill 96, the state operating budget. I am Jason Koma, the executive director of the Charitable Healthcare Network.

The Charitable Healthcare Network is the statewide network of free and charitable providers in Ohio. We work to achieve our mission to strengthen and ensure high-quality health care for people who are vulnerable with and through a network of 56 free clinics and charitable providers in Ohio. This diverse network includes free clinics, charitable clinics, rural health centers, charitable pharmacies, and counseling centers, among others. As of 2024, our 56 network institutions serve 86 of Ohio's 88 counties.

The financial support from the Ohio General Assembly, the Ohio Department of Health and the governor's office is essential to support our care for the uninsured and underserved populations across the state. This crucial support of general revenue funds through the Free Clinic Safety Net line item within the Ohio Department of Health is currently at \$1.75M per fiscal year. It serves as a vital lifeline to Ohio's free clinics.

With the support of this funding, in 2024, Ohio's free and charitable providers delivered nearly 715,000 healthcare services – primary care, specialty care, prescriptions, and education, among others. The total value of these services was approximately \$224M, providing vital healthcare services to the most vulnerable in our state at little to no cost to those patients. We are asking for your continued support of the Free Clinic Safety Net Services line item.

As I close, I want to provide additional context on the patients served by our clinics. They are hard-working Ohioans who often work more than one job but have no health insurance. These are moms, dads, brothers and sisters. Here are just two brief stories on the impact of free and charitable clinics in Ohio.



# CHARITABLE HEALTHCARE NETWORK

*Ohio: Stronger. Healthier. Together.*

*In July 2024, we met a patient who works full-time but despite her full-time employment, she cannot afford health insurance. This patient is a breast cancer survivor, currently in remission, but her health battle cost her a better-paying job with superior benefits. She came to us with numbness in her fingers, but due to her financial situation, she couldn't afford the diagnostic tests needed to determine the cause. During her visits, she broke down in tears as she shared the weight of her ongoing medical and social challenges. In response, we immediately involved one of our care coordinators to support her during the medical visit. Together with our volunteer provider, our care coordination team is now working closely with her to address both her healthcare and social needs. This includes connecting her with dental care, establishing a medical home, and guiding her through the healthcare system to ensure she receives the diagnostic testing required to manage her health.*

*Husband and wife came into the clinic because they lost insurance and could not afford insurance premiums. They were both diabetic and had numbers that were out of range. They were able to obtain free labs and medication and obtain appointments with an endocrinology specialist. The husband was able to get free insulin medication that would normally cost \$500 per month. His A1c (average blood sugar) has now improved from 9.4 to 7.3. Overall, both of their medical conditions improved due to the care and services provided at our clinic.*

As you can see, the state's free clinics and charitable providers are the backbone of our healthcare safety net but we cannot do so without your support. Again, we are asking for your continued support of the Free Clinic Safety Net Services line item.

## STATEWIDE IMPACT & SUPPORT

CHN works directly with ODH to support free and charitable providers in Ohio with general revenue funds through the Free Clinic Safety Net line item. CHN is incredibly appreciative of the support from Governor DeWine, the Ohio legislature and the Ohio Department of Health for including \$1.75 million a year in the state's biennial budget. With that funding, the total value of care provided in 2024 reached \$224 million, underscoring the vital role these clinics play in preventing costly medical emergencies, keeping Ohio's workforce healthy, and reducing the financial strain on hospitals and taxpayers.
