

After I lost my job at NetJets, I realized that I needed some type of catastrophic health insurance. I called the Obama Care health hotline and was told, I could not get insurance as I had no income. They suggested I called Job and family services and apply for Medicaid " it's free ".

I contacted Job and family services and they confirmed what the health line said I needed to sign up for Medicaid and " it's free "

With my reading disabilities I got the paperwork to look over but I believe I applied over the phone they never once said it was not free, or there was any kind of estate recovery.

At one point I believe I was told that they would charge any doctor's cost to my estate, I thought that was no problem as we do not go to the doctors. Four or five to seven years we have not gone to the doctors when my wife had to see an eye doctor we made sure to pay cash!

We were led to believe by Job and family services there would be very little burden on my estate that will go to my only daughter and five grandchildren. Then after a telephone renewal call, at the end of the call they had me listen to a recording. It said something about a state recovery, I asked for more details about it. I was told they would include out of pocket doctor bills and monthly premium charges. I asked for the monthly charge amount and they said they did not know I tried to get that information from Job and family services, Medicaid office, Molina healthcare, attorney generals office, and got the runaround and called all of them again none of them could tell me what the cost was and would be.

I told the agent a job and family services to me this is an open-ended contract I don't think they are legal in Ohio to have an open-ended contract I told them to cancel Medicaid immediately.

Later I found out that they did not cancel it and did not tell me that they did not cancel it. I had been telling Molina healthcare when they called that I do not have Medicaid they never corrected me or told me otherwise.

I contacted Job and family services when I found out it was not canceled they said they

did not cancel due to covid. I insisted they cancel it and provide written verification of the cancellation immediately.

Someone at Job and family services was finally able to provide a spreadsheet with the monthly charges for the Medicaid \$ it averaged about \$1,000 per person per month. A total of \$70,208.29.

They also said there was a medical bill charge to my account but she could not get any information about it the whole time we had Medicaid we never filed a claim!

When I spoke to the attorney general's office about being lied to about the estate recovery and the non-existent doctor visit the person on the phone asked me abruptly "Are you dead yet?" Then he really said "If you're not dead then you don't owe anything!"

How can I question or testify about what has happened if I'm dead?

I reported the fraud to the attorney general's intake office and they sent me a letter stating that they were not going to investigate.

The attorney General's office is the authority that's supposed to protect Ohioans from fraud and other problems. When I asked for their help with the \$70,208.29 fraud case they said no. The reply was understandable since they are part of the people that are propagating The conspiracy to commit the theft of the estates of thousands of unsuspecting Ohioans.

If the government was not involved it would be: an open-ended contract, fraud, conspiracy, racketeering, and who knows what else. Since the attorney general's office is involved they will do nothing!
