Opposition Testimony on SB1

Chairperson Tom Young, Vice Chair Kevin Ritter, Ranking Member Beryl Piccolantonio and members of the Workforce and Higher Education Committee.

Thank you for allowing me to testify. My name is Lisa Lee Kohler. I am a lifelong Ohioan, a mom and a very concerned citizen. I am strongly opposed to SB1, the Enacted Advance Ohio Higher Education Act.

Growing up in Canfield Ohio, my parents drilled the importance of a good well rounded education into me. They were convinced that such an education was the key to a successful life. We moved to Canfield Ohio, because it was the best school in the area and had never failed a school levy. Good times way back then. I went on to attend both Ohio State University and Youngstown State University. I owned & operated a successful insurance agency, retiring during the COVID Pandemic. I did better than my parents, who did better than their parents. The way the American dream worked before the Republican Party decided that the government should be run like a business and broke us.

I raised my daughter with the same emphasis on education. She is a higher education project director, whose project, advancing women in STEM at small Appalachian colleges has been rescinded by DOGE. In today's hostile to education environment her PHD in Higher Education is becoming less valuable and sadly, because of the regressive policies in our State and our Nation, she is unlikely to "do better."
