Dear Senator Cirino,

On behalf of the undersigned unions and organizations of the Ohio AFL-CIO Executive Board, I write in opposition to any effort to curtail the collective bargaining rights of workers. A threat to any union is a violation of the labor principles and values that bind us together and strengthen the voice of all working people. Senate Bill 1/House Bill 6 represents an attack on collective bargaining rights not seen since Senate Bill 5 in 2011- a bill that Ohioans overwhelmingly rejected in a referendum vote. Support for unions and worker rights has only increased since then.

Senate Bill 1/House Bill 6 limits collective bargaining subjects that are key to the terms and conditions of employment for unionized full-time faculty at Ohio's public colleges and universities. These bills go even further by prohibiting faculty from being able to strike, one of organized labor's most sacred rights. These anti-labor provisions are deliberate attempts to silence the voices of over 10,000 union workers who are dedicated to their profession and will educate the next generation of Ohio leaders and help drive Ohio's research economy.

If passed, these bills will create an unacceptable precedent to limit collective bargaining rights for public workers outside of the public safety and public health realms. We stand firmly resolved to oppose any attempts to erode collective bargaining, such as contained in Senate Bill 1/House Bill 6. This is an affront to unions and the people of Ohio.

We urge you to reject these bills, as well as any other proposals that would restrict collective bargaining rights for Ohio workers.
