Andrew E. Doehrel has served as President of the Ohio Chamber of Commerce since April 1993. Prior to his position as president, Doehrel was the executive vice president and general counsel for the organization, in which he directed the Chamber's full-time legislative team.

In addition to his responsibilities as president, Doehrel works with legislators, business leaders and government officials every day on issues affecting Ohio Chamber member companies. Doehrel also specializes in labor issues including workers' compensation, product liability law, civil justice reform and regulatory practices. In fact, he has played a primary role in the passage of several key Ohio workers' compensation reform laws over the years and continues to be a key figure in refinement of the program.

Prior to joining the Chamber in 1983, he was a partner in an occupational safety and health consulting firm. He also served as program director for Ohio's OSHA on-site consultation program and spent four years as staff legal counsel for the Ohio Department of Industrial Relations. In 1991 he was appointed to the Unemployment Compensation Advisory Commission in Ohio where he served as co-chairman of the commission for over fifteen years. He currently serves on a number of state boards including the Ohio Expo Commission which oversees the Ohio State Fair.
