Introduction

Chairman Schaffer, Vice Chair Koehler, Ranking Member Hicks-Hudson, and members of the Committee, my name is Christina O'Keeffe, and I am the executive director of the Ohio Air Quality Development Authority (or OAQDA). We respectfully request \$3,996,000 in FY 2026 and \$4,773,000 in FY 2027 to ensure the agency's efficient operations in the next biennium, supporting our programmatic growth. This funding is essential to meet the increasing demands of Ohio businesses seeking our financial assistance, which drives economic relief and promotes a strong economy in our communities.

Proven Track Record of Success

For more than 50 years, OAQDA has been a non-regulatory state agency governed by a seven-member board. We are focused on furthering economic development in Ohio by issuing conduit revenue bonds for projects that reduce air emissions, regardless of whether the project uses coal, natural gas, oil, or another resource type.

The results are significant. For every \$1 invested in an OAQDA-financed project, \$6.41 in benefits are returned to Ohio in new jobs, lower operating costs, healthier workplaces, reduced health incidences, and improved economic opportunities locally.

Each project tells a compelling story. It may be the neighborhood dry cleaner who eliminated toxic chemicals that help him and his daughter, working by his side, and their customers breathe easier. Or the mid-size manufacturer who upgraded their building expansion with clean air and energy-saving features that meet environmental standards as a supplier to keep their book of business. We also work with major employers in the state to grow their businesses and add jobs to local communities. Recent examples include AMG Vanadium and Cargill, which both expanded business operations in Ohio using OAQDA-issued clean air bonds.

Our website is filled with these customer stories, videos, and case studies. In the last five years alone, OAQDA has partnered on nearly 100 projects to finance a total of \$1.3 billion. Exhibit A includes a map and some projects. Furthermore, in Exhibit B, accessible via QR codes, we also captured video customer stories highlighting our work in the advanced manufacturing and small business sectors. That way, you hear directly from our customers about the impact of OAQDA on growing their businesses and local economies in their communities.

Our entire bond and loan portfolio currently stands at \$3.5 billion, involving banks, investors, and other private capital providers who use our bonds to direct private capital into hundreds of projects throughout the state. OAQDA performs robust due diligence on applications through our signature programs, including the Clean Air Improvement Program and Small Business Assistance Program, to qualify these clean air improvements for financing and the related tax benefits. Additional responsibilities given to OAQDA by the 133rd General Assembly include the

program administration of the Solar Generation Fund, which involves approval, monitoring, and verification of payments for certain solar facilities as required by statute.

To fulfill our mission, OAQDA is a proven and adaptable state partner in meeting our customers where they are in the project development process and achieving their high service standards. We accomplish these tasks with efficiency and focus by a small, dedicated staff. The core functioning of OAQDA is fully supported by revenues generated through the issuance of project bonds, loans and other financial assistance from federal awards. No general revenue funds are included to support our operating costs.

Challenges and Priorities in the Next Biennium

OAQDA continually monitors industry and market trends to anticipate and align its programs to meet the needs of Ohio businesses. Many are exploring more creative, lower-cost financing options and incentives beyond their reliance on traditional borrowing to fill these gaps. Greater needs come from rural communities, where the economic headwinds may be more persistent.

Many manufacturers, small businesses, and developers turn to OAQDA for help. We have close to \$1 billion in active project requests and another billion in inquiries fielded every day. OAQDA is ready to meet the growing demand from our business community. OAQDA is a recipient of federal funding awards, which expands the ability to provide financial and technical assistance to more clean air improvement projects and expanded regions of the state. This effort can further maximize the return of benefits to Ohio, alleviating the economic barriers many are facing.

This budget request is consistent with authorizations by the General Assembly in 2021 and 2024 to ensure OAQDA has sufficient personnel to meet the rising business demands for its financing programs. Preferring its small, agile structure that better serves customers, OAQDA seeks a modest increase in the number of positions and payroll spending authority, as reflected in the operating line of the budget request, which is required to manage at least a fivefold increase in the number of projects forecasted in 2026 – 2027. This approach includes our continued use of professional service providers to augment our capacity and expertise. It demonstrates our commitment to focusing on governmental efficiency while achieving high customer service and successful project compliance, all to maximize the funding and impact for Ohioans.

Conclusion

Consistent with our purpose over the past five decades, OAQDA will fulfill its mission with efficiency and cost-effectiveness while meeting the increasing demands of businesses and communities. Our ability to expand our financing into more areas of the state with the modest increase in our spending authority for operating costs will enable more benefits for Ohioans, especially those significantly impacted by negative economic conditions.
