Proponent Testimony from Greg Gifford, Superintendent, Caldwell Exempted Village School District

Good afternoon Chair Brenner, Vice Chair Blessing, Ranking Member Ingram, and members of the Senate Education Committee.

My name is Greg Gifford, and I serve as the Superintendent of Caldwell Exempted Village School District. I appreciate the opportunity to speak today in support of the reinstatement of Career Awareness Funding, and to explain the positive impact these funds have on our students, even though they are administered through our partner Career and Technical Center, Mid-East CTC.

Mid-East Career and Technology Centers (MECTC) plays a vital role in our region, providing career-technical education to high school juniors and seniors. But their impact extends far beyond those high school years. MECTC provides crucial career awareness activities and resources for our younger students, and these activities directly benefit Caldwell Exempted Village School District.

While Caldwell Exempted Village School District does not receive these funds directly, the programming they support is invaluable to our students. The Career Awareness Funding allows MECTC to provide a range of activities, including:
