I respectfully ask the representative to use the state budget to address the lack of recreational centers in our local community. Recreational centers like The Boys and Girls Club are facilities that are publicly open for everyone to join and indulge in sports, interaction, and overall a place for everyone to chill and have fun. These centers are specifically used for the youth to have something to do after school or whenever they have nowhere else to go (Cambridge <u>Dictionary</u>). Teenagers are out here stealing cars and other property that doesn't belong to them. If they had a place to rest and indulge in activities that help them grow and become decent people, this wouldn't have even been a problem in the first place. Fox19 reports that a group of teens from Dayton stole a car in Butler County, leading to a pursuit into Montgomery County (Ken Brown). Police are saying that even if you lock your car, there's still a high chance it might get stolen. People are scared that their cars might be stolen and there's nothing they can do about it besides praying.. They would have to get a new car, using money that could've gone to something more useful. My grandma almost got her car stolen by these teenagers. If it wasn't for her neighbors catching them and reporting them to the police, my grandma would have no way to come see us because she doesn't have a car.

The County Commission should put more money into recreational facilities in Dayton. Across the world other people's property is getting stolen by these gang members. On the other hand, if we can get more facilities into our communities there would almost certainly be no thugs or teenagers roaming our streets, making future generations and Dayton as a whole feel safe and secure. Recreational activities can go beyond basketball courts. For example, the Sicangu Youth Program helps keep young people active with a blend of cultural activities, life skills, and athletics (Rosewood and Munoz).
