

House Bill 96 Written Proponent Testimony of Travis Gulling Simon Kenton Council

Chairman Cirino, Vice Chairman Chavez, Ranking Member Hicks-Hudson, and Members of the Senate Finance Committee,

My name is Travis Gulling, CEO and Scout Executive of the Simon Kenton Council of Scouting America. On behalf of the Simon Kenton Council, thank you for the opportunity to express strong support for House Bill 96 and its investment in youth development. We respectfully urge the Senate to maintain critical funding for the ScoutReach initiative, which is one of the most effective programs we offer to ensure children across underserved Ohio communities have access to leadership development, character education, and community service opportunities.

The Simon Kenton Council of Scouting America delivers the Scouting program to youth across Central and South-Central Ohio. Our programming is rooted in fun, friendships, and creating unforgettable experiences that become the core memories kids carry with them for life. Scouting helps youth develop life skills and grow into the best version of themselves by shaping confident, compassionate, and capable future leaders.

Currently, the Simon Kenton Council services more than 11,000 youth across 18 counties in Central and Southern Ohio. We have more than 4,500 adult volunteers who deliver over 500,000 volunteer hours to their community. Eagle Scouts alone have achieved more than 30,000 service hours that represent \$934,500 in direct service to Ohio communities.

ScoutReach is a vital initiative that ensures all youth—regardless of background or financial circumstance—have access to the life-changing experiences and leadership development opportunities offered through Scouting. In 2024, the ScoutReach program grew by over 100%, a reflection of both the need of programs like Scouting in local communities and the powerful outcomes the program produces for our youth.

House Bill 96 appropriates funding that will directly support the expansion of ScoutReach across under-resourced and hard-to-reach communities in central and southern Ohio. This funding will allow the Simon Kenton Council to:

• Triple Scouting membership in communities facing economic challenges,

- Hire two additional program coordinators to manage and deliver high-quality programming,
- Employ a dedicated risk manager to enhance youth safety protocols,
- Integrate social work support to meet the broader needs of families served by the Simon Kenton Council,
- Provide financial assistance for families who would otherwise be unable to participate, and
- Invest in outreach and marketing efforts to expand the program's impact.

This investment in Ohio's youth not only promotes access to Scouting but also fosters character development, leadership, and academic success—qualities that will benefit Ohio and its communities for generations to come.

The Simon Kenton Council thanks leaders in the Ohio House of Representatives for helping the Simon Kenton Council reach more Ohio youth. We urge the Senate to recognize the value of youth development and maintain this provision in its budget.
