RE: HB96 Proposed State Budget Testimony

Dear Chair Cirino, Vice Chair Chavez, Ranking Member Hicks-Hudson, and fellow respected Committee Members:

My name is Dara Adkison. My pronouns are they/them. And today, I stand before you on behalf of TransOhio–Ohio's first statewide trans-led equity organization; dedicated to protecting and advancing the rights of trans, nonbinary, intersex, and gender nonconforming people in Ohio.

How can we as a state expect to grow and flourish when our budget calls for so much that will make our state worse and less safe. The current proposed budget fosters division, otherization, marginalization, and harms public health instead of addressing the actual needs of Ohio's students, families, elderly and businesses.

Ohioans have been reaching out to all of you and the Governor from all across the state since this budget was proposed. Attached to our testimony is the testimony of over 175 Ohioans from 30+ Counties who are either unable to be here or didn't feel safe in doing so. They plead for you all to listen to their true needs. I will share with you a few examples of those comments:

From Jen in Union County: "At bare minimum, these kinds of policy changes should be proposed as individual bills and heard for public comment."

From Kay in Franklin County: "If the state continues down this path we will lose - economically and by driving young, smart, ambitious, hardworking people away."

From Lauren in Stark County: "Though Governor DeWine claims Ohio is a welcoming state for LGBTQ+ people, in practice this is proved to be untrue again and again. This instance is particularly galling as it tacks on human rights issues to what should be a simple budget bill. I am a queer Ohioan. I am also a worker, a community volunteer, a homeowner, an avid reader and library user. This bill sends a direct message that I am no longer welcome in the state I was born in."

From Rae in Franklin County: "If you pass this bill I will refuse to vote or endorse you or your party next election, you've gone to far. "

From Marin in Hamilton County: "These discriminatory parts of the budget will hurt my family, community, and business."

From Emily in Montgomery County "Why do you hate your constituents so much? Being inclusive creates a happier community. LGBTQ people are literally just trying to be happy in their lives and this doesn't hurt anyone. Please stop spreading hate and misinformation."

From Edith in Wood County "Discrimination is a blatant disregard of the Federal Constitution guaranteeing life, liberty and the pursuit of happiness by citizens. "

TransOhio has collected the testimony of all these people from across this state, from so many counties, from so many walks of life, you represent all of these these people, please listen to them.

For the good of all Ohioans we urge you to not:

- Defunds youth homeless shelters that serve LGBTQ+ youth and families
- Redefine gender as only 2 sexes and cannot be changed
- Restricts access to t all materials in libraries with any LGBTQ+ content to minors
- Bans Pride flags at government buildings
- Restricts Medicaid funding for most gender affirming care
- Bans public buildings from placing menstrual products in men's restrooms
- Allows higher levels of lead in drinking water
- Cuts BOTH public school funding & library funding
- Weakens collective bargaining & labor protections
- Abolishes the Ohio Elections Commission
- Require photo ID verification for adult websites
- Slashes funding for pediatric cancer research
- Limits access to state contracts for minority-owned businesses'
- Call for a public abortion data dashboard

TransOhio urges this committee to reject this iteration of the state budget, and particularly the lines 757 - 759: "
It is the policy of the state of Ohio to recognize two sexes, male and female. These sexes are not changeable and are grounded in fundamental and incontrovertible reality." This language is not only factually incorrect, it is dangerous. It contradicts well-established medical, psychological, and legal understanding of sex and gender. It denies the lived reality of thousands of Ohioans, including transgender, nonbinary, and intersex people. And it puts lives at risk.

The idea that sex is binary and immutable is not supported by science. Major medical associations—including the American Medical Association, the American Academy of Pediatrics, and the Endocrine Society—continue to recognize that sex and gender exist on a spectrum. Intersex people, for example, are born with biological traits that do not fit the traditional definitions of male or female. The language of this proposed budget rejects their lived experiences and reality. For many trans and intersex Ohioans, legal and medical transition is

life-saving. The United States Supreme Court's decision in Bostock v. Clayton County confirmed that discrimination against transgender people is a form of sex discrimination. Further, courts across the country—including those in Ohio—have upheld the right of individuals to update identity documents to reflect their correct name and gender. Attempts to erase or deny these rights through budgetary language would almost certainly invite legal challenge, costing Ohio taxpayers both financially and morally. In fact, the language that is taken word for word from an Executive Order in currently the subject of no less than 13 Federal lawsuits.

We urge the committee to remove this language from the budget. It does not belong in fiscal policy, and it does not reflect the values of fairness, science, or compassion that Ohioans deserve.

Dear Members of the Ohio Senate,

I am writing to express my profound concern and opposition to the discriminatory provisions embedded within Ohio's HB 96. As a representative of an organization dedicated to supporting and empowering our community, I witness firsthand the devastating impact that such legislation will have on the lives of vulnerable individuals and families.

The proposed state budget, under HB 96, contains measures that directly undermine the fundamental human rights and well-being of LGBTQ+ individuals, particularly our youth. Specifically, I urge you to reconsider the following:

- -Defunding youth homeless shelters that serve LGBTQ+ youth and families: This action will leave already marginalized young people without essential support and safety nets. These shelters provide crucial resources and safe spaces, and their defunding will exacerbate the crisis of youth homelessness within the LGBTQ+ community.
- -Redefining gender and denying gender affirming care:
 Redefining gender as only two sexes and restricting Medicaid funding for gender affirming care denies individuals their basic human rights and access to necessary medical treatment. This will have severe negative consequences for the mental and physical health of transgender individuals.
- -Restricting access to LGBTQ+ content in libraries: Limiting access to information and resources that reflect the lived experiences of LGBTQ+ individuals creates a hostile and discriminatory environment. Libraries should be spaces of inclusion and access for all.
- -Banning Pride flags at government buildings: This symbolic act of exclusion sends a clear message that LGBTQ+ individuals are not welcome or valued by their government.
- -Denying menstrual products in mens bathrooms: This action creates unneeded discrimination and a health risk for any person who may need them. Additionally, sometimes men may have a daughter with them who is experiencing a menstrual cycle and needs products while out in the community. Increasing accessibility to necessary feminine health products is crucial.

Furthermore, the inclusion of other harmful provisions, such as increased lead in drinking water, cuts to public school and library funding, and limitations on minority-owned business access,

Defunding them for supporting a specific chunk of the population is, to put it bluntly, evil. Do you want these children, with nowhere else to go, to live on the streets, to beg for money and food, to be harassed by passers-by, just because they are gay or trans? Additionally, even if you don't agree with what is said in books written by queer authors, silencing their voices is contrary to the principles of the United States - the banning of literature is a telltale sign of a government becoming fascistic, limiting free speech and prohibiting their citizens from accessing certain topics that go against the will of those in power. Please, do not fall into these traps.

Finally, on a personal note, I'm begging you to not cut Medicaid funding for gender-affirming care. I know this is another attempt to protect children, but kids under 16 who are struggling with their identities are only ever given hormone blockers, which have temporary and completely reversible effects. Those 16 or over can acquire hormones - at least before the recent executive orders and HB 68 - but it is a grueling, expensive, long process. I assure you, those trying to make it through the transgender health system are dedicated to transitioning, and the likelihood of them regretting their decision is incredibly low. If they do end up detransitioning, hormones at a low dose do not change the body dramatically in the first few months. In fact, the regret rate for gender affirming surgeries is <1%, and to remind you, these can only be accessed by adults after a long and expensive process. I

In an effort to speak up for the safety and support of those I love and care for, as well as my fellow Ohio residents at large, I am writing today to urge the senate to remove discrimination from the state budget. Or, at the very least, these kinds of policy changes must be proposed as individual bills and heard for public comment.

HB96 contains explicit discrimination against those of the LGBTQ+ population. As an Ohio resident with several family members and friends who belong to this population, this is a very important matter to me. And from what I can tell, people all across the state share my deep concerns.

The discrimination in HB96 includes a proposal to stop funding youth homeless shelters that help LGBTQ+ youth and families access the resources they need to stay housed and off the streets, protecting them from harsh weather and other hazards to their health and well-being. It also includes a proposal to redefine gender as only "two sexes" which could severely impair countless individuals' ability to receive crucial medical care or even broader services depending on how this unspecified and pointless redefinition is enforced. It would require that all books in libraries with any LGBTQ+ content be made inaccessible to minors, a blatant and shameful form of discrimination that endangers the health and education of all youth. It would ban pride flags at government buildings, an unproductive act of suppression of recognition for marginalized populations. It would restrict Medicaid funding for most gender affirming care, a cruel and unjust punishment thrust upon people of whom experience some of the most significant rates of suicidal ideation when restricted from accessing this crucial form of health care, of which the patients themselves along with their highly educated and licensed providers consistently support the funding of. It would also ban public buildings from placing menstrual products in men's restrooms, which in my honest opinion is frankly ridiculous. This bill not only undermines the well-being of LGBTQ+ Ohioans, but it also poses broad threats to public health, education, environmental safety, and basic human rights across our state. First and foremost, eliminating funding for youth homeless shelters that support LGBTQ+ individuals is both unethical and dangerous. Studies consistently show that LGBTQ+ youth are disproportionately represented in the homeless population—up to 40% of homeless youth identify as LGBTQ+, often due to family rejection. Denying them access to affirming shelter puts them at dramatically higher risk of suicide, substance abuse, and exploitation. Additionally, redefining gender as only two immutable sexes is medically and scientifically inaccurate. This definition disregards the medical definition of intersex, when an individual is born with medical variations in their sex characteristics. The American Medical Association, the American Psychological Association, and the World Health Organization all recognize that gender is not binary and can differ from the sex assigned at birth. Restricting access to gender-affirming care—especially through Medicaid—will harm transgender individuals who already face high barriers to care and are at significantly higher risk for depression, anxiety, and

		suicide when denied treatment.
		HB 96's censorship of LGBTQ+ materials in libraries and its ban on Pride flags at government buildings are overtly discriminatory and infringe upon free expression. Limiting access to inclusive information and visible support alienates LGBTQ+ youth and adults alike, increasing feelings of isolation and stigma. Evidence shows that affirming environments significantly reduce suicide rates and improve mental health outcomes.
		Beyond its assault on LGBTQ+ communities, this bill weakens public infrastructure in alarming ways. Allowing more lead in drinking water jeopardizes the neurological development of children and endangers public health. Cutting funding to public schools and libraries while also limiting access to pediatric cancer research, minority-owned business support, and collective bargaining harms the most vulnerable Ohioans and stifles economic equity.
		Lastly, the proposal to lease public parks to private oil and gas companies undermines environmental protections and ignores the growing climate crisis. Public lands should serve the public good—not corporate interests.

		This bill, across thousands of pages, hides provisions to weaponize the funding that is meant to improve the lives of Ohioans to target housing for displaced youth, mental health

access that saves lives, promote censorship and restrict parental rights, and adopt an executive order that has no fiscal justification and no connection to the budget.

Vague language prohibiting affirmation of social gender transition in youth shelters will only serve to force unhoused kids--transgender or not--onto the streets. Does that sound like an improvement to our support of unhoused children? It is cruel, it is pointless, and it provides no fiscal incentive or justification. I, for one, would not want any child, no matter their gender or orientation, on the streets. This language needs to be removed from the bill.

In the same vein, provisions withholding funds from Medicaid are based on similar language. Again, this begs the question of who stands to benefit from such a provision? This will disrupt services, increase bureaucratic red tape, and endanger those who need this life-saving care. That is not to mention the fact that this provision was not in the original bill. It needs to be removed.

Censorship. That is the purpose of the proposed change to Chapter 3375 mandating books dealing with gender identity or sexual orientation be designated 18+. Books with adult content are already age restricted. Where is the limit? Gender identity is not something specific to the LGBTQIA+ community. Being a woman is a gender identity. Being a man is a gender identity. Everyone in this committee has one, whether they wish to call it that or not. That is not to mention that libraries are understaffed and underfunded, but we want to divert their time and resources to cataloging books on subjective language in a budget bill? And what then, of the parents? Is it not a parent's duty and privilege to ensure their children are reading age appropriate content? Should law-makers be the parents to every child in Ohio's libraries? It is not a lawmaker's job to determine what a child should or should not be reading, and Libraries are meant for EVERYONE. This is a waste of funds with no benefit, and is a clear exercise in censorship.

Finally, the adoption of a flawed definition of sex. This has no business in a budget bill. OF THE OHIO CONSTITUTION: BILL OF RIGHTS:

Inalienable rights.

§1 All men are, by nature, free and independent, and have certain inalienable rights, among which are those of enjoying and defending life and liberty, acquiring, possessing, and protecting property, and seeking and obtaining happiness and safety. (1851)

Right to alter, reform, or abolish government, and repeal special privileges.

§2 All political power is inherent in the people. Government is instituted for their equal protection and benefit, and they have the right to alter, reform, or abolish the same, whenever they may deem it necessary; and no special privileges or immunities shall ever be granted, that may not be altered, revoked, or repealed by the General Assembly. (1851)

Right to assemble.

§3 The people have the right to assemble together, in a peaceable manner, to consult for the common good; to instruct their Representatives; and to petition the General Assembly for the redress of grievances. (1851)

Rights of conscience; education; the necessity of religion and knowledge.

Evan M.

Franklin County

§7 All men have a natural and indefeasible right to worship Almighty God according to the dictates of their own conscience. No person shall be compelled to attend, erect, or support any place of worship, or maintain any form of worship, against his consent; and no preference shall be given, by law, to any religious society; nor shall any interference with the rights of conscience be permitted. No religious test shall be required, as a qualification for office, nor shall any person be incompetent to be a witness on account of his religious belief; but nothing herein shall be construed to dispense with oaths and affirmations. Religion, morality, and knowledge, however, being essential to good government, it shall be the duty of the General Assembly to pass suitable laws, to protect every religious denomination in the peaceable enjoyment of its own mode of public worship, and to encourage schools and the means of instruction. (1851)

Freedom of speech; of the press; of libels.

§11 Every citizen may freely speak, write, and publish his sentiments on all subjects, being responsible for the abuse of the right; and no law shall be passed to restrain or abridge the liberty of speech, or of the press. In all criminal prosecutions for libel, the truth may be given in evidence to the jury, and if it shall appear to the jury, that the matter charged as libelous is true, and was published with good motives, and for justifiable ends, the party shall be acquitted. (1851)

Preservation of the freedom to choose

health care and health care coverage

- §21 (A) No federal, state, or local law or rule shall compel, directly or indirectly, any person, employer, or health care provider to participate in a health care system.
- (B) No federal, state, or local law or rule shall prohibit the purchase or sale of health care or health insurance.
- (C) No federal, state, or local law or rule shall impose a penalty or fine for the sale or purchase of health care or health insurance.
- (D) This section does not affect laws or rules in effect as of March 19, 2010; affect which services a health care provider or hospital is required to perform or provide; affect terms and conditions of government employment; or affect any laws calculated to deter fraud or punish wrongdoing in the health care industry.
- (E) As used in this Section,
- (1) "Compel" includes the levying of penalties or fines.
- (2) "Health care system" means any public or private entity or program whose function or purpose includes the management of, processing of, enrollment of individuals for, or payment for, in full or in part, health care services, health care data, or health care information for its participants.
- (3) "Penalty or fine" means any civil or criminal penalty or fine, tax, salary or wage withholding or surcharge or any named fee established by law or rule by a government established, created, or controlled agency that is used to punish or discourage the exercise of rights protected under this section. (2011)

The Right to Reproductive Freedom

with Protections for Health and Safety

§22 A. Every individual has a right to make and carry out one's own reproductive decisions, including but not limited to decisions on:

- 1. contraception;
- 2. fertility treatment;
- 3. continuing one's own pregnancy;
- 4. miscarriage care; and
- 5. abortion.
- B. The State shall not, directly or indirectly, burden, penalize, prohibit, interfere with, or discriminate against either:
- 1. An individual's voluntary exercise of this right or
- 2. A person or entity that assists an individual exercising this right, unless the State demonstrates that it is using the least restrictive means to advance the individual's health in accordance with widely accepted and evidence-based standards of care. However, abortion may be prohibited after fetal viability. But in no case may such an abortion be prohibited if in the professional judgment of the pregnant patient's treating physician it is necessary to protect the pregnant patient's life or health.
- C. As used in this Section:
- 1. "Fetal viability" means "the point in a pregnancy when, in the professional judgment of the pregnant patient's treating physician, the fetus has a significant likelihood of survival

outside the uterus with reasonable measures. This is determined on a case-by-case basis."

- 2. "State" includes any governmental entity and any political subdivision.
- D. This Section is self-executing. (2023)

By pushing this budget, you are not only going against the very country and state you have sworn to protect, you are actively breaking the state of Ohio's constitution. We are allowed the right to choose what care we receive. I want to point this out specifically in THE RIGHT TO REPRODUCTIVE FREEDOM WITH PROTECTIONS FOR HEALTH AND SAFETY. As stated, "Every individual has a right to make and carry out one's own reproductive decisions, including but not limited to decisions on: 1. contraception; 2. fertility treatment; 3. continuing one's own pregnancy; 4. miscarriage care; and 5. abortion. B. The State shall not, directly or indirectly, burden, penalize, prohibit, interfere with, or discriminate against either: 1. An individual's voluntary exercise of this right or 2. A person or entity that assists an individual exercising this right, unless the State demonstrates that it is using the least restrictive means to advance the individual's health in accordance with widely accepted and evidence-based standards of care." Evidence-based standards of care for transgender individuals from WPATH have been constantly overstepped and ignored by those without medical degrees AND with political agendas regarding their own biases towards a very small population of individuals. Joe	Franklin	To the honorable members of the Ohio Senate, regarding proposed state budget HB96, I feel compelled to finally speak out on behalf of Ohio citizens who are being singled out for punishment for no conceivably good reason. I have heard the reasoning behind why gay and trans people are being labeled as a threat, with language that pretends that such targeting is intended to "protect" children (especially girls) from harm. I find this reasoning to be deeply flawed. Gay and trans citizens of our state (and our country) are not more likely to harm girls or children in general. There is no evidence or proof behind this claim that gay or trans citizens are a greater threat to children or girls than their straight or cisgender counterparts. Quite the opposite is true. Statistics very clearly show that trans and gay people are far more likely to be VICTIMS of psychological, sexual and physical abuse, not perpetrators. This proposed budget, which unfairly targets trans and gay citizens using grossly inaccurate stereotypes, will only increase the disproportionate harm and suffering already being experienced by this demographic. It is unconscionable to consider intentionally inflicting even more

harm in this way. Many of those who would be harmed are children themselves. This bill makes no logical sense and will literally protect no one, while simultaneously inflicting great harm on a carefully selected few.

I am a father of two with a beautiful wife and two wonderful children. We raised both our children according to their birth genders in a very traditional way. Nevertheless, one of our children made the discovery that they were gender non-binary. This wasn't something that they were taught or chose to be. It's something that they came to realize over time. It was with fear and anxiety that they broke the news to us, the parents. We made the decision to love and to not judge. So many other kids who come of age with the same discovery are not so lucky. They are rejected by their families, friends and churches based on stereotypes and religious bigotry, simply for being honest with who and what they are. Having caused no harm to anyone, gay and trans children still endure harm from everyone they know and trust. I know from my experience as a father that gender identity and sexual orientation are personality characteristics that are discovered, not chosen or taught. The scientific and medical experts agree with my anecdotal experience. There is no credible evidence to suggest that such major characteristics are simple matters of choice, like what to wear or what football team to follow. There is zero evidence that gay or trans people are more likely to cause harm or abuse.

Evidence is what matters. Policy decisions should always be based on evidence - actual facts - not fiction (aka "alternative" facts"). Facts are observable, verifiable and undeniably, objectively true. They are not based on superstition, stereotypes, gut-feelings, conventional wisdom or popular belief. The policy decisions being considered in HB96 are ones that deliberately seek to separate citizens into two groups - one that is a favored class with enhanced rights and powers to openly discriminate against others, while the other is a diminished subclass with few rights and little power that the state intends to treat with open hostility. If you had substantial, clear evidence that this subclass was truly engaging in harmful activity, then the policy might make a little sense. There is no such evidence in existence regarding gay or trans citizens. One might find an individual anecdote, but no pattern, no persuasive evidence whatsoever. On the other hand, there is very clear evidence in HB96 that the Ohio Statehouse is engaging in behavior that is deliberately intended to cause

		harm to a specific group of Ohio citizens. Perhaps they should hold a mirror up to themselves when looking for someone to punish for willfully destructive behavior. My apologies if that concept is offensive to anyone, but I am deeply offended by HB96. I am sick and tired of innocent people being scapegoated and harmed in the name of "protection". This bill, while protecting absolutely no one, would profoundly harm people I know - people I love, people I trust, people who are just trying to live their authentic lives in peace and who have never considered harming those who inexplicably hate them. This bill is nothing short of evil masquerading as an attempt to do something good. The people who wrote it should be ashamed. This bill is nothing but an absolute disgrace and thoroughly deserves to be treated as such. I cannot be any kinder or more respectful to the architects of such a policy proposal.
