## **Opponent Testimony of Ohio Council of YWCAs**

HB 96 – FY 26/27 State Operating Budget

June 6, 2025

Chair Cirino, Vice Chair Chavez, Ranking Member Hicks-Hudson, and members of the Senate Finance Committee:

My name is Lisa McDuffie, and I am the President and Chief Executive Officer of the YWCA of Northwest Ohio. My association is one of 13 associations in the state of Ohio. Collectively, we represent the Ohio Council of YWCAs. YWCA of Northwest Ohio operates the only domestic violence shelter in our community. Last year, 588 individuals were served with 16,690 nights of service in our shelter; 285 were children under 18 years of age. Our shelter accepts pets who are also fleeing with survivors and their dependent children. The YWCA of Northwest Ohio also provides school-based youth programming for boys designed to prevent sexual abuse and promote healthy relationships to prevent domestic violence in the future.

We also provide teen pregnancy prevention in Toledo Public Schools for boys and girls. Last year, 3517 teens were served. Our Rape Crisis Center offers 24/7 crisis intervention for anyone who has been sexually assaulted. Last year, 731 survivors received services. YWCA Child Care Resource and Referral serves 20 counties in Ohio and offers services to parents and family members seeking child care services, early education and child care professionals working with children and their families, agencies serving families, businesses, and communities. We served 21,628 individuals last year.

I am offering written opponent testimony to the Senate substitute version of House Bill 96. In the Governor's introduced version of the budget, the Ohio Council of YWCAs was allocated \$1.5 million per fiscal year. The House-passed version made broad reductions to the TANF Block Grant, which cut our funding in half – to \$750,000 annually. The Senate substitute bill released on Tuesday eliminated this funding entirely for both FY 2026 and FY 2027. Today, I respectfully and humbly urge this committee to accept our proposed amendment that would restore flat funding of \$1.5 million per year, as originally proposed by the Governor.

This funding directly supports programming that provides critical, often life-saving services to survivors, children, and families who have experienced domestic violence. It also sustains and expands our youth development and sexual abuse prevention initiatives in our county and across Ohio. Specifically, the funding supports Council programs that:

- Provide emergency shelter and crisis support for survivors, their dependent children and pets fleeing of domestic violence;
- Deliver trauma-informed services for survivors, including counseling, case management, and post shelter housing support.
- Offer outreach and education to prevent sexual abuse of children, and to promote healthy relationships that will prevent domestic violence before it begins, particularly among youth.

YWCA of Northwest Ohio programs are evidenced based and are designed to strengthen families. Last year alone, Ohio YWCA chapters reached more than 90,000 women, children, and family members. In partnership with over 45 school districts and alternative schools statewide, we deliver after-school care, violence prevention education, and youth programming that changes lives.

Your investment has already produced real results. In the last biennium, with state support:

- Over **304,000 meals** were served to youth and families facing food insecurity;
- Approximately 677 parents and families received childcare assistance that allowed them to remain in the workforce;

 Nearly 10,600 individuals impacted by domestic violence and abuse received vital support services.

The need is urgent and growing. In 2023, Ohio reported **36,111 incidents of domestic violence.** Meanwhile, **1 in 5 children in Ohio face hunger**, and **4 in 10 working parents** have had to miss work due to lack of childcare. These numbers reflect the reality we see on the ground every day—and they underscore why this funding is so critical.

YWCA Northwest Ohio is also a part of the Ohio Domestic Violence Network. Last year, ODVN commissioned a formal study of the economic impact of DV in Ohio. It is more than a billion dollars a year!

We are grateful for the investment made by both the Governor and the House. Their recognition of our collective impact is deeply appreciated. We are now asking the Senate to demonstrate that same support. While we are requesting a restoration to \$1.5 million per fiscal year—as originally proposed by the Governor—we would be grateful for any investment, as it would allow us to reach significantly more individuals and expand our impact across the state. This investment is modest compared to the far-reaching costs of domestic violence and sexual abuse in our communities.

Ohio's YWCAs do far more than respond to crisis. We are leaders in preventing abuse and domestic violence, combating human trafficking, promoting economic stability, and empowering youth and survivors to lead healthy, self-sufficient lives. This investment would amplify those efforts at a time when communities need them most.
