# Written Testimony Before the Ohio Senate Finance Committee June 5, 2025

Chairman, Vice Chair, Ranking Member, and Members of the Senate Finance Committee:

Thank you for the opportunity to provide written testimony seeking support to create Health Workforce Ohio, a public-private partnership to achieve comprehensive health workforce improvements across the state.

#### **Background and Need**

Ohioans across our state—particularly in urban, rural, and Appalachian medically underserved areas—face significant barriers in accessing timely, quality healthcare. Two primary factors drive this challenge:

- 1. A persistent and acute shortage of certified and licensed health professionals.
- 2. Stark geographic disparities in access to care.

Currently, there are over 70,000 active job postings in healthcare in Ohio. The healthcare sector contributes \$171.5 billion to the state's economy and supports over 1.19 million jobs, yet, our workforce pipeline struggles to meet growing demand.

## **Proposed Solution: Health Workforce Ohio**

To address these pressing challenges, we propose the establishment of **Health Workforce Ohio**—a collaborative hub for statewide health workforce innovation. This initiative will:

- Increase the size, and preparedness of the in-demand health workforce.
- Improve access to quality care in underserved communities.
- Increase retention of healthcare professionals trained in Ohio.

Health Workforce Ohio would work to address the healthcare workforce shortage by connecting job seekers with living-wage healthcare positions. Their approach focuses on three key actions: convening stakeholders, assessing workforce needs, and investing in strategies that create clear career pathways. The initiative aims to bridge the gap between available jobs and potential candidates, particularly in underserved communities. Health Workforce Ohio is helping individuals access training and partnering with employers on job placement opportunities.

#### **Key Strategies and Measures of Success**

Health Workforce Ohio will implement targeted strategies, including:

- Developing standardized career pathways of Ohio's most in-demand health professions.
- Expanding and enhancing healthcare education programs.
- Supporting telemedicine training and deployment in underserved areas.
- Surveying healthcare students to understand and improve post-graduation retention.
- Launching pilot programs that address top retention drivers.

#### Success will be measured through:

- Increased student enrollment in healthcare programs.
- Improved hiring and retention rates.
- Reduced vacancy rates.
- Enhanced telemedicine capability in underserved regions.
- Higher rates of graduates remaining to practice in Ohio.

#### **Funding and Sustainability**

State funding to launch Health Workforce Ohio will support:

- Strategic workforce development
- Promotion of Career Pathways
- Research and data management
- Education and training alignment
- Scaling best practices and innovation

To ensure long-term impact and continued engagement, Health Workforce Ohio will pursue federal and state grants, private sector investment, and philanthropic support. Additionally, we will explore fee-based services to sustain operations.

#### Conclusion

Health Workforce Ohio represents a strategic, collaborative solution to one of the most critical health infrastructure challenges facing our state. By investing in the people who power our health system, we can expand access, improve outcomes, and strengthen the economic foundation of communities across Ohio.
